Terms and Conditions

- 1. Tenderer has to enclose Rs.2,000 (Two thousand rupees only) towards E.M.D. along with the tender by way of DD from any nationalized/scheduled bank drawn in favour of "The Cotton Corporation of India Ltd," Payable at Hubli or through e-payment to the account details mentioned in Technical bid.
- 2. The duly filled tender form should be enclosed in a sealed cover superscribed as "Tender for sale of Tarpaulins (unserviceable)" and should be submitted on or before 11.04.2022 upto 03:00 PM addressed to The Deputy General Manager, The Cotton Corporation of India Ltd, W.B. Plaza, 3rd Floor, New Cotton Market, Hubli-580029.
- 3. The tenders received will be opened and finalized at Branch Office, Hubli on 11.04.2022 at 03.30 PM in the presence of the tenderers who may wish to remain present.
- 4. Copy of GST certificate (if registered) & PAN is to be enclosed along with Technical bid.
- 5. The quoted rates mentioned in financial bid should be exclusive of GST, other taxes (if applicable), miscellaneous charges etc. which shall be borne by buyer/H-1 bidder.
- 6. Tarpaulins located at the respective godowns/factory are stacked in heap form and are in unserviceable condition due to wear and tear. Some are in torn condition but has been considered as one tarpaulin. The bidder shall consider for the whole heap and offer the rate on <u>per tarpaulin</u> basis for the mentioned tarpaulins quantity. The H-1 bidder has to make full payment for the mentioned quantity. The sale is "as is where is basis" and the highest bidder has to take all the quantity without any rejection.
- 7. Bidders should inspect & satisfy themselves regarding quantity & quality and condition of items before participating in auction. No complaint or dispute of any kind shall be entertained after tender and the Buyer shall not be allowed to withdraw.
- 8. The H-1 bidder shall take delivery of Tarpaulins by making **full payment within 05 working** days from the date of receipt of work order.
- 9. The payment shall have to be made by way of e-payment or Demand Draft, or Banker's cheque in favour of "The Cotton Corporation of India Ltd." payable at Hubli.
- 10. In case the H-1 bidder does not lift within free period, the EMD will be forfeited and the Corporation shall have the option to cancel the contract without giving further notice.
- 11. The Buyer may depute his representative at the time of delivery.
- 12. All expenses at the place of delivery from destacking of tarpaulins to loading in the truck and other expenses if any shall have to be borne by the buyer/H-1 bidder only.
- 13. The Corporation reserves its right either to accept/reject any or all tenders without assigning any reason. The decision of the Corporation in this respect shall be final and binding on the buyer/H-1 Bidder.
- 14. The dispute arises, if any shall be within Hubli jurisdiction only.
