- Only those firms are allowed to participate in the tender who are General Sales Tax (GST) registered and have National Tax Number (NTN) and must be activated at FBR level if any hurdle comes regarding activation of firm in records of such departments for payment of taxes; firm will be responsible.
- 2. Bidder(s) must have sound financial position, sufficient experience, well reputation and capability for timely completion and delivery of required items.
- The interested bidders can visit NHMP M-2 South Sector Store to check the sample of all items in order to observe the quality and standard of items required.
- 4. The bidders must bring one sample of each item at the time of opening of technical proposal. The sample provided, if not matched with department sample/specification, will be rejected. Such rejection will be for that item only.

- 6.
