Tenders applications with documents as per terms and conditions will be received up to **01:00 P.M** on **21.06.2022** and will be opened on the same date at **01:30 P.M** in the office of the undersigned in the presence of contractors or their authorized representatives who care to attend. #### Terms and Conditions.

1. The Application must be accompanied with Bid security @ 4% of the NIT amount in shape of CDR in favor of **Executive Engineer, Project Civil Division Pak PWD Sahiwal** issued by any schedule bank of Pakistan clearly mentioning the name of firm. The remaining Bid security @ 4% of Bid amount i.e. difference between Bid amount and NIT amount must be enclosed in the sealed Bid. Otherwise the same will be rejected summarily.

2. 3. The applicant firm will provide at least 02 Nos. work orders amounting equal to the above mentioned works along with completion certificates for completed projects during last 02 years.
4. The firm will also provide detail of at least one work in hand amounting equal to the above mention work.

Undertaking on original stamp paper of Rs. 100/- that the firm/constructor is neither involved in any litigation with any Divisional office of this Department and other Departments nor abandoned any work/ black listed in any Department along with certificate that particular/ information furnished are true and correct duly signed by Oath Commissioner.
6. The Firm will enclose Annual Financial Audit Report in last 03 years conducted by firm with satisfactory QCR rating otherwise the application will be rejected.
7. The firm must be E-filer and provide active tax payer certificate.
8. The firm will provide PEC registered Engineer along with his qualification and documentary evidence of his disbursement of salary on the pay roll of the construction firm at the time of purchasing the tender.
9. Tender documents shall be sold on production of proof of being Proprietor of the firm or his authorized representative possessing valid power of attorney duly registered with the concerned Registrar.
