

TERMS AND CONDITIONS:-

1. Interested bidders can only submit their bids online through e-Tender Portal of ML&C Deptt (<https://etender.mlc.gov.pk>), Contractors having valid NTN No, STRN No. and PEC Registration of relevant codes are eligible to apply with proper PEC registration renewal. The cutoff time for submission of online bids will be 1200 hrs dated **19/07/2022** and shall be opened on same day at 1230hrs electronically on the portal. The contractors will be able to see the comparative statement online.
2. E-Tenders without attachment of call deposit/bid bond in favour of the undersigned equal to the earnest money will be rejected.
3. The Cantonment board reserves the rights to demand the analysis of quoted rates to check their reasonability and workability.
4. The successful contractor shall enter into prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Jhelum within 07 days for the issuance of acceptance letter.
5. The Cantonment Board/ Executive Officer reserves the rights to reject the tender as per PPRA's Rule No.33 (1) due to any reason thereof.
6. The issuance of work order shall be subject to approval from Board.
7. The validity of tender rates shall be up to 180 days as per PPRA/PEC Rules.
8. In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of work) reasonable amount decided by the undersigned in the shape of call deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
9. Any information regarding the e-tender can be obtained from the office of undersigned during office hours. Furthermore, user guidance tutorial has been uploaded on the portal.
10. The contractors / bidders, who quoted their bids / rates more than 10% below the Engineer's estimate, shall submit performance guarantee equal to 8% of the estimated cost under rule 39 of PPRA Rules 2004.
11. In complete / disfiguring / overwriting / by hand / delayed bids shall be declared non-responsive.
12. Any bid received in the contravention of enabling provisions of PPRA Rules, 2004 will be declared non responsive by the procuring entity.
13. . The contractor shall remain in force till the end of the current financial year or till another term of contract in place of this contract is executed by the Jhelum Cantonment Board whichever is later.
14. Contractors/ firms can be participated after the deposit of tender fee as tabulated above, tender fee challan will be obtained from Cantonment Board Office "Tufail Road" Jhelum Cantt after the publication of the invitation to bid
