#### CERTIFICATE OF INDEPENDENT PROPOSAL DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all proposals<sup>1</sup> invited.

#### INTRODUCTION

Stainless steel strapping is widely used on City Power's networks to support various equipment on structures. The applications include, amongst other things, attaching pole mounted service distribution boxes to pole structures, straining and suspending clamps for aerial bundled conductors on steel or similar poles, supporting cables parallel to a pole in overhead line, etc. The strapping has to meet the specified technical requirements to sustain the life expectancy of the network.

#### 1 SCOPE

The purpose of this specification is to detail the technical requirements to be met when acquiring stainless steel strapping for use on City Power's distribution networks.

#### **2 NORMATIVE REFERENCES**

The following documents contain provisions that, through reference in the text, constitute requirements of this specification. All standards and specifications are subject to revision, and parties to agreements based on this specification are encouraged to investigate the possibility of applying the most recent editions of the documents listed below.

SANS 50028-1, Flat products made of steels for pressure purposes.

SANS 50028-7, Flat products made of steels for pressure purpose.

SANS 242, Stainless Steel sinks with draining boards for domestic use.

#### 3 DEFINITIONS AND ABBREVIATIONS

The definitions and abbreviations in the above document shall apply to this specification.

#### **4 REQUIREMENTS**

#### 4.1 General

- 4.1.1 In general, the requirements for stainless steel strapping and buckles shall comply with the requirements of SANS 50028-7 or any other equivalent standard acceptable to City Power.
- 4.1.2 The stainless steel shall be AISI type 304 and the chemical composition shall be as in clause 4.1 table 1 of SANS 242.
- 4.1.3 The classification and designation of the steel grade shall comply with the requirements of SANS 50028-1
- 4.1.4 Nothing in this specification shall lessen the obligations of the supplier. The supplier shall be fully responsible for the design and its satisfactory performance in service. Acceptance by City Power shall not relieve the supplier of the responsibility for the adequacy of the design.

#### 4.2 Stainless steel strapping

- 4.2.1 The strapping shall be made from grade 304 stainless steel or any higher grade to the acceptance of City Power.
- 4.2.2 The strapping shall have a width of 20 mm and a thickness of 0,7 mm and shall withstand a minimum tensile load of 8,2 kN/mm<sup>2</sup>.
- 4.2.3 The strapping shall have no welded joints.

4.2.4 The strapping shall have a smooth, polished finish and rounded edges to eliminate burrs and sharp edges.

#### 4.3 Stainless steel buckle

- 4.3.1 The buckle shall be made from grade 304 stainless steel or any higher grade to the acceptance of City Power.
- 4.3.2 The buckle shall be compatible with the strapping, and the thickness of the material used in the manufacture of the buckle shall not be less than 1,5 mm.
- 4.3.3 The buckle shall have a smooth, polished finish and rounded edges. The buckle shall not have any sharp edges, including gripping "teeth".

#### 5 TESTS

Tests on stainless steel strapping and buckles shall comply with the requirements of SANS 50028-1.

#### 5.1 Type test

- 5.1.1 Tensile test at room temperature;
- 5.1.2 Impact test

#### 5.2 Routine test

- 5.2.1 Dimensional test;
- 5.2.2 Visual examination of the surface condition

#### **5.3 Factory Acceptance Test (FAT)**

5.3.1 Factory Acceptance Test (FAT) shall be carried out as per SANS 50028-1, with the presence of City Power Personnel before the stainless steel strapping are released from the manufacturer. City Power reserves the right to request to approve prototype testing before any ordering can commence.

#### **6 MARKING, LABELLING AND PACKAGING**

- 6.1 Marking, labelling and packaging shall comply with the requirements of SANS 50028-1.
- 6.2 The strapping shall be supplied in coils of 30 metres and shall be packaged so as to facilitate unwinding and prevent unravelling of the coil.
- 6.3 The buckle shall be marked with the manufacturer's name or logo and shall be packed in packets of 100.

#### 7 DOCUMENTATION

Documentation that complies with the requirements of SANS 50028-1 shall be submitted in a catalogue format. In addition, relevant test certificates confirming compliance with the requirements of SANS 50028-1 shall be submitted.

#### 8 TRAINING

- 8.1 A certified training course shall be offered to relevant City Power staff. The training shall include handling, storage and installation of stainless steel strapping and buckles.
- 8.2 The associated costs for the certified training course in 8.1 shall be given per person and shall be fixed for the period of the contract.

#### 9 QUALITY ASSURANCE

A quality management plan shall be set up in order to assure the proper quality management of stainless steel strapping during design, development, production and installation. Guidance on the requirements for a quality management plan may be found in the ISO 9001. The details shall be subject to agreement between City Power and supplier

#### 10 ENVIRONMENTAL MANAGEMENT

An environmental management plan shall be set up in order to assure the proper environmental management of stainless steel strapping throughout its entire life cycle (i.e. during design, development, production, installation, decommissioning and disposal phases. Guidance on the requirements for an environmental management system may be found in ISO 14001standards. The details shall be subject to agreement between City Power and supplier. This is to ensure that the asset created conforms to environmental standards and City Power SHERQ Policy.

#### 11 HEALTH AND SAFETY

A health and safety plan shall be set up in order to ensure proper management of the stainless steel strapping and compliance of the queuing system during installation, operation, maintenance, and decommissioning phases. Guidance on the requirements of a health and safety plan may be found in OHSAS 18001 standards. This is to ensure that the asset conforms to standard operating procedures and City Power SHERQ Policy. The details shall be subject to agreement between City Power and the Supplier.
