2. Duly attested Photostat copy of the certificate of Registration as a firm under GST Act duly renewed up to date should be uploaded.
3. The tenderers should remit the Earnest Money Deposit by RTGS/NEFT in favour of TNCSC . The tenderers are requested to upload the UTR number, e-tender number and a certificate in Bank's letter head mentioning name of the tenderer, EMD Amount. e-Tender not covered by requisite Earnest Money Deposit will be summarily rejected.
4. Two samples of 'Y' cone for each colour as per the specifications indicated in *Annexure-A* should be submitted at TNCSC, Head Office on or before the closing time of e-tender ie., (before 11.00 AM on 12.08.2022) The 'Y' cone samples should satisfy TNCSC specification.
5. The audited Balance sheet, Profit and Loss account and the Income-tax return submitted for the 3 financial years duly certified by the Auditor for the years, 2018-2019 , 2019-2020 and 2020 - 2021 should be uploaded.
6. There should not be any pending supply to TNCSC in the ordered quantity of the previous tenders than the allowed proportionate quantity to be supplied up to the day of opening of tender. If the pendency is more than the proportionate quantity, the tenderer is not eligible to participate in the tender.
