- In liaison with the Project Coordinator, manage the quality implementation and monitoring within scope, time, and budget.
- In liaison with the Project Coordinator, produce consolidated annual/semi-annual reports for sharing with other stakeholders.
- Collaborate with the Ministry of Education at National, Provincial, and District levels to ensure the project's successful implementation.
- Support documentation and dissemination of promising/best practices for future programming.
- Support the development of a data repository for the project for better knowledge management and utilization.

- Collaborate with local-level stakeholders for effective programme implementation and sustainability.
- Represent WVZL in various key meetings at the district level for alignment of



national and local priorities.
