1. Item rate e-tenders are invited through the e-tendering NIC CPP portal by Deputy General Manager (Engg. Civil), Dholera International Airport Company Ltd. (DIACL), 3<sup>rd</sup> Floor, A2 Wing, Block-1, Karmyogi Bhavan, Sector 10A, Gandhinagar (Gujarat)-382010, (Tel)-079-23258528 on behalf of Chairman, Dholera International Airport Company Ltd. (DIACL), Gandhinagar (Gujarat), from the eligible Architect/Firms for the work of "Providing Consultancy Services for development of DIACL Office at 6<sup>th</sup> floor of existing ABCD Building, Dholera, Dist. Ahmedabad." at an estimated cost of INR 5.60 Lakhs (Exclusive of GST) with completion period of 03 (Three) Months.

**Qualifying requirement of contractors /tenderers** 

- C. Qualifying requirement of contractors /tenderers containing the following:
  - i. Should have satisfactorily completed (#Phase/Part completion of the scope of work in a contract shall not be considered, however pre-determined phasing of the work will be accepted), three works, each of INR 2.24 lakhs (Excluding GST) or two works, each of INR 2.80 lakhs (Excluding GST) or one work of INR 4.48 lakhs (Excluding GST) of estimated costing single contract of similar nature of work i.e "Architect Consultancy Services work in Office Buildings/Aviation Buildings/Commercial Complex/Institutional Buildings during the last seven years ending on last date (extended date if any) of submission of bids in India.

"The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid".

Client certificate for experience should show:

- i) Name of work
- ii) Value of work
- iii) Date of start
- iv) Date of completion as per agreement
- v) Actual date of completion and satisfactory completion of work
- vi) Nature/scope of consultancy work done

[If any of the above details are not mentioned in the client's completion certificate, then relevant supporting documents issued by the client such as Work Order/Agreement (relevant pages) etc. shall be submitted as applicable]

Tenderers showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources certificate (form 26AS and 16A) along with a certificate issued by registered Chartered Accountant (with valid UDIN as per ICAI guidelines), clearly specifying the name of work, total payment received against the consultancy work, in support of their claim for having experience of stipulated value of work and TDS amount for the work.



- ii. Should have annualized average financial turnover of **INR 1.68 lakhs** against works executed during last three years ending 31st March of the previous financial year (i.e 31-03-2021). As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the tenderer should be submitted along with the application. Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected. **The Certificates issued by chartered accountant should have valid UDIN as per ICAI guidelines.**
- x. The tenderer should have a minimum net worth of INR **0.84** Lakhs Issued by certified Chartered Accountants with valid UDIN as per ICAI guidelines as per Annexure-IV
- xi. Financial data sheet as per Annexure-VI

Scanned copy of all the documents of Envelop- I mentioned above shall be submitted on the CPP-portal. Original/hard copy/copies of DD against Tender processing FEE is required to be submitted/sent to Deputy General Manager (Engg.- Civil), Dholera International Airport Company Ltd. (DIACL), 3<sup>rd</sup> Floor, A2 Wing, Block-1, Karmyogi Bhavan, Sector 10A, Gandhinagar (Gujarat)-382010 on or before date and time mentioned in CRITICAL DATA SHEET. The tenderer, whose DD against tender processing FEE are not received by the date and time mentioned in critical data sheet, then their tenders will be liable to be rejected. #### **Envelope- II: - The Financial e-bid through CPP portal: -**

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderers, the bid will be rejected.

#### 3. Bid Submission: -

The tenderer shall submit their application only at CPP Portal: <a href="https://etenders.gov.in/eprocure/app">https://etenders.gov.in/eprocure/app</a>. Tenderer /contractor are advised to follow the instructions provided in the tender document of online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.



Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- 4. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s) / director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 5. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website <a href="https://etenders.gov.in/eprocure/app">https://etenders.gov.in/eprocure/app</a>, shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to e banned from doing business with DIACL.
- 6. Bids Opening Process is as below: -

# Envelope-I: Envelope-I Tender processing fee, EMD declaration, Technical bid and Prequalification).

(Envelope -I containing documents as per Para 2 (A), (B) and (C) (Uploaded by the tenderers) shall be opened on date & time mentioned in CRITICAL DATA SHEET.

If the bidder has any query related to the Bid document of the work, they should use 'Seek Clarification' on CPP portal to seek clarifications. No other means of communication in this regard shall be entertained.

If any clarification is needed from the bidder about the deficiency in his uploaded documents in Envelope – I and Envelope – II, he will be asked to provide it through CPP portal or email if required. The tenderer shall upload the requisite clarification/documents within time specified by DIACL, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance /rejection of their bids will be intimated to the tenderers through CPP portal.

#### **Envelope-II (Financial Bid):**

Envelope-II containing financial bid of the tenderer found to be meeting the technical criteria and qualifying requirements shall be opened on date & time mentioned in CRITICAL DATA SHEET. (In case the date and time for opening of Envelope- II (Financial bid) is required to be changed, the same shall be intimated through CPP Portal).

- 7. DIACL reserves the right to accept or reject any or all applications without assigning any reasons. DIACL also reserved the right to call off tender process at any stage without assigning any reason.
- 8. DIACL reserve the right to disallow the working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/Temporary or Permanent debarment/black listing by any department of DIACL etc. DIACL reserve the right to verify the credential submitted by the tenderer at any stage (before or after the award the work). If at any stage, any information /documents submitted by the applicant is found to be



incorrect/false or have some discrepancy which disqualifies the tenderer then DIACL shall take the following action:

- (a) The tenderer. Shall be suspended for one year and shall not be eligible to bid for DIACL tenders.
- (b) The tenderer shall be liable for debarment from tendering in DIACL, apart from any other appropriate contractual/legal action.
- 9. Consortium /JV companies shall not be permitted.
- 10. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.
- 11. Concessions to Indian Micro & Small Enterprises (MSEs) units (enlisted for similar works i.e. Architectural Consultancy) registered with DIC/NSIC/KVIC/KVIB/Directorate of Handicraft and handloom etc. to be given as per the provisions of public procurement policy for MSEs order 2012, MSEs with up to date amendments, shall be applicable for tenders of supply/services and shall not be extended to construction work. Benefit as above to MSEs shall be available to MSE's registered for providing Architectural Consultancy only
- 12. Tenderers have to submit UDIN generated documents like Balance Sheet/Turnover certificate, Net worth certificate, Tax deduction at Source (TDS) certificate for Non-Govt. works etc. as per NIT conditions duly certified by CA and having UDIN. The documents by bidders without UDIN shall not be entertained.
