A = is the value of the existing commitments and ongoing works to be completed in the next 'T' years.

Note: Bid capacity of the tenderer and value of existing commitments for ongoing works during period of **11 months** w.e.f last date or extended last date of bid submission has to be submitted by the tenderer as per the prescribed performa mentioned at **Annexure-8A and Annexure-8B on page A-31 & A-32.** These data (Bid Capacity along with Annexure-8A and Annexure-8B) shall be certified by the Chartered Accountant/ Company Auditor with his stamp and signature in original with membership number and UDIN number.

viii) Companies other than propriety firm shall submit, scanned copy of Authorization Letter/ Power of Attorney along with copy of Certificate of Incorporation of the Company under Companies Act showing CIN/LLPIN/Name of Directors of the Company & Copy of Board Resolution regarding Authority of assign Power of Attorney.

- Proprietary firm shall submit scanned copy of Authorization Letter/ Power of Attorney only if the tender is processed by a person other than proprietor.
- ix) The Pre-qualification Performa (duly filled & signed) shall be submitted by tenderers. A-42 to A-46.
- x) Tenderer/Contractor should have EPF & ESI registration. (In case EPF & ESI registration are not available with bidder while submitting tender. Bidder shall submit an undertaking to submit EPF & ESI registration after awarding of work.)

C. Qualifying requirements of Contractor/tenderers containing the following:-

- i. Should have satisfactorily completed (Phase / Part completion of the scope of work in a contract shall not be considered, however pre-determined phasing of the work will be accepted) three works, each of Rs. 615.06/- Lakhs (Excluding GST) or two works, each of Rs. 768.82/- Lakhs (Excluding GST) or one work of Rs. 1230.11/- Lakhs (Excluding GST) in single contract of similar nature work (the similar nature work implies construction of Airport Terminal Building, Air Traffic Control Tower, Multiplex, Shopping mall, Five Star Hotels) during last seven years ending on last date (extended date) of submission of e-Bid in India.
- ii. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date (extended date) of submission of bid. The experience certificates of works completed pre GST era, completion amount will be divided by 1.12 (to exclude pre GST tax of VAT 12%).
- iii. Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Tenderers showing work experience certificate from non-government / non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the wok and TDS amount for the work.
- iv. Should have annualized average financial turnover of Rs. 461.29/- Lakhs against works executed during last three years ending 31st March of the previous financial year. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the tenderer should be submitted along with the application issued by certified Chartered Accountants & having UDIN. The documents submitted by bidder without UDIN shall not be entertained. Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- v. The tendered should have a minimum net worth of Rs 230.65/- Lakhs issued by certified Chartered Accountants & having UDIN. The documents submitted by bidder without UDIN shall not be entertained.

Scanned copy of all the Documents of Envelope-I mentioned above shall be submitted on the CPP portal. The requisite amount of Tender processing fee is required to be paid online only. The tenderer, whose Tender processing fee is not received, then their tender will be liable to be rejected.

Original / Hard copies of BG against EMD (along with Letter of undertaking from the Depositor to Bank duly acknowledged by Bank), hard copy of signed Unconditional Acceptance of AAI's Tender Conditions as well as signed original copy of Integrity Pact is required **to be submitted/ sent** to the Asst. (iii) While submitting the documents to BG issuing bank, the Vendors/Customers/Concessionaries will also submit a letter to the issuing bank as per the format given in the "Annexure -11"

Refund of EMD

The refund of EMD to tenderers, who fail to qualify in the eligibility / technical criteria, shall be initiated within 7 days of their rejection. For all tenderers who qualify and their financial bids are opened, the refund of EMD of all such tenderers except L-1 shall be processed within 7 days of opening of the financial bid.

Envelope-II: - The Financial e-Bid through CPP portal.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the Tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected.

3. Bid Submission:-

The tenderer shall submit their application only at CPP Portal https://etenders.gov.in/eprocure/app. Tenderer/ Contractor are advised to follow the instructions provided in the tender documents for online submission of Bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned documents.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- **4.** Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/ director(s) are common) be allowed to tender for the same contract as separate competitors. A Breach of this condition will render the tenders of both parties liable to rejection.
- **5.** Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website https://etenders.gov.in/eprocure/app, shall not tamper/ modify the tender from including downloaded price bid template in any manner. In case if the same is found to be tampered/ Modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AAI.

6. Bids Opening Process is as below: -

Envelope –I: (Tender Processing fee, EMD & other documents):

Envelope I containing documents as per Para 2 (A), (B) and (C) (uploaded by the tenderers) shall be opened on date & time mentioned in CRITICAL DATA SHEET.

If the bidder has any query related to the Bid Document of the work, they should use 'Seek Clarification' on CPP Portal to seek clarifications. No other means of communication in this regards shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope-I, he will be asked to provide it through CPP Portal or email if required. The tenderer shall upload the requisite clarification/ documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/rejection of their bids will be intimated to the Tenderers through CPP portal.

Envelope-II (Financial Bid):

Envelope-II containing financial bid of the tenderers found to be meeting the Envelope-I criteria shall be opened on date & time mentioned in CRITICAL DATA SHEET. (In case the date and time for opening of Envelope-II (Financial bid) is required to be changed, the same shall be intimated through CPP Portal).

- **7.** AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
- 8. AAI reserves the right to disallow the working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain / Temporary or Permanent debarment/ black listing by any department of AAI or Central/ State Govt. Depts/ PSUs/ World Bank/ ADB etc. AAI reserve the right to verify the credential submitted by the tenderer at any stage (before or after the award the work) If at any stage , any information/ documents submitted by the applicant is found to be incorrect / false or have some discrepancy which disqualifies the tenderer then AAI shall take the following action:
