## NOTICE INVITING e-TENDER (2BOT - 2 Envelope Open Tender)

1. Item Rate / EPC e-tenders are invited through the e-tendering CPP Portal by Senior Manager Engg(Electrical), AAI, B.P.I. Airport, Bhubaneswar on behalf of Chairman, A.A.I from the eligible contractors for the work / composite work of "Electrical Work for installation of integrated CWIS – RVR System at B.P. International Airport, Bhubaneswar" at an estimated cost of Rs. 7,12,462.00(Excluding GST) with completion period of Two (02) Months.

The tendering process is online at CPP-portal URL address https://etenders.gov.in/eprocure/app or www.aai.aero. Prospective Tenderers may download and go through the tender document. Prospective Tenderers are advised to get themselves register at CPP-portal, obtain 'Login ID' & 'Password' and go through the instructions available in the Home Page after log into the CPP-portal https://etender.gov.in / eprocure /app or www.aai.aero. They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their application. The process normally takes 03 days time. The tenderer may also take guidance from AAI Help Desk Support through path aai.aero/tender/e-tender/help desk support.

  - iii) Tenderer should deploy sufficient plant and machinery as per the requirement of the work in consultation with the Engineer-in-charge (EIC) to achieve the milestones/ targets and overall completion within the time period. Tenderer shall submit scanned copy of 'Undertaking' (Annexure-5) on Company's Letter Head at Page No-143 in GCC of Tender Document.
  - iv) Companies other than propriety firm shall submit, scanned copy of Authorization Letter / Power of Attorney along with copy of Certificate of Incorporation of the company under Companies Act showing CIN/LLPIN/Name of Directors of the Company & Copy of Board Resolution regarding Authority to assign Power of Attorney.
    - Proprietary firm shall submit scanned copy of Authorization Letter / Power of Attorney only if the tender is processed by a person other than proprietor.
  - v) Scanned copy of **Undertaking as per Performa given as Annexure-2 at Page No.-140 in GCC** of Tender Document.
  - vi) Scanned copy of duly signed undertaking by agency / bidder regarding compliance of GST provision as Annexure-3 at Page No. 141 in GCC of Tender Document.
  - vii) Scanned copy of 'Undertaking' regarding Blacklisting / Debarment on Company's Letter Head (Annexure-4, Page No.142 in GCC of Tender Document).
  - viii) Scanned copy of Net Worth issued by certified Chartered Accountant as per Performa given as **Annexure- 6** at **Page No-144** in GCC of Tender Document.
  - ix) Electrical Contractor having valid Electrical Contractor License.
  - x) PQ PROFORMA duly filled.

- C. Qualifying requirements of contractors / tenderers containing the following:-
- i) Should have satisfactorily completed (# Phase/Part completion of the scope of work in a contract shall not be considered, however pre-determined phasing of the work will be accepted) three works, each of Rs. 3,36,282.00(Including GST) or two works, each of Rs. 4,20,353.00(Including GST) or one work of Rs. 6,72,564.00(Including GST) in single contract of similar nature of "Electrical Works of SITC in nature" during last seven years ending on last date of submission of bid.

"The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid".

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Tenderers showing work experience certificate from non-government / non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by Registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Tenderers showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.

- ii) Should have UDIN generated annualized average financial turnover of **Rs. 2,52,212.00(Including GST)**, against works executed during last three years ending 31st March of the previous financial year. As a proof, UDIN generated copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the tenderer should be submitted along with the application. Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- iii) The tenderer should have a minimum net worth of **Rs. 1,06,869.00** turn over issued by certified Chartered Accountants last financial year,

Scanned copy of all the Documents of Envelope-I mentioned above shall be submitted on the CPP portal (Online payment copy for Tender processing fee and EMD is required to be submitted)

#### Refund of EMD

The refund of EMD to tenderers who fail to qualify in the eligibility/technical criteria shall be initiated within 15 days of their rejection by CPP Portal. For all tenderers who qualify and their financial bids are opened, the refund of EMD of all such tenderers shall be processed by CPP Portal within 15 days of opening of the financial bid or award of contract.

#### **Envelope-II:** - The Financial e-Bid through CPP portal.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected.

#### 3. Bid Submission: -

The tenderer shall submit their application only at CPP Portal: <a href="https://etenders.gov.in/eprocure/app">https://etenders.gov.in/eprocure/app</a>. Tenderer/Contractor is advised to follow the instructions provided in the tender document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- 4. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstance will father and his son(s) or other Close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 5. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website <a href="http://etenders.gov.in/eprocure/app">http://etenders.gov.in/eprocure/app</a>, shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AAI.

### 6. Bids Opening Process is as below: -

### **Envelope-I (Tender processing fee, EMD, Technical bid and Pre-qualification):**

Envelope-I containing documents as per Para 2 (A), (B) and (C) (uploaded by the tenderers) shall be opened on date & time mentioned in CRITICAL DATA SHEET.

If the bidder has any query related to the Bid Document of the work, they should use 'Seek Clarification' on CPP portal to seek clarifications. No other means of communication in this regards shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope - 1, he will be asked to provide it through CPP portal or email if required. The tenderer shall upload the requisite clarification/documents within time

specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/rejection of their bids will be intimated to the tenderers through CPP portal.

#### **Envelope-II (Financial Bid):**

Envelope-II containing financial bid of the tenderers found to be meeting the technical criteria and qualifying requirements shall be opened on date & time mentioned in CRITICAL DATA SHEET. (In case the date and time for opening of Envelope-II (Financial bid) is required to be changed, the same shall be intimated through CPP Portal).

- 7. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
- 8. AAI reserves the right to disallow the working agencies whose performance at ongoing project (s) is below par / usually poor / has been issued letter of restrain/Temporary or Permanent debarment/black listing by any department of AAI or Central /State Govt. Depts./PSUS/World Bank/ ADB etc. AAI reserves the right to verify the credential submitted by the tenderer at any stage (before or after the award of work). If at any stage, any information /documents submitted by the applicant is found to be incorrect/false or have some discrepancy which disqualifies the tenderer then AAI shall take the following action:
  - a) Forfeit the entire amount of EMD submitted by the tenderer.
  - b) The tenderer shall be liable for debarment from tendering in AAI, including termination of the contract apart from any other appropriate contractual/legal action.
- 9. Consortium/JV companies shall not be permitted.
- 10. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.
- 11. Tenderers have to submit UDIN generated documents like Balance Sheet/Turnover certificate, Working Capital Certificate (works done during last 5 financial years & works in hand), Net worth Certificate, Tax Deduction at source (TDS) Certificates for Non-Govt. works etc. as per NIT conditions duly certified by CA and having UDIN. The documents submitted by bidders without UDIN shall not be entertained.
