The quotation (Envelope "A"- Eligibility details) shall be opened in the office of the JGM (CNS) on **13/04/2022 at 14:00 hrs.** Envelope "B" of only those firms who have qualified will be opened thereafter either on the same day or at a date notified later. The Schedule of Quantity is enclosed at **Annexure-I** and the terms and conditions are mentioned here below:

I) Terms and Conditions:

1. Scope of work:

- 1.1. Supply of RAM and SSD as per the schedule of quantity mentioned in Annexure-I and specifications mentioned in Annexure-II.
- 1.2. A total of 03 No. of RAM and 06 Nos of SSD should be supplied and installed in the desktops which are installed in the operational offices of Hubballi Airport, Karnataka. The list of desktops to be upgraded are mentioned in Annexure-II.
- 1.3. **A sample RAM of each type should be provided and tested in the identified desktops of AAI, Hubballi. Items should be supplied and installed after successful compatibility check of RAM.**

2. Payment terms: 100% Payment shall be done after successful supply installation testing of all RAMs and SSDs. Invoice raised shall include applicable taxes.

3. Period:

- 3.1. Supply and Installation of items should be completed **within a period of 3 weeks from the date of receipt of purchase order.**
- 3.2. If there is any delay in completion of the work, Order placed for the work stands cancelled.

4. Rates:

- 4.1. Rates quoted shall be **exclusive** of GST.
- 4.2. In case of any ambiguity between the quoted rates in Figures & Words, the rate quoted in words shall be considered for evaluation.
- 4.3. Cost of installation and testing is to be included in the unit rate. No separate charges will be paid for installation and testing.

4. Compliance to the specifications of items mentioned in Schedule of Quantity (Annexure-I) to be should be submitted as per the Annexure-II.

5. Checklist as per the Annexure-should be submitted.

Envelope – B:

Should contain quoted price in the format given in the Schedule of Quantity at Annexure-I.

General Conditions:

Envelope "A" will be opened first on **13/04/2022 at 14:00 hrs.** After opening the Envelope – A, Price bids (Envelope "B") of only those firms who have technically qualified will be opened thereafter either on the same day or at a date notified later to the bidders qualified in the technical bid.
