RS. 51,330/- (Rupees Fifty one thousand three Hundred Thirty only) including GST (18%)

2. Eligibility criteria:

Any Proprietorship Firm/ Partnership Firm / Pvt. Ltd. Company or Company fulfilling the following criteria is eligible to participate in tender.

- **B.** Handover the original Calibration certificates with company seal & sign after successful completion of each test equipment calibration.
- **C.** Affix the stickers on each equipment after calibration with validity period & equipment details.
- **D.** The Calibration Certificate of equipment **[Equipment- NAV-ANALYZER]** should be valid for minimum three years from the date of calibration of equipment.
- **E.** The Calibration Certificate of equipment **[THRULINE WATTMETER]** should be valid for minimum One year from the date of calibration of equipment.

SECTION-II

GENERAL TERMS & CONDITION

- 1) Quotations received from a party or an individual falling under the following categories shall be rejected:
 - a) Having outstanding dues in respect of any contract with Airports Authority of India, at any airport under its administrative control.
 - b) Debarred /black-listed by Central Vigilance Commission, Central Bureau of Investigation or by Airports Authority of India.
- **2)** Duly completed quotation along with requisite documents should reach by registered/recorded post or in person at the following address on or before the due date & time positively.

- 3) On the master envelope "Onsite Calibration of test equipment used in CNS department at Civil Aerodrome, Vadodara Airport, Vadodara from NABL/BIS from accredited Laboratories." Should be written in clear & bold letters, which will contain sealed Envelope-A (Technical Bid) & Envelope-B (Financial Bid).
- **4)** Envelope 'B' (Financial bids) shall be opened after scrutiny of the basic documents of Envelope 'A' (Technical bid). Interested bidders or their authorized representatives may be present during opening of the sealed quotations.

5) <u>RATE</u>:

- a) The rates quoted shall be in **INR only**, and no increase in rates shall be entertained due to any of the reason during contract period.
- b) Amount quoted must include the charges including boarding, lodging, travelling expenses and all type of taxes inclusive of GST or any charges applicable. All the travelling expenses to be incurred by the agency to visit the site for complete scope of work, shall be included in the rates quoted by the agency and no payment in this account shall be reimbursed additionally.







6). TERMINATION OF CONTRACT:

- 4.1) the contract shall be deemed to have been automatically terminated on the expiry of the contract period unless A.A.I has exercised the option to extend this contract in accordance with the provision, if any, of this the contract.
- 4.2) If A.A.I considers the performance of the contractor is unsatisfactory or not up to the expected standard, then the A.A.I shall notify the contractor in writing and specify in details the cause of such dissatisfaction. A.A.I shall have the option to terminate the contract by giving 1 day notice in writing to the contractor, if, contractor fails to comply with the requisitions contained in the said written notice issued by the A.A.I.
- 4.3) After opening of documents in Envelop A & B, if anything found not as per NIQ terms & condition, then Quotation shall be rejected out rightly.
- 4.4) AAI reserves the right to accept/reject any/all quotation/s without assigning any reason.

7). PAYMENT

- 7.1). No advance payment shall be made to contractor.
- 7.2) Payment shall be released by AAI after satisfactory completion of the work as mentioned in work schedule/ Scope of work in Section-I, on production of Tax Invoice as per GST norms where breakup of base price and GST clearly mentioned.
- 7.3) All payments shall be through ECS. To enable ECS the vendor shall give the bank account details on company letter head with cancelled cheque. The format will be provided with work order. The format will be provided with work order.

8). LIQUIDATED DAMAGES: -

- **a)** That in the event of any default in complying with the terms and conditions of the contract by the contractor on which AAI at his discretion shall be the sole judge. AAI may recover such damages as may be determined and may also terminate this contract. The decision of AAI in this regard shall be final and binding on the contractor in all respect.
- b) If the successful bidder fails to complete the work within time fixed under the contract, he shall pay to the AAI without prejudice to any other rights or remedy as may be available to the purchaser, an agreed compensation amount calculated @ 1% of the tendered value per week or a part of week of delay or lesser amount as decided by the competent authority subject to the maximum of 10% of contract value.

9). <u>INCOME TAX</u>: -

As the enactment, income tax as applicable under law will be deducted.





10). SUBLETTING OF CONTRACT:-

The work shall not be sublet/assigned directly or indirectly to other agencies.

- **11).** <u>ARBITRATION</u>: Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with meaning, operation, effect, interpretation of the contract thereof which parties are unable to settle mutually, the same shall be referred to Arbitration for which arbitrator will be appointed by the A.A.I
- **12).** <u>IURISDICTION</u>:- The agreement including all matter with this agreement, shall be governed by the laws of India for the time being in force and shall be subject to exclusive jurisdiction of the Vadodara Court only.
- 12.1). The contractor has to sign and put the rubber stamp of his firm on each page of the N.I.Q. failing which his offer will not be considered.
