Item rate Sealed quotations are invited by Airport Director, Airports Authority of India, Dibrugarh Airport, Assam-786012 from Reputed agencies for the "Repair of Agni Vijay TATRA CAS-40 ACFT (manufactured by M/s Tovarna Hasici Technicky, Policka, Czech Republic) at Dibrugarh Airport."

1. TWO ENVELOPE SYSTEM

Quotations should be submitted in two separate envelopes.

- **A. ENVELOPE A -** Technical Bid Containing the following documents
 - i) Copy of GST registration
 - ii) Copy of PAN Card
 - iii) Seal & Signed Undertaking Cum Declaration certificate as per Annexure-I (Page No. 3)
 - iv) Copy of NIQ pages 1 to 3 (either downloaded from AAI website or obtained from AAI Technical Department) duly seal & signed by the bidder on each page accepting terms & conditions.
- **B. ENVELOPE B** Price Bid Containing the following document.
 - i) Un- conditional price bid in prescribed format as per Annexure II

Both the envelopes super scribing Envelope- A (Technical Bid) & Envelope-B (Price Bid) shall be separately sealed and placed in a master envelope. The master envelope shall also be sealed and super scribed with the name of the work and submitted to In-charge (Tech), Airports Authority of India, Dept. of Technical, Dibrugarh Airport, Assam -786012. Offers not adhering to two envelope system or unsigned offer shall be rejected out rightly.

Envelope- B shall be opened after evaluation of basic documents of Envelope – A.

2. OTHER TERMS & CONDITIONS

The rate quoted shall be including all applicable charges except GST for Completion of work at Dibrugarh Airport.

The rates shall be valid for acceptance for 45 days from the date of opening of Financial Bid

The taxes and other charges if any should be clearly specified and in case it is not applicable the relevant row / column should indicate "Not Applicable" or "Nil" or "Included" and in the event it is left blank, it shall be deemed to have been included in the basic cost.

The bidders are requested to offer their best-discounted rates. The rates quoted in Annexure –II should be inclusive of Basic Cost, Transportation charges, Transit Insurance Charges, Loading & unloading charges, Packing & Forwarding Charges, Installation Charges, any Consumable Charges in connection with completion of work and any other extra charges but exclusive of GST.GST shall be quoted separately in the annexure-II. No extra payment will be made other than the quoted amount.



In the event of the date of opening of technical bid or price bid is postponed due to administrative or technical reasons, the same shall be opened on the next working day. The bidders can be present during opening of technical and price bid if they wish to. No separate intimation will be given in this regard.

The quantity may vary during actual execution of works. The bidder shall execute the additional quantity at their quoted rates up to 50% of quantities given in Annexure-II.

AAI is not bound to accept lowest quotation and reserves the right to accept or reject any or all quotation without assigning any reason there-of, and to call for any other details or information from any of the bidder.

AAI shall not be responsible for any postal delay and offers received beyond stipulated date and time shall not be considered.

All-time extensions, corrigenda, addenda, amendments, clarifications etc. if any to the NIQ document will be posted on AAI website. Bidders should regularly visit website to keep themselves up dated.

The Agency may visit and inspect the vehicle before quoting the rates in financial bid for proper understating the quanta of work required in repair work etc.

The evaluation criteria for the purpose of identifying the lowest bidder shall be on the basis of lowest quoted total amount (inclusive of all charges) excluding GST and in case of identical quoted amount, the price negotiation shall be done as per AAI guidelines.

The starter motor and ignition switch shall have minimum 1-year warrantee after completion of work.

Payment will be made within 15 days through RTGS on receipt of material along with bill at Dept. of Technical, Dibrugarh Airport, Assam.

The completion of work shall be within 15 days from the date of work order and if the contractor fails to complete within the allowed period, a liquidated damage/ penalty calculated @ 0.5% of the total order value (Incl. of GST) of uncompleted portion of work per week or part thereof subject to maximum of 10% of value of delayed items (Incl. of GST).
