SH:Laying of LT cables at Surat Airport, Surat,"at an estimated cost of Rs.12.73 Lakh (excluding GST) with a completion period of Three (03) Months.

In-case bidder is having multiple business verticals in a state and having separate registration for each business vertical, GSTIN of each vertical concerned with the supply and service involved, as per the scope of NIT to be informed to AAI. In case firm do not possess the same & becomes L1 the firm will be required to get it essentially before award of work.
- vi. Firm shall submit EPF and ESI registration proof. In case, firm do not possess the same & becomes L-1 then firm is required to get themselves registered with EPF & ESI authorities and submit it within 30 days after the award of work. An undertaking for the same need to be submitted.

C. Qualifying requirements of contractors/ tenderers containing the following:-

Should have satisfactorily completed (Phase/Part completion of the scope of work in a contract shall not be considered, however pre-determined phasing of the work will be accepted) three works, each of Rs.5.09Lakh(E/x GST) or two works, each of Rs.6.37Lakh(E/x GST) or one work of Rs.10.18Lakh(E/x GST) in single contract of similar nature i.e. "Laying of HT / LT Power cables and it's associated works " in India during last seven years ending on last date or extended date of submission of bid as per critical data sheet.

"For the experience certificates of works completed pre-GST era, Completion amount will be divided by 1.12 (to exclude pre-GST tax of VAT) to make it at par with experience certificates of post GST era but excluding GST."

"The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum,



calculated from the date of completion to the last date of submission of bid or extended date of submission of bid as per critical data sheet".

Client certificate for experience should show the nature of work done, the value of work done, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. The tenderer should submit work order along with detailed BOQ.

Tenderers showing work experience certificate from Non-Government/ Non-PSU Organizations should submit copy of Tax Deduction at Source [TDS] Certificate alongwith a certificate issued by registered Charted Accountant mentioning UDIN No, clearly specifying the name of work, total payment received against the work and TDS amount for the work.

- ii. Should have annualized average financial turnover of **Rs.3.82Lakh** against works executed during last three years ending **31st March 2022**. As a proof, copy of Abridged Balance Sheet, Profit and Loss Account Statement (with UDIN no) of the Tenderer should be submitted along with the application. **Tenderer showing continuous losses during the last three years in the balance sheet shall be summarily rejected.**
- iii. The tenderer sheet should have a minimum net worth of **Rs.1.91Lakh** issued by certified Charted Accounted (As per format given at **Page No.165** of tender document mentioning UDIN No).

Scanned copy of all the Documents of Envelope-I mentioned above shall be uploaded online on the CPP portal upto due date and time as per critical data sheet. Any documents in any other mode shall not be accepted. Non-submission of tender processing fee, EMD and Technical particulars shall lead to disqualification of tenderers.

Refund of EMD

The refund of EMD to tenderers who fails to qualify in the eligibility/ technical criteria, shall be initiated as below:

- a) The online payment made against tender processing fee by the tenderer will remain on **'Tender Settlement Account'** and EMD amount will remains in **'Pooling Account'**.
- b) After Opening the tender and submission of technical evaluation report on the CPP portal, The EMD of technically qualified bidders will remain in the pooling account and EMD amount of rejected tenderers will be refunded to their source account.
- c) After submission of financial evaluation report on the CPP portal, the EMD of L1 tenderers will remain in the pooling account and EMD amount of rejected bidders will be refunded to their source account.
- d) After A.O.C. completion on the portal, EMD amount of L1 bidder will be refunded to their source account subject to Adjustment of Security Deposit (SD) as per NIT Condition.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the

same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderers). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the yenderer, the bid will be rejected.

3. Bid Submission:

The tenderer shall submit their application only at CPP Portal: <u>www.etenders.gov.in</u> Tenderers/Contractors are advised to follow the instructions provided in the tender document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per para 2.Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned documents.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- 4. Not more than one tender shall be submitted by one contactor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 5. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website <u>http://etenders.gov.in/eprocure/app</u>, shall not tamper/ modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tempered /modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AAI.

6. Bid Opening Process is as below:

Envelope-I (Tender processing fee, EMD, Technical bid and Pre-qualification):

Envelope-I: Containing Documents as per para 2 (A), (B) and (C) (uploaded by the tenderers) shall be opened on date & time mentioned in the CRITICAL DATA SHEET. If the bidder has any query related to the Bid Document of the work, they should use 'Seek Clarification' on CPP portal to seek clarifications. No other means of communications in this regards shall be entertained. If any clarification is needed from the bidder about the deficiency in his uploaded documents in Envelope – I, he will be asked to provide it through the CPP portal or e-mail if required. The tenderer shall upload the requisite clarification / documents within time specified by AAI, failing which it shall be presumed that Bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/rejection of their bids will be intimated to the tenderers through CPP portal.
