4. The basic documents submitted in **Envelope-A (Technical Bid)** will be evaluated first and the Price bid of technically qualified Bidders will be opened.

Terms & Conditions:

- 1. The Transporter / Carrier / Freighter is advised to study the Dimensions / Details of machine given in Annexure-I, Financial Bid (Annexure –III) and Unconditional Acceptance Letter (Annexure –II). The bidders are requested to offer their best-discounted rates. The rates quoted in Annexure-III should be exclusive of GST and inclusive of all other charges including ramp facility for Loading of complete machine, Transportation, Unloading of material at destination Airport and other incidental charges like Toll, Transit Insurance etc. No extra payment will be made other than the quoted amount. Further before Quoting rate the equipment can be inspected at Regional E&M Workshop, LGBI Airport, AAI, RHQ-NER, Guwahati-781015. Transporter should ensure all RTO compliance for their deployed Truck-Trailer and driver till completion of the job.
- 2. The bidder has to purchase Inland Transit Insurance Policy for 01 No. New Holland Tractor fitted and Grass Cut and Collect Machine before shifting/transportation.
- **3.** The New Holland Tractor and Grass Cut cum Collect Machine were procured in 2019 and purchase cost is as follows
 - a. New Holland Tractor- ₹ 14,54,039.13
 - b. Grass Cut cum Collect Machine- ₹ 70,46,730.03 Total Purchase Cost- ₹ 85, 00, 769.16
- **4.** In the event of the date of opening of technical bid or price bid is postponed due to administrative or technical reasons the same shall be opened on the next working day.
- **5.** Evaluation of price bids will be based on overall Lowest Bid status (Exclusive of GST). In case rate offered by two or more firms are same, AAI may on its discretion decide suitably to award the work to any of the lowest bidder. No query shall be entertained in this regard and decision of AAI shall be final, and binding on all the bidders. AAI is not bound to accept lowest quotation and reserves the

- right to accept or reject any or all quotation without assigning any reason thereof, and to call for any other details of information from any of the bidder.
- **6.** AAI shall reserve all rights to accept or reject any / all quotation without giving any reasons whatsoever.
- **7.** The rates shall be valid for acceptance for 90 days from the date of opening of Technical bid.
- 8. The firm should not submit more than one offer.
- **9.** The bidders can be present during opening of bid if they wish to.
- **10.** All-time extensions, corrigendum, addendum, amendments, clarifications etc. if any to the NIQ document will be posted on AAI website. Bidders should regularly visit website to keep themselves updated.
- **11.** Your quotation kept in a sealed envelope should be sent to this office on or before the last date and time for Bid Submission. AAI is not responsible for any postal delay and offers received beyond stipulated date and time shall not be considered.
