Airport Authority of India, Bhavnagar Airport is having 13 nos. vehicles (11 Nos. diesel vehicles and 02 nos. petrol vehicles) with 02 D.G. Set & 01 Mobile D.G. Set at Bhavnagar Airport. We are interested to enter into Annual Contract for availing credit facility for drawing POL Items (Diesel & Petrol) on regular basis for the period of two years from the date of entering into contract on following terms and conditions. The offer shall be given in attached format at Annexure-1.

- 1. Bill cycle will be for 15 days i.e. from 1st to 15th and 16th to 30th.
- 2. The POL supplier will have to ensure submission of bills within 5 days of completion of each cycle i.e. up to 20th and 5th of every month.
- 3. On recent of bill, AAI will ensure to release the payment within 10 days i.e. up to 30th and 15th of each month.
- 4. The POL supplier will have to provide the credit slip to AAI free of cost, well in advance to the Airport Director, Airports Authority of India, Bhavnagar Airport, Bhavnagar-364001 for smooth functioning of the arrangement.
- 5. The rate of POL items will be charged as approved by the Govt. from time to time.
- 6. AAI may not deposit any advantage for this purpose.
- 7. POL supplier will have to give one month notice prior to withdrawing the services and this notice period clause will also be applicable on AAI while terminating the contract.
- 8. In case the services of POL supplier are not found satisfactorily, AAI will have the right to go for termination of contract as per clause 7.
- 9. This rate contract will be further extendable for one more year on mutual consent of both the parties and at the same terms and conditions.
- 10. We have estimated expenditure of ₹. 9.50 Lakhs for POL (diesel & petrol) during 2022-23.
