1. **Eligibility Criteria:** - Applying Agency should have valid Permanent Account Number (PAN), GST Registration, Work Experience Certificate, Valid Electrical License etc.
2. **Method of Submission:** - The quotations shall be submitted in the prescribed form in 02 (two) envelopes. The contents of the envelopes shall be as follows:

Name of the work as mentioned above, Envelope No., Address of officer and Name & address of submitting agency shall be mentioned on the envelope.

Envelope- I: - Pre-qualification documents shall contain self-attested copies of

- i) Permanent Account Number (PAN).
- ii) GST Registration.

3. Should have satisfactorily completed (# Phase/Part completion of the scope of work in a contract shall not be considered, **however pre-determined phasing of the work will be accepted**) three works, each of **Rs. 0.93 Lacs** or two works, each of **Rs. 1.16 Lacs** Or one work of **Rs. 1.86 Lacs** in single contract of similar during last seven years ending on **31.03.2022**.

“The value of executed works shall be brought to current level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid i.e., 31.03.2022.”

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. **Tenderers showing work experience certificate from government and PSU.**

Envelope- II: - Price Bid shall contain this quotation form duly signed by authorized representative on all pages. Rates shall be quoted in the prescribed column in attached Annexure- "A" (Schedule of quantity).

4. **Procedure of Opening of Quotations:** - Envelope No. 1 will be opened on prescribed date and time in the office of In-charge, AGM(E-E) JPNI Airport, AAI, Patna in presence of bidders (if any), on scrutiny of documents in envelope no. 1 for fulfilling eligibility criteria the envelope no. 2 (i.e., price bid) will be opened.
5. **Award of Work:** - Work will be awarded to the firm offering lowest price for the work.
6. **Time period of work:** - The period for work will be of 10 Days.
7. **Condition for work execution:** -
 - a) Items supplied shall meet with the IS or CPWD specifications.
 - b) All the items have to be supplied with all the accessories as supplied by manufacturer and installed at JPNI Airport, Patna or at the locations as directed.
 - c) The Agency shall be responsible for all damage due to negligence or default of his work man.
8. **Price:** - The rates quoted shall be inclusive of all taxes, duties but excluding GST as applicable.
9. **Declaration by The Agency/Bidder:** - I/We hereby declare that none of the members or my/our relatives is relative of any employee of AAI and I/We also further declare that no Director/Employee of Airports Authority of India is/are a Director/Partner of my/ our firm/ Company/ Partnership/ Proprietor.
10. Agency shall be responsible for compliance with all obligations and restrictions imposed under the rules and regulation of AAI made there under as applicable on date.
11. The Agency is advised to study the schedule of work/quantities. Also, to quote rate against each item shown in Schedule-A attached. Special care shall be taken to write rates in "FIGURES" and as well as in words and the AMOUNT in FIGURES only in such a way that interpolation is not possible. The total amount shall be written both in words and Figures. Agency shall inspect the site and deemed to have full knowledge of the work before the quotations are submitted.
12. The quantity shown in the schedule may vary during actual execution of work. You shall carry out the work as per actual site requirement, whatever be the change of scope of work for the agreement items, Agency is supposed to execute at the quoted rates for which he cannot claim any extra cost whatsoever it may be.
13. On completion, each item of work shall be jointly measured by you or your authorized representative and the AGM (E-E), JPNI or his representative.

14. After satisfactory completion of the work, final bill shall be submitted by you to the E-I-C JPNI Airport and the same shall be processed with the following documents:
 - a) Certificate of completion of work issued by the Jt.GM (E-C), JPNI at the time of final bill.
 - b) Other relevant documents, if any.

TERMS OF PAYMENT: - Final bill will be paid after satisfactory completion of work at site with the necessary documents after deducting security deposit@ 10%, IT, CESS, TDS GST @2% as applicable and SD shall be released after successful completion of **defects Liability period of One Year**. GST shall be reimbursed to the agency after production of original GST invoice.

15. **COMPENSATION FOR DELAY/POOR PERFORMANCE:** - If you fail to complete the work within the stipulated period and no justifiable reasons are found for the delay, Compensation for delay shall be levied at the rate of 1% of total value of work order per week subjected to a maximum of ten percentage of the bill amount.
16. **IN – CHARGE:** Jt.GM(E-C), JPNI, Airports Authority of India, Patna who will be the in - charge for this work.
17. **Guarantee:** work shall be guaranteed for one year. Agency has to repair/replace the items at free of cost during this period (if required).
18. The quotation shall be valid for 90 days from the date of opening.
19. Airports Authority of India reserves the right to reject any or all quotations and will not be bound to accept the lowest quotation.
20. The Agency shall sign in the place provided as a proof of acceptance of items and conditions and the same shall be returned along with schedule.
