

FILE NO. : **SCOPE OF WORKS:-** "Transportation of 01(One) UPS system with batteries (25 Boxes of approximate 1200 KG apprx) from Guwahati Airport to Hollongi Airport, PIN- 791113, Arunachal Pradesh & 01(One) UPS system with batteries (25 Boxes of approximate 1200 KG apprx) from Guwahati Airport to Ballary Airport, Bellary - 583 104, Karnataka by suitable Vehicle, including Loading from Guwahati Airport and Unloading at Hollongi & Ballary Airport by suitable means which include transit insurance for the above mentioned items value Rs. 5,13,761/- each total cost is 10,27,521/- (Rupees Ten Lakhs Twenty Seven Thousand Five Hundred Twenty One only). 2). **RATE:** The rates quoted shall be in INR only, and no increase in quoted rates shall be entertained. The hire rate shall be net inclusive of Transit Insurance of the items and cost of transportation and other levies including GST. No other charges will be paid extra.

- AAI reserves the right to accept or reject any or all quotation without assigning any reason there-of, and to call for any other details or information from any of the bidder.
- Transportation of Goods from Guwahati Airport to Hollongi Airport & Guwahati Airport to Ballary Airport by suitable vehicle including Loading and Unloading by suitable means like labors & Hydra.
- Site Visit is requested to Bidder for understand the scope of work.
- All essential documents such as valid Certificate relating to Registration Road-tax, insurance, fitness, permit; PUC etc. (whatever applicable) should always be available with the vehicle and one copy of each should be submitted to O/o Jt.GM, CNS, AAI, Guwahati Airport. Before loading of the 02 nos UPS with accessories Transit Insurance in favour of Airports Authority of India, L.G.B.I Airport must be handed over to Jt.GM(CNS),AAI, L.G.B.I Airport, Guwahati.
- The contractor shall ensure that only skilled driver with sufficient experience in respective trade are deployed on the job to avoid any accident/mishap and are not put over- exertion, as per applicable labor laws.
- The contractor shall indemnify the AAI against any claim arising out of operation of this service for AAI.
- The contractor shall ensure the driver /Operator engaged by him to drive the vehicle should fulfill and fully comply with the requirements of Motor Vehicle Act and other statutory provisions

3). **PENALTIES:-**

In case the contractor fail to provide the service requisitioned, within 7 days from the date of issue of work order the A.A.I reserves the right to hire such services as requisitioned from the market at the risk and cost of the Contractor and the hire charges including additional amount if any, over and above the rate agreed to by the contractor, will be deducted from the bill payable to the contractor. The amount stated by the Project-in-Charge shall be final and binding on the contractor.

4).TERMINATION OF CONTRACT:

The contract shall be deemed to have been automatically terminated on the expiry of the contract period unless A.A.I has exercised the option to extend this contract in accordance with the provision, if any.

If A.A.I considers the performance of the contractor is unsatisfactory or not up to the expected standard, then the A.A.I shall notify the contractor in writing and specify in details the cause of such dissatisfaction. A.A.I shall have the option to terminate the contract by giving 1 day notice in writing to the contractor, if, contractor fails to comply with the requisitions contained in the said written notice issued by the A.A.I.

5) Work Completion period:

Work completion period is 15 Days which will be reckoned from the next date of issue work order.

6) PAYMENT

6.1). The payment will be made after successful completion of the work for both the sites (Hollongi & Ballary Airport) as certified by the Station In-Charge of the respective Airport.

6.2). No advance payment shall be made to contractor. However, Contractor shall submit bills in duplicate along with Bank Mandate duly signed by bank Authorized officials along with stamp after completion of Job.

6.3). AAI shall arrange to make payment on the receipt of the bill through RTGS/NEFT.

7). LIQUIDATED DAMAGES: - If the successful bidder fails to complete the supply / work within time fixed under the contract, he shall pay to the AAI without prejudice to any other rights or remedy as may be available to the purchaser, an agreed compensation amount calculated @ 1 % of the total value of the uncompleted portion of the work per week or part thereof subject to a maximum value equal to the 10% of Total Contract value. If the work is delayed by 2 weeks, AAI reserves the right to cancel the contract. In the event of any default in complying with the terms and conditions of the contract by the contractor/seller on which AAI at his discretion shall be the sole judge. AAI may recover such damages as may be determined and may also terminate this contract. The decision of AAI in this regard shall be final and binding on the contractor in all respect.


8)COMPENSATION: - The contractor shall be wholly responsible for and shall pay any compensation to the workman which would be payable for injuries/accidents under the Workman Compensation Act.AAI will not be liable for the same at any circumstances.

9) INCOME TAX: - As the enactment, income tax as applicable under law will be deducted at source from the contractor's bill.

10) LIASON: - The contractor shall keep close liaison with the official and supervising staff to ensure smooth operation.


11) SUBLETTING OF CONTRACT:- The work shall not be sublet/assigned directly or indirectly to any other agencies.

12) ARBITRATION: - Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with meaning, operation, effect, interpretation of the contract thereof which
