Bidders are requested to go through FAQ and help files available in the portal (CPPP). In case of any difficulty, bidders may contact the help desk numbers and emails ID provided in the CPP Portal.

### 4. Submission of Tender Fee & EMD

#### 4.a. Tender Fee.

The tender fee is Rs.590/- (Rupees five hundred and Ninety only) (Rs.500 plus 18 % GST). The tender fee is non-refundable. Bidders shall pay the tender fee through NEFT/RTGS in favor of **Airports Authority of India, Trivandrum.** The details of transaction including UTR number shall be submitted online along with technical bid in cover A

### 4.b. Earnest Money Deposit(EMD).

- (i) Each tender shall accompany with the Earnest Money Deposit of **Rs**. 8190/- (Rupees Eight One Hundred and Ninty only). Earnest Money Deposit shall be paid online by way of NEFT/RTGS in favor of Airports Authority of India, Trivandrum. The details of Electronic fund transfer of EMD also to be submitted online along with technical bid in cover A
- (ii) Tenders not accompanied by the requisite EMD and Tender Fee shall be summarily rejected. Scanned copy of the details of the EMD and Tender fee payment shall be uploaded along with **Technical Bid** documents.
- i (iii) Concessions to the bidders registered with NSIC, shall be applicable as per the directives of Govt. of India.

#### 5. Procedure for exemption of tender fee and EMD for NSIC/MSME registered firm.

- a. Eligible Bidders need not pay the tender fee /EMD and can download the tender form free of cost.
- b. Bidders shall upload valid NSIC registration Certificate online. During bid evaluation Tender Fee/EMD exemption shall be granted to the NSIC registered firm .However the benefits of MSME can be available to goods and services produced and provided by the MSME for which they are registered. In case NSIC registration certificate is found invalid during evaluation the bid of such bidder shall be rejected without any explanation.

The following procedure is adopted for the bidders registered with NSIC.

- 6. Forfeiture of EMD amount
- a. AAI is liable to return EMD amount subjected to terms and conditions of the Tender
- b. All bank charges shall be to bidder's account.
- c. Bidders shall provide to AAI requisite Bank Account details for return of EMD.
- d. The EMD of the unsuccessful bidder shall be returned subjected to terms and conditions of the Tender, on award of contract to successful bidder and EMD of bidder who are not qualified in initial eligibility requirement or Technical qualification, EMD shall be refunded after Prequalification/Technical evaluation.
- e. If any successful shortlisted bidder, due any unsatisfactory reason in view of AAI, does not want to further participate in the tender then EMD in any form of such bidders shall be encashed and forfeited.

f. Any firm who wishes to sublet or outsource to any third party then it shall bring to notice of AAI in submittals to this bid itself. AAI may or may not agree or accept such intentions / proposals of out sourcing or subletting of scope of work in the tender.

g. Bidder firm shall also submit an undertaking that if any portion of the work is outsourced or subcontracted then it shall accept all AAI objections within the scope of work or shall change/replace subcontractor if required by AAI and shall undertake work itself without any compensation.

h. If due some reason AAI cancels this tender then EMD of all bidders without any interest shall be returned back

#### 5. Eligibility Criteria:

Firms or supplier must have experience in similar work in PSUs, Government organizations, and should have successfully executed in last three years, orders for Supply of similar items meeting any one of the following criteria.

### 7.1 Experience (Inclusive of Tax)

- i. One order of value more than or equivalent to **Rs.3,27,600/-** (80% of Estimated Cost)
- ii. Two orders each of value more than or equivalent to **Rs. 2,04,750/-** (50% of Estimated Cost)

iii. Three orders each of value more than or equivalent to **Rs.1,63,800/-** (40% of Estimated Cost)

Date of publishing of NIT in AAI site will be taken as reference for assessing the eligibility criteria.

Experience certificate in respect of the above works should be issued by the end user agencies for whom the works have been carried out and endorsed by the bidder. Such performance/experience certificates should clearly indicate the following:

- i. Value of order or contract,
- ii. Scope of order or contract,
- iii. Order or Contract No., Award date
- iv. Order or Contract Completion date.
- v. That the supplied & installed systems have performed satisfactorily after commissioning.

### 7.2 Bidders must have valid GST registration.

**7.3 The bidder shall be an established Company** registered in India having experience of providing such hardware/devices. The company shall be in operation for a period of 3 years in

India as on date of submission of bid. Bidder should be registered under the Indian companies act.

### **7.4 Annualized average financial turnover**: (Inclusive of Tax)

Bidder should have a minimum annualized average financial turnover of **Rs. 1,22,850/- (30% of the estimated cost)** or equivalent during last three financial years, ending on 31st March 2022. As a proof of financial turnover, copy of abridged Balance Sheet along with Profit & Loss account of the firm (bidder) for last three years should be submitted. A Certificate from Statutory Auditor / CA stating shall also be accepted as a proof of financial Turnover, net worth and profitability.

### 7.5 Should be a Non Black Listed Company

Bidder firm shall submit an undertaking stating its firm or its partners or its Directors have not been black listed or any case is pending or any complaint regarding irregularities is pending in India by any Indian State/Central Governments Departments or Public-Sector Undertaking of India as on date of bid submission.

#### 7.6 OEM or Its Authorized dealer

The firm shall be either OEM or its authorized dealer or system integrator. Supporting document for being OEM or letter of authorization from the OEM is to be submitted.

## 6. Down loading of Tender Document

Tender documents can be downloaded from CPP portal <a href="https://etenders.gov.in/eprocure/app">https://etenders.gov.in/eprocure/app</a> (Government of India, Central Public Procurement Portal). Only one tender document shall be submitted by a single party either a firm or an individual. The proprietor of more than one company or firm will be considered as single party and one legal entity. Downloaded tender documents duly filled and digitally signed shall be submitted through E-tendering process described in above said portal along with the details of the non-refundable tender fee. Any amendment or corrigendum to the tender document shall be posted only on CPP portal and AAI website.

- 7. The Bidding is through two Bid system. The Cover-01 (Pre qualification and Technical Bid) shall be opened on the dates specified and cover-02 (Financial Bid) will be opened later for the vendors found to be meeting the eligibility criteria which will be intimated.
- **8.** The Bids opened Online through CPP Portal shall be evaluated by a committee duly constituted by the Airport Director, Airports Authority of India, Trivandrum Airport.
- **9.** Clarification needed if any may be sought through the CPP portal only and not through any other means. Bidders are advised to visit the CPP portal to get the details and familiarize in this regard. Clarifications/queries may be uploaded on the procurement portal in MS Excel sheet as per format below
