 The work is inclusive of Loading & Unloading, Ramp facility for loading,
 Unloading, Transportation of Goods/ Equipment to the destination in
 good condition without any damage.
- II. Transporter should ensure all RTO compliance for their deployed Truck Trailer and Driver till completion of the job.
- III. **RATE:**-Rate quoted shell is inclusive of all charges including ramp facility for other incidental charges like Toll Transit Insurance etc. No payment will be made other than the quoted amount.
