- The scope of work involves execution of following items and shall be executed as per CPWD Specifications and as per EIC Instructions.
 - a) Internal Electrification & Provision of Air-conditioner at Ancillary Building.

Agencies are requested to quote their rates in the format given at Schedule-A (Pg No1-4).

- The quotations shall be submitted in the office of Asst. General Manager Engg (E), Hubballi Airport, Hubballi – 580030 on or before 1500 Hrs on <u>09.05.2022</u> and shall be opened at 1530 Hrs on same day in presence of agencies present at the above time.
- 4. The date of completion of work shall be of **30 days** from the date of Handing over of site or 10th day from Date of Award of work whichever is earlier.

5. Submission of Quotation

The agency shall submit their offer in two sealed envelopes **ENVELOPE ',I'**, and **ENVELOPE 'II**" The firm should submit the following, sealed and signed Documents, in order to participate in Quotation, failing which the agency participation shall be summarily rejected.

I. ENVELOP-I

Qualifying requirements of Contractor/ Firm:-The firm should posses following Qualification:-

- a) Agency Should Have Permanent Account Number(PAN)
- b) Agency Should Have GST Registration.
- c) Unconditional Acceptance with sealed & Signed (Enclosed as Annexure-B)
- d) The original / downloaded NIQ duly signed on each page(NIQ Page No1 to 6)

a) Dully filled and signed (Financial quote) Schedule of Quantity- Schedule A.

Price bids **(Envelope "II")** shall be opened of only those firms who have submitted all the necessary documents as mentioned above in Envelope "I" and have also agreed to all the terms and conditions of this NIQ without any deviations and who have not stipulated any additional conditions in Envelope "II".



6. GENERAL AND SPECIAL TERMS AND CONDITIONS

- i) Price & Payments: The Successful agency/ contractor shall submit Original GST Invoice after completion of work. Payment shall be released after deducting statutory taxes such as Income Tax @ 2%, Labour Welfare Cess@1 % and GST TDS @2% on gross value of work done etc., for which the contractor may become liable. The final bill shall be submitted by the contractor to the Engineer-in-charge and the same shall be processed with the following documents.
 - a) GST Invoice in proper format indicating HSN/SAC Code & Tax Percentage clearly.
 - b) Other relevant Documents like Proof of GST Payment made, if any required at the time of billing.
- ii) Security norms/ Guidelines Contractor shall obtain necessary entry pass/token/identity card for work force from AAI/BCAS/CISF/CRPF and vehicle/ machinery passes etc who is in charge of security matters. It is the responsibility of the contractor to fulfill all the relevant formalities viz police verification, photographs, addresses and keeping in safe custody etc and bear the fee, if any.
- iii) **ENGINEER–IN-CHARGE:** The Assistant General Manager (Engg-Elect), Hubballi Airport, Hubballi shall be the Engineer In-Charge for this work.
- iv) **DEVIATION:** The quantity shown in the schedule may vary during actual execution of work. You shall carry out the work as per actual site requirement whatever be the change from the scope of the items at the same rate as quoted by you upto the maximum limit of 30% of the total value of amount quoted.
- v) VALIDITY: The quotation shall be valid for a period of 90 days from the date of opening of quotation.

vi) **REJECTION CLAUSE:**

- a) AAI reserves the right to reject any or all of the quotations without assigning any reason thereof and shall not be bound to accept the lowest quotation only.
- b) AAI reserves the right to disallow issue of Quotation to the working agencies whose performance at ongoing project(s) is below par or unusually poor.
- c) AAI is not responsible for any postal delay in receipt of the quotations.
- vii) On completion of work, the same shall be jointly measured by the department and the contractor. Unused materials, debris etc. shall be removed by the contractor. The final bill shall be processed as follows:
 - a) Measurement book will be jointly signed by the Contractor and the Engineer–In –Charge/ its authorized representative.
 - b) Completion certificate will be issued by the Engineer In-Charge.



- viii) The agency shall sign in the place provided as a proof of acceptance of terms and conditions and the same may be returned along with schedule, otherwise the quotation is liable to be rejected.
- ix) It shall be ensured by the agency that all the workmen deployed by him follows standard safety practices during the period of work. AAI will not be responsible for any accident/emergencies during the work.
- x) No claim/Compensation against untoward incidents/accidents during the execution of work shall be borne by AAI. The successful agency is responsible for such claims/compensations and need to be settled.
- xi) Any loss or damage for material issued departmentally shall lead to recovery at the cost of material. The decision of Engineer-in-Charge shall be final in this regard.
- xii) The Agency shall make his own arrangement for watch and ward of T&P items and Materials during the execution of the work. AAI is not responsible for any loss of materials.
- xiii) The work shall be executed in co-ordination with all departments at the airport and also no inconvenience shall be caused to the passengers/public/agencies.
- xiv) Work shall be carried out as per directions of Engineer-In-Charge or its authorized representative. The Agency shall indemnify AAI against all claims, damages, and compensations under relevant labour acts and shall insure the entire work at his cost.
- xv) Specification:- All the works shall be carried out as per CPWD norms and materials shall be supplied as per attached AAI Approved List of Make. Prior to supply any material agency has to take approval from the EIC.

v. In event no rate has been quoted for any item(s), leaving space both in figure(s), word(s), and amount blank, it will be presumed that the bidder has included the cost of this/these item(s) in other items and rate for such item(s) will be considered as zero and work will be required to be executed accordingly.
