1. Item rate e-tenders are invited through the e-tendering CPP Portal by Asst. General Manager (Engg-Electrical), Airports Authority of India, Rajahmundry Airport, Madhurapudi (Post) - 533102, Tele No: 0883-2020171, Ph: 9445403803 (Bid Manager) on behalf of Chairman, A.A.I from the eligible Manufacturers of Crash rated Hydraulic Bollards and Boom Barriers/Authorized Dealers/Specialized Agencies for the work of "SITC of Bollards, Boom Barriers and associated Electrical works including AICMC for 05 years at Rajahmundry Airport." at an estimated cost of Rs.63,38,913.00 (Excluding GST) (Sixty Three Lakh Thirty Eight Thousand Nine Hundred and Thirteen Only) with completion period of 04 (Four) Months.

C. Qualifying requirements of contractors /tenderers containing the following: -

i. Should have satisfactorily completed (Phase/Part completion of the scope of work in contract shall not be considered, however pre-determined phasing of the work will be accepted) three work each of Rs.25,35,565/- or two work each of Rs. 31,69,457/- or one work of Rs.50,71,130/- in single contract of similar nature of work i.e. "SITC of Crash rated Hydraulic Bollards and Boom Barriers" along with work order & schedule during last '7 years' ending on last date of submission/ extended date of submission of e-bid in India.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid.

- **ii.** Client Certificate for Experience should show the Nature of Work done, the Value of Work, Date of Start and Date of Completion as per Agreement, Actual Date of Completion and Satisfactory Completion of Work along with Work Order and Bill of Quantities.
- iii. Tenderers showing Work Experience Certificate from Non-Government/ Non-PSU Organizations should submit copy of Tax Deduction at Sources (TDS) Certificates along with a certificate issued by registered charter accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.
- iv. Scanned Copy [in PDF Format] of Annual Turnover Details: The Agency should have annualized Average Financial Turnover of Rs.19,01,674.00 against works executed during Last Three Years ending 31st March of the previous financial year. As a proof, Copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the tenderer should be submitted along with the application. Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- v. The tenderer should have minimum net worth of Rs.9,50,837.00 issued by certified Charted Accountant as per (Annexure-E).
- vi. Scanned copy of all the documents of Envelope-I mentioned above shall be submitted on the CPP portal. The requisite amount of Tender processing fee & EMD Fee is required to be paid online only. The tenderer, whose tender processing & EMD fee is not received, then their tender will be liable to be rejected.

Scanned copy of all the Documents of Envelope-I mentioned above shall be submitted on the CPP portal.

Refund of EMD

Refund of EMD to unsuccessful bidders who fail to qualify the eligibility/technical criteria, shall be initiated through the CPP portal on same day of their rejection. For all the bidders who qualify and their financial bids are opened, the refund of EMD of all unsuccessful bidders shall be processed through the CPP portal on same day of opening of the financial bid.

Envelope-II: -The Financial e-Bid through CPP Portal.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected.

3. Bid Submission: -

The tenderer shall submit their application only at CPP Portal: https://etenders.gov.in/eprocure/app Tenderer/ Contractor are advised to follow the instructions provided in the tender document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- 4. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstance will father and his son (s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/ director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 5. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website https://etenders.gov.in/eprocure/app shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and the tenderer shall be suspended from bidding in AAI Tenders for 01 Year and also liable to be banned from doing business with AAI.

6. Bids Opening Process is as below:

Envelope-I (Tender Processing Fee, EMD, Technical bid and Prequalification):

Envelope-I containing documents as per Para 2 (A), (B) and (C) (uploaded by the tenderers) shall be opened on date & time mentioned in CRITICAL DATA SHEET.

If the bidder has any query related to the Bid Document of the work, they should use 'Seek Clarification' on CPP Portal to seek clarifications. No other means of communication in this regards shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope - I, he will be asked to provide it through CPP Portal or email if required. The tenderer shall upload the requisite clarification/documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/ rejection of their bids will be intimated to the tenderers through CPP Portal.

Envelope-II (Financial Bid):

Envelope-II containing financial bid of the tenderers found to be meeting the technical criteria and qualifying requirements shall be opened on date & time mentioned in CRITICAL DATA SHEET.

- 7. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
- 8. AAI reserves the right to disallow the working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/agency defaulted with GST authority/Temporary or Permanent debarment/black listing by any department of AAI or Central /State Govt.

Depts./PSUs/World Bank/ ADB etc. AAI reserves the right to verify the credential submitted by the tenderer at any stage (before or after the award the work). If at any stage, any information/ documents submitted by the applicant is found to be incorrect/ false or have some discrepancy which disqualifies the tenderer then AAI shall take the following action:

- a) Forfeit the entire amount of EMD submitted by the firm.
- b) The tenderer shall be Suspended from bidding in AAI Tenders for 01 Year.
- c) The tenderer shall be liable for debarment from tendering in AAI, including termination of the contract apart from any other appropriate contractual/legal action.
- 9. Consortium/ JV companies shall not be permitted.
- 10. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.
- 11. Since this work falls under the category of construction works, concession to Indian Micro & Small Enterprises (MSEs) unit registered with DIC/NSIC/KVIC/KVIB/Directorate of Handicraft and handloom etc. to be given as per the provisions of public procurement policy for MSEs order 2012 with up-to-date amendments shall not be extended to this tender.
- 12. If the entity participating in any of the tenders is a private or public limited company, Partnership Firm or proprietary firm and any of the Directors/ Partners/Proprietor of such company is also a Director of any other company or partner of a concern or a sole proprietor having established Business with AAI and has outstanding dues payable to the Authority, then the said entity shall Not be allowed to participate in AAI tenders.
- 13. Tenderers have to submit UDIN generated documents like Balance Sheet/Turnover certificate, Working Capital Certificate (works done during last 5 financial years & works in hand), Net worth Certificate, Tax Deduction at Source (TDS) Certificates for Non- Govt. works etc. as per NIT conditions duly certified by CA and having UDIN. The documents submitted by bidders without UDIN shall not be entertained."
