#### NOTICE INVITING TENDER

**1.** Tenders from eligible bidders are invited by The Airport Director, Goa International Airport, Goa on behalf of Chairman, Airports Authority of India (AAI) for the works as detailed below:

## (i) Name of work: Supply, Installation, Testing & Commissioning of SCCTV System at Goa International Airport with Three years onsite warranty and Three years CAMC after warranty period.

(ii) Estimated Cost: Rs 5,02,80,706.60 (Exclusive of GST)

## (iii) Earnest Money Deposit (EMD): Rs 10,05,614.13

- 2. Tender documents shall be obtained from Airports Authority of India through Central Public Procurement Portal (URL http://etenders.gov.in/eprocure/app) only.
- **3.** Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: http://etenders.gov.in) by using valid Digital Signature Certificates on the CPP Portal. Bidders, who have positive intent to participate, can create a bid response only through CPP portal (e-Procurement), after **online payment of non-refundable tender fee.**
- 4. Duly complete e-bid response shall be submitted on the CPP eprocurement tender portal only along with the EMD. Any amendment or corrigendum to the tender document shall be posted only on CPP portal (e-Procurement) URL (http://etenders.gov.in/eprocure/app).
- 5. The Tender Fee shall be (inclusive of GST) of INR 2950.00 (Rupees Two Thousand Nine Hundred Fifty only) & shall be non- refundable. Bidder has to select the payment option as "Online" to pay the Tender Fee & EMD as applicable.

State Bank of India (SBI) has been authorized as Nodal Bank and its payment gateway has been integrated/ mapped with CPP Portal for the collection of **Tender Processing Fee & EMD** through e-procurement portal from various bidders participating in e-Tendering/ e-Procurement process.

6. This tender e-bid response is to be submitted in **two parts**, consisting **of T**WO **Envelopes**:

- **7.** All submissions by bidder firm on CPP e-procurement tender portal shall be in English language and documents shall be digitally signed using appropriate class of digital certificate issued by Indian Digital Certificate issuing authority.
- 8. All queries by bidders may be referred to AAI through CPP eprocurement tender portal only in "Clarification Option/Folder". The queries submitted to AAI by means other than e-tender portal will not be replied. Any queries received by AAI after the stipulated "last date of receipt of queries" will not be considered for reply.

9. Bidders, who have positive intent to participate, can create a bid response only through CPP e-procurement tender portal, after Online payment of non-refundable tender fee. Duly complete e-bid response shall be submitted on the CPP e- procurement tender portal only along with Scanned copy of Proof against Tender processing fee and Copy of EMD Payment (online or though Bank Guarantee).
 Any amendment or corrigendum to the tender document shall be posted only on CPP e-procurement tender portal.

## **10.2.1 ELIGIBILITY DETAILS OF FIRM/AGENCY**

The bidder shall submit supporting document indicating **Original Equipment Manufacturer (OEM) or its Authorized Representative (AR)/Indian Agent (IA) or a System Integrator (SI).** 

#### **10.3 GUIDANCE & UNDERTAKINGS**

- 10.3.1 If an Authorized Representative (AR) or Indian Agent (IA) or System Integrator (SI) purchase bid documents and submit the bid response in its own name, then credential towards eligibility criteria for Pre-Qualification of the Authorized Representative (AR)/ Indian Agent (IA)/System Integrator (SI) bidder firm shall be considered for evaluation.
- 10.3.2 In case of OEM firm, proof of being Original Equipment Manufacturer (OEM) shall be submitted for offered equipment(s)/item(s). OEM firm shall also submit an undertaking (Annexure- VIII) that the offered product(s) are not declared obsolete or end-of-life and not a white label products by OEM, and shall undertake to provide spares, sales, service and software support, in India for the life-time of the equipment i.e. Seven years or more.
- 10.3.3 OEM Authorized Representative (AR) or Indian Agent (IA) firm, shall submit current authorization from OEM **(Annexure- VIII)** authorizing the bidder as its representative for the product(s) offered in the tender shall be submitted along with authorization for its product(s), spares, sales, service and software support, in India for the life-time of the equipment i.e. **Seven years or more.**
- **10.3.4** System Integrator (SI) firm shall submit an undertaking (Annexure- IX) for complete responsibility to provide **product(s) not declared obsolete or end-of-life and not a white label products by OEM**, and to provide product spares, services, including replacement of product(s) and software support as required during the Warranty period and Post-Warranty AMC period of the work, without any additional liability to AAI.

#### 10.3.5 Bidder firm(s) shall submit an undertaking regarding nonblacklisted (As per Performa at Annexure- V) stating:

- i) Bidder firm or its Partners or its Directors have not been blacklisted or any case is pending or any complaint regarding irregularities is pending, in India or abroad, by any global international body like World Bank/International Monetary Fund/World Health Organization, etc. or any Indian State/ Central Governments Departments or Public Sector Undertaking of India. Bidder firm(s) not meeting this criterion may not apply. At any stage of evaluation, if it is found that bidder firm has given wrong or misleading information, then bid of such bidder firm(s) shall not be evaluated further and shall be liable for rejection. In such cases, the corresponding bidder firm's EMD shall be forfeited and the bidding firm shall be blacklisted for a period of FIVE YEARS in AAI.
- ii) Bidder firm and its authorized Partner firm shall jointly possess the required tools, plants, skilled manpower, etc. required for

execution of the subject scope of work in the tender at site.

- iii) Bidder firm shall not sublet or outsource any part of the scope of work to any third party without written consent from AAI. The requisite consent of AAI, in this regard, may be taken by the successful bidder after award of work and before commencement of work.
- iv) If the entity participating in tender is a private or Public Limited Company, Partnership Firm or Sole Proprietor and any of the Directors/Partners/Sole Proprietor of such company is also a Director of any other company or partner of a concern or a Sole Proprietor having established business with AAI and has outstanding dues payable to the Authority, then the said entity may not be allowed in AAI tenders. Bidder firm(s) shall submit an undertaking stating its firm or its partners or its directors or Sole Proprietor do not have any outstanding dues payable to the Airports Authority of India.
- v) The complete responsibility of completion of scope of work shall be of the bidder firm only to carry out works as per the scope of tender.
- vi) No bidder firm or its subsidiary firm or its parent firm shall be allowed to submit **alternate or partial bids.**
- 10.3.6 The bidder as OEM or OEM Authorized Representative (AR)/Indian Agent (IA) or System Integrator (SI) can participate in the tender for all full quantities of scope of work.
- 10.3.7 Foreign/Principal OEM firms shall enclose all details of their Indian Partners/Firms/Representatives along with **irrevocable Letter of Representation** valid up to the concurrency of present tender/contract.
- 10.3.8 The bidder firm (applicable in case of foreign registered firms having permanent establishment (PE) in India and Indian registered bidder firms only) shall have valid PAN, GST Registration in respect of firm and shall submit same with the Pre-Qualification bid in **Envelope A**.
- 10.3.9 The bid response shall be submitted in the name of the firm, in whose name bid documents has been purchased. Tender Documents and submittals shall be signed only by the bidder Firm"s Authorized Signatory & not by any representative. Indian Bidder Firm(s) shall submit complete contact details of authorized signatory along with Power of Attorney (Annexure- III) on company Letter Head, signed by authorized Director(s) of Firm and Foreign Bidder Firm(s) shall submit complete contact details of authorized signatory along with Power of Attorney (Annexure- III) on its Letterhead, signed by authorized Director(s) of Firm, so that AAI can refer its queries and authorized replies from the authorized signatory. receive No replies/queries from other than authorized signatory shall be accepted/considered by AAI.
- 10.4 **EARNEST MONEY DEPOSIT (EMD):** Each tender shall accompany the EMD in the following form:
- 10.4.1 **EMD** of the value of **Rs. 10,05,614.13 o**nly through online/ Bank Guarantee from a National/Scheduled Bank under RBI.

**NOTE: EMD** shall be accepted online **or** in the form of Bank Guaranty from a Scheduled Bank but not from any Co-operative or Garmin Bank drawn in favour of Airports Authority of India payable at Goa. The Earnest Money Deposit (EMD) submitted through Bank Guarantee (BG) of value as stipulated in the Notice Inviting Tender, a scanned copy shall be submitted in "**Envelope "A**" on the CPP portal.

- 10.4.2 The tenders of the bidders who fail to submit online paid EMD details or scanned copy of original BG for EMD from a Nationalized/Scheduled Bank (as per RBI Schedule Bank but not cooperative bank) towards EMD in the Prescribed Performa as per Annexure-II-A, before the stipulated time shall be rejected outright. The bidders shall submit SFMS (Structured Financial Messaging System) details for EMD BG verification.
- 10.4.3 Authorized Partners/representatives in India of foreign bidder firm can also submit EMD in Indian Rupees on behalf of their Foreign Principal Bidders only.

## **10.5 EMD Bank Guarantee**

- 10.5.1 **EMD Bank Guarantee (EMD BG)** shall be valid for a period of **six months** from the notified date of opening of the tender without any conditions by the bidder.
- 10.5.2 In case of any extension of tender opening date, bidder shall arrange to extend validity of such EMD Bank Guarantee, suitably, within two weeks, at no cost to AAI.
- 10.5.3 Bidder shall provide name, designation address, Fax & phone of the bank issuing BG along with **SFMS (Structured Financial Messaging System) details** for confirmation & Verification purpose. As per **ANNEXURE- II-D.**
- 10.5.4 Bidder firm shall not change, altered, or modify, in any way, the language/contents of any or all Annexures.
- 10.5.5 Any bid submitted with changed, altered, or modified language /contents of any or all Annexures, then the Bid of the firm may be liable to be rejected.
- 10.5.6 No interest or any other expenses, whatsoever, shall be payable by AAI on the EMD in any manner.

#### 10.5.7 Refund of EMD:

The refund of EMD to bidders who fail to qualify the eligibility/technical stage shall be intimated within 15 days of their rejection. For all bidders whose financial bids are opened, the refund of EMD except for lowest bidder (in the online reverse auction) shall be processed within 15 days of opening of the financial bid.

- 10.5.8 If due some reason AAI cancels this tender then EMD of all bidders without any interest shall be returned back.
- 10.6 This tender work involves Supply, Installation, Testing, Commissioning, Three years Warranty and Three years CAMC after warranty period.

The nature of this tender work is composite, indivisible, and continuous. It falls under the category of "Works contract". To such a contract, the provision of MSME act 2006 shall not be applicable.

10.7 This composite work (SITC+Warranty+CAMC) is indivisible in nature, the award shall be given to the successful Lowest bidder after Reverse Auction only. This tender work shall not be splitted in any manner.

## 10.8 Micro & Small Enterprises (MSEs) and Bidders registered with NSIC

**Concessions/ Benefit** to Micro and Small Enterprises (MSEs) – registered with District Industries Centres or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National small Industries Corporation or Directorate of Handicraft and Handloom or any other body specified by the Ministry of Micro, Small and Medium Enterprises as MSMED Act, 2006 and as per provisions of public Procurement policy for MSEs order 2012 with up to date amendments shall be applicable only for goods/Services produced and shall not be extended and applicable to this composite work contract.

- 11.1.7 Technical bid shall not contain Price of quote/information; otherwise, the technical bid of such bidding firm shall be technically disqualified and it is liable to be rejected.

- 12.4 NO CONDITION, WHATSOEVER, SHOULD BE STIPULATED IN THIS PART.

## **13. OPENING OF TENDER DOCUMENT**

- **ENVELOPE-A**: In **step 1: Envelope A** : Containing documents for 13.1 "Fee, Undertakings, Pre-Qualification & Technical Bid, " shall be opened online on e-tender portal in respect of bidders whose bids (soft copies of Tender Fee & EMD BG and all mentioned Undertakings/ Certificates/documents for pre-qualification and technical Bid) are positively submitted and available on CPP eprocurement tender portal on the designated date of opening of tender/e-bid response online. Envelope "A" e-bid response in soft copy available on CPP e- procurement tender portal, shall be evaluated and bidders meeting eligibility requirements as per all parts of Clause 10 and 11 its Sub-Clauses, Compliances against different Para"s of section A, B & C of Technical Bid shall be checked/verified by AAI along with clarifications if any submitted by bidders on AAI e-portal, against AAI queries, shall be informed and considered for further participation in Price bid.
- 13.1.1 Every bidder shall submit his offered equipment at his own cost for Technical Demonstration as a part of technical evaluation, in case AAI demanded. AAI appointed committee will witness technical demonstration tests on the offered equipment by bidders at Goa Airport to evaluate its operational/functional capabilities as per requirements of this tender.
- 13.1.2 Bidders not submitting/offering their offered equipment against this tender on AAI request, for the tests by AAI within stipulated time shall be considered non- compliant/non responsive. Such bidders are liable to be technically disqualified by AAI and commercial bids of such bidders shall not be considered by AAI for opening.
- 13.1.3 Bidders meeting/not meeting Tender criteria even after clarifications sought by AAI and technical demonstration shall be informed for meeting/not meeting the eligibility or technical criteria. The EMD of unsuccessful bidders shall be returned and no further communication regarding progress of this tender shall be made by AAI to such bidders. They shall not be considered for further participation in price bid as the case may be.
- 13.2 **ENVELOPE- B:** In Step 3: Envelope "B" containing Price bid of shortlisted vendors in step 1, shall be opened on CPP e-procurement tender

portal as per schedule.

- 13.2.1 Price Bid opened on CPP e-procurement tender portal only shall be evaluated by AAI as per tender conditions.
- 13.3 To short-list bidders in step 1 and 2, opened e-bids responses of eligible bidders shall be scrutinized by AAI to ensure whether the same are in conformity with the tender requirements.
