- **11.** Inspection shall be carried out by the authorized representative of AAI at the time of delivery of item. For any defective item, the supplier shall replacefree-of-cost.
- **12.** If the offer is accepted by AAI, the delivery should be made within 3 weeks or otherwise it will attract LD clause. For belated delivery, 1% of liquid damages per week up to 1 month, maximum of 2.5% of the value while making the payment.
- **13.** It will be the responsibility of the supplier to deliver the ordered items in good condition and correct quantity to the destination for which the items shall be properly insured against the risk of damages/loss during transportation and no separate charges will be borne by AAI for the same.
