- 2. AAI will not be responsible for delay in submission of quotation sent by post.
- **3.** Envelope B which shall be opened after scrutiny of the basic documents of Envelope A. Envelope A will be opened on the same day (i.e. **25-05-2022**) at 1500 HRS in the presence of interested tenderer or their authorized representative (maximum two person). Financial Bid of the technically qualified bidder shall be opened later.
- **4.** The price quoted (Inclusive of all Taxes) as per schedule given in the **Annexure-VI**. No extra payment will be made other than quoted amount.
- 5. The validity of quotation/NIQ should be for a minimum period of 90 days.
- 6. Incomplete & ambiguous tender will be rejected.
- **7.** The bidder who has Debarred/Blacklisted by AAI will not be eligible for the tender/NIQ. The Bidder should submit duly signed Annexure VIII.
- 8. <u>Scope of Work</u>:- The Bidder/contractor is responsible for CAMC i.e the upkeep and maintenance of the Quantity=04,10KVA UPS of ADOR POWERTRON make as per Annexure-II in healthy and serviceable condition, installed at the ATS BLOCK (various CNS sites) of CCSI Airport Lucknow. The Contractor shall have to carry out quarterly maintenance checks for the UPS under CAMC and a service report as per Annexure V or in similar format, duly signed and certified by the Maintenance in Charge of AAI has to be submitted.

Maintenance includes:

- a) Solving of reported hardware/software problems of UPS mentioned in Annexure-II on or as required During the CAMC period at the cost of contractor.
- b) Replacement of parts and components of UPS as and when necessary for preventive maintenance at the cost of the contractor including AC/DC capacitor, change over unit and isolation transfer.
- c) Break down maintenance at no extra cost to the AAI, if any of the UPS becomes unserviceable during the period of contract.
- d) Replaced Parts and components as mentioned above shall be the absolute property of AAI.
- e) <u>Replacement of UPS batteries is not within the purview of this contract</u>. The service engineer of the AMC Company will carry out periodic checking and cleaning of batteries and advice AAI in advance about their replacement in the event of the performance deterioration of these



batteries. Service Engineer should report any requirement for replacement of batteries to facilitate timely procurement of batteries. AAI will bear the cost of Batteries.

#### 9. Penalty:-

Complains made if any shall be attended immediately due operational reasons and in not more than 48 hours in any case any delay in attending complains beyond three days will cause penalty of 200 /- per day for 07 days and Rs 500 /- per day thereafter.

In case the problem is attended and the contractor fails to rectify the problem within 48 hours, AAI at its discretion shall get the faulty items repaired from other sources at the risk & cost of the CAMC service provider. In such an event AAI shall deduct a fine equal to the repair charges plus all other incidental charges on the repair from the quarterly bill of the CAMC.

- **10.** AAI reserves the right to accept/reject any quotation without assigning any reason.
- **11.** AAI reserves the right to cancel a part or whole NIQ without assigning any reason.
- **12.** Successful Bidder has to sign the agreement with AAI on Rs 100 stamp paper as per Annexure IV.
- 13. L1 BIDDER (Lowest one) WILL BEE DECLAIRED ON THE BASIS OF OVER ALL PRICE i.e. GRAND TOTAL VALUE.
- 14. Performance Bank Guarantee (PBG):- The successful bidder shall submit contract Performance Bank Guarantee (in lieu of Contract Performance security) of the value equivalent to 3% (three percent) of the total Contract price (CAMC cost) to AAI in the form of an irrevocable and unconditional Bank Guarantee on a Nationalized/Schedule bank as per Performa attached as Annexure-VII. The guarantee shall be submitted within 15 calendar days of the issue of letter of acceptance of his bid, and will be valid till 180 days after the end of the contract period (i.e. CAMC period + 180 days). In case successful bidder fails to submit the PBG within stipulated period, interest @ 12% p.a. on performance Guarantee amount would be levied (non-refundable) for delayed period of submission and shall be deducted from First running Bill. In case, successful bidder fails to submit performance bank guarantee within 60 days, AAI reserve the right to cancel the order, black list the bidder and debar for specific period for bidding in AAI

#### 15. Period of Contract:-

- a) The period of contract will be one year from the date of signing of contract Agreement as per annexure IV.
- b) The Contract may be extended further for a period of one year subject to satisfactory service rendered by the Contractor during the previous period of contract, as per the same terms and condition on mutual agreement of both the parties.

## 16. The contracting firm shall have the following responsibilities with respect to Maintenance and Support:

- a) The CAMC shall cover the comprehensive on-site support for all services and spares of the online UPS systems.
- b) All the on-line UPS systems should be configured for its optimal use. Preventive maintenance service is to be carried out quarterly for all the on-line UPS systems covered under the contract.



- c) The responsibility of maintaining the stock of spare parts (original OEM) / subsystems needed for maintenance of the equipment under the purview of this contract shall be the responsibility of the CAMC Service Provider.
- d) A preventive maintenance report from the contractor would be submitted to the undersigned failing which an amount of Rs. 1000/- as a penalty would be imposed. Preventive maintenance means quarterly servicing of the equipment irrespective of whether the equipment has undergone a breakdown or not.
- e) CAMC shall include the repair/replacement of defective parts with the parts of equivalent or higher specification and details of replacement should be provided to the competent authority. A standby arrangement is also mandatory in such cases. In case any equipment/ part has to be taken out for repair, a standby equipment/ part of similar configuration will be provided by the firm.
- f) The items that are not serviceable by the agency due to obsolescence of technology or non-availability of parts/ assemblies/ components will be withdrawn from the maintenance contract. The decision of the competent authority regarding non-availability and obsolescence of technology and withdrawal of these items from the maintenance contract will be final. Withdrawal of such items shall be communicated to the contractor and equivalent maintenance charges shall be deducted accordingly.
- g) The vendor should maintain a record of all calls attended, pending issues, preventive maintenance records and details of all replaced spare parts.
- No replacement and repairing charges for the parts covered under the CAMC shall be made. Comprehensive CAMC includes all the plastic items, knobs, movable rotational parts necessary for operation of the original equipment" No parts are excluded from the CAMC.
- i) The contracting firm will provide support to AAI on all seven days between 0930 IST to 1800 IST. All maintenance work/preventive maintenance shall be carried out in presence of AAI executives
- j) The contracting firm will undertake full responsibility for ensuring that equipment are fully and regularly maintained once a quarterly, adjusted, lubricated and if firm's judgment condition warrant, repair/replace all parts necessary to keep the installation in top class working condition.

#### 17. Payment terms:-

- a) No mobilization advance shall be paid for any activity.
- b) The payment towards **CAMC of UPS** shall be made on quarterly basis after the successful completion of each quarter. The certificate of satisfactory service during the quarter for which the payment has been requisitioned from the maintenance in-charge AAI, shall be a mandatory requirement for the release of the payment.
- c) 100% of the charges minus the recoveries if any shall be paid after the successful completion of each quarter and on satisfactory performance certification from the Maintenance in-charge of AAI. Payment will be through E-Transfer.
- d) CIC, AAI, CCSI Airport, Lucknow is the paying authority.
- e) The contracting Firm shall raise the Bill on quarterly basis of previous 3 months. The Jt. General Manager (CNS), AAI, CCSI Airport, Lucknow, on receipt of the aforesaid quarterly bill



will make the payment to the contracting firm, subject to the deduction, if any, as per the terms already mentioned.

- 18. Bill shall be deposit in triplicate along with satisfactory completion report from the CNS Dept of AAI.
- **19. Exclusion of Items from contract/Termination of Part / Full Contract.** 
  - a) The CAMC can be terminated by either AAI or contractor with notice of one month. Contractor shall handover the system/equipment in fully serviceable and functional condition at the time of closure of maintenance contract. Else, the defects shall be rectified at the risk and cost of contractor.
  - b) AAI shall terminate the contract and takeover the system maintenance at any time without notice, in case the services are not found satisfactory. Under such conditions, all the defects shall be rectified at the risk and cost of contractor. AAI has the right to terminate the contract with one month notice, if AAI decided to replace the UPS with New one or closure of the facility/system.
  - c) Any of the UPS under CAMC can be withdrawn by AAI, from CAMC during the contract due operational requirements with one months notice and the CAMC payment will be made on pro rata basis only.
  - d) Any dispute pertaining to the terms and conditions of the contract entered between the parties shall be referred to the Arbitrator, appointed by AAI. The decision of the Arbitrator shall be final, conclusive & binding on both the parties.

It is clarified that after unconditionally accepting the NIQ conditions in its entirety, it is not permissible to put any remarks / conditions (except unconditional rebates on quoted rates if any) in the NIQ enclosed in envelope "A" & "B" and the same has been followed in the present case. In case any provisions of this NIQ are found violated after opening envelope "A" & "B", I / we agree that the NIQ shall be rejected.
