A. ENVELOPE – A – “Technical Bid” – Containing the following documents

- Copy of NIQ except Price Bid (either downloaded from AAI website or obtained from AAI Technical Department) duly signed by the bidder accepting terms & conditions.
- Copy of PAN Card
- Copy of Work Order of Transporting Similar Vehicle.

B. ENVELOPE – B – “Price Bid” – Containing the following document.

i) Un- conditional ‘Price Bid’ in prescribed format as per ‘Annexure – B’

Both the envelopes super scribing **Envelope- A (Technical Bid) & Envelope-B (Price Bid)** shall be separately sealed and placed in a **Master envelope**. The master envelope shall also be sealed and super scribed with the name of the work and submitted to **In-charge (Tech), Technical Department, Airports Authority of India, Devi Ahilya Bai Holkar Airport, Indore (M.P.) -452005**. Offer not adhering to two envelope system or unsigned offer shall be rejected out rightly.

The Envelope- B shall be opened after evaluation of basic documents of Envelope – A.

2. GENERAL TERMS & CONDITIONS:

1. Your Quotation should reach this office on or before **23/05/2022 at 1500 Hrs.** and it will be opened on the same day at 1600 Hrs. Quotations received after due date & time will not be entertained at any cost.
2. The proofs of Transit risk insurance cover for each vehicles and E-Way Bills for the Transportation towards the above mentioned ACFT has to be submitted before commencement of the trip. Exact date of commencement of trips will be communicated within 1 or 2 days before the start of the trip.
3. For any clarification on the above work or for visual inspection of the above ACFT, the contractor/agency can visit the Indore and Jabalpur Airport, on all working days between 10:00 hrs to 17:00 hrs before the expiry of due date & time.
4. Airport Director Indore, Airport Authority of India reserves the right to accept or reject any or all quotations without assigning any reason thereof.

3. SPECIAL TERMS & CONDITIONS:

1. Rates quoted should be inclusive of packing, forwarding, Transportation charges, loading and unloading, salary & D.A of the employees (Driver and Helper/Cleaner), E-way bills, Transit insurance-way bill etc. Excluding GST for shifting of the Vehicle. No additional charges whatsoever other than the quoted amount will be paid.
2. The L1 will be decided based on the Lowest Total Amount Quoted Excluding GST by the Party for the works mentioned.
3. Loading of ACFT to trailer and Unloading of ACFT from trailer shall be the sole responsibility of the transporter. All tools, equipments, manpower and other facility if required shall be arranged by the transporter only and the cost towards such arrangements shall be borne by him. No charges other than quoted amount shall be paid by AAI. AAI's representatives may available for the supervision of loading/unloading of ACFT.

4. AAI is not responsible for any postal delay in receipt of quotation. The bidder should ensure that the quotation reached on or before the due date & time.
5. Rate should be quoted in the given format at Annexure-B only.
6. No request for advance payment will be made.
7. The payment will be made within 15 working days from the date of receipt of supply through e-payment & the e-payment details will be obtained later from the successful bidder.
8. The payment will be released by AAI subject to the submission of the following documents:
 - (i) Signed Invoice in original.
 - (ii) Satisfactory receipt of ACFT with all accessories as per list by authorized AAI official at the receiving Airport-Jabalpur Airport & Indore Airport.
9. **Liquidated damage:** A sum equivalent to 0.5 (half) per cent per week for the price of uncompleted portion / activity / delivery of contract cost executed / completed beyond delivery schedule is recovered as liquidated damages. The total damages shall not exceed 10 (Ten) per cent of the value of delayed goods. The liquidated damages shall be calculated on the base cost without the Govt. taxes and duties.
