\* Notwithstanding anything contained in the agreement, parties agree that during the Concession Term, in the event the Authority opts to transfer its rights such as operation, maintenance, development etc. of the Airport to a third party under PPP model or in any manner as may be decided by AAI / Government of India, then the Authority shall have the right to assign / novate / alter the Agreement, in favour of such third party, to which concessionaire hereby gives their consent unconditionally and Authority will not be bound to obtain any further consent of concessionaire. Such assignment / novation / alteration would release Authority of all liabilities and obligations arising under the agreement from and after the date of assignment / novation / alteration and the rights and obligations of Authority under the Agreement and other arrangements entered into in accordance with the provisions of the Agreement shall be vested in such third party. The parties, along with relevant third party shall execute necessary documentation or put in place necessary agreements for the aforesaid assignment / novation / alteration as and when need arise.

### 1.2 RFP in Brief

- **1.2.1** This RFP is being issued for the determination of the Selected Bidder, who shall be granted the Concession as per the terms of the Concession Agreement.
- **1.2.2** This RFP sets out the requirements that must be satisfied by the Bidders in order to participate in the competitive Bidding Process and the selection process to determine the Selected Bidder to whom the Concession shall be granted.
- **1.2.3** The Concession Agreement sets forth the detailed terms and conditions for grant of the Concession to the Selected Bidder, including the scope of the Concessionaire's rights and obligations.
- **1.2.4** The statements and explanations contained in this RFP are intended to provide a better understanding to the Bidders about the subject matter of this RFP and should not be construed or interpreted as limiting in any way or manner the scope of rights and obligations of the Selected Bidder set forth in the Concession Agreement or Authority's rights to amend, alter, change, supplement or clarify the scope of the Concession to be awarded pursuant to this RFP or the terms thereof or herein contained. Consequently, any omissions, conflicts or contradictions in the Bidding Documents including this RFP are to be noted, interpreted and applied appropriately to give effect to this intent, and no claims on that account shall be entertained by Authority.
- **1.2.5** The Bidding Documents include the draft Concession Agreement and any addenda issued subsequent to this RFP Document will be deemed to form part of the Bidding Documents.
- **1.2.6** Authority shall receive Proposals pursuant to this RFP in accordance with the terms set forth herewith and other documents which may be provided by Authority as modifications, alterations, amendments and clarifications from time to time by (collectively called the **"Bidding Documents"**). All Proposals shall be prepared and submitted in accordance with such terms on or before the date specified in Clause 1.6 ( the **"Proposal Due Date"**).
- **1.2.7** Authority, at its absolute discretion, reserves the right to modify any proposed terms and conditions set out in this RFP as deemed necessary by it, including but not limited to cancelling/ withdrawing the RFP, to meet its objectives and principles as set out in the RFP.
- **1.2.8** The successful bidder has to enter into Service level agreement (SLA) with authority for mandatorily providing Mobile/Laptop Charges/Q Mangers/Security Tray etc. as per the requirement of the Airport concerned and decided by the authority. In addition to this Authority will also have the right to install LCD/LED TV for display of News/Entertainment Channels/Passenger information's etc. for the requirement of passenger facilitation through respective service providers if required.

#### 1.3 Sale of RFP Document

**1.3.1** The RFP document may be downloaded /purchased from the Government of India Central Public Procurement Portal (www.etenders.gov.in). The portal can also be visited through the website of Authority (http://www.aai.aero), where a link as "E-Tender" has been provided on the Home page for this purpose.

Tender fee Rs. 50,000/- (Rupees Fifty Thousand only) is the cost of the RFP document, which is non-refundable.. The cost of RFP document is to be deposited through RTGS (Bank name – STATE BANK OF INDIA, SBI account no. 33814920430, IFSC code SBIN0001183, branch code -1183, SWIFT code SBININBB 536, MICR code- 400002068, Type of account-Current Account, AAI PAN- AAACA6412D, AAI GST no. 27AAACA6412D1Z8).

A scanned copy of the receipt of the payment made for cost of RFP document is to be uploaded along with technical bid documents at the time of bid / proposal submission. Non-Submission of payment receipt for cost of RFP document as stated above shall lead to disqualification.

No other mode of payment shall be acceptable. The bids of parties / agencies, whose cost of RFP document has not been received before the Last date/Time for Bid Submission, will not be considered for further processing.

### 1.4 Validity of the Proposal

**1.4.1** The Proposal shall be valid for a period of not less than 180 days, extendable by another 90 days, if so desired by the Authority, from the Proposal Due Date (the "PDD").

#### 1.5 Brief Description of Selection Process

**1.5.1** The Authority has adopted a single stage selection process (the "**Selection Process**") in evaluating the Proposals, comprising Technical and Financial Proposals to be submitted online together through website of NIC CPP PORTAL (www.etenders.gov.in). After receipt of Proposals, a technical evaluation will be carried out as specified in Clause 3.3. Based on this technical evaluation, a short-list of Technically Qualified Bidders shall be prepared as specified in Clause 3.3.4. Thereafter, the evaluation of Financial Proposals submitted by only the Technically Qualified Bidders will be carried out as specified in Clause 3.4. Financial Proposals will finally be ranked and the Bidder proposing the highest Financial Proposal shall be selected for award of LOIA (the "Selected Bidder"). If the bidder proposing the highest financial proposal, withdraws its bids or does not sign the concession agreement for any reason, the authority shall cancel the entire RFP process and go for revised bidding.

If the applicant / bidder quoting the highest financial proposal, withdraws its bids or does not sign the concession agreement for any reason, the Authority may, in its, discretion, annul the Bidding Process and the highest bidder's EMD will be forfeit and AAI will reserve its right to debar for a period of 02 (two) years.

- **1.5.2** The Authority reserves its right to grant the Concession to the Selected Bidder.
- **1.5.3** A Bidder is required to deposit, along with its Proposal, an Earnest Money Deposit (EMD) equivalent to **INR 17,77,000/- (Indian Rupees Seventeen lacs seventy seven thousand only**). The cost of EMD is to be deposited through RTGS (Bank name STATE BANK OF INDIA, SBI account no. 33814920430, IFSC code SBIN0001183, branch code -1183, SWIFT code SBININBB 536, MICR code- 400002068, Type of account-Current Account, AAI PAN-AAACA6412D, AAI GST no. 27AAACA6412D1Z8). The scanned copy of the proof for payment of EMD through RTGS is to be uploaded by Bidder along with the Technical Proposal. No other mode of payment shall be acceptable. Non-Submission of EMD receipt as stated above shall lead to disqualification.

The refund and forfeiture of the EMDs shall be as per Clause 2.20 of the RFP.

- **1.5.4** Any condition or qualification or any other stipulation by the Participating Bidder contained in the Proposal shall render the Proposal liable to rejection out rightly as a non-responsive Proposal.
- **1.5.** Bidders are advised to examine in greater detail and to carry out such studies as may be required to be carried out by them for submitting their respective Proposals for award of the Concession including implementation thereof at their exclusive cost. **Authority would** extend all assistance in that respect.
