NOTICE INVITING QUOTATION

Sealed Item Rate Quotations are invited by Airport Director, Airports Authority of India, Dibrugarh Airport, Dibrugarh-786012 in two envelope system from Transporters/Trailer providers/reputed agencies for the work of "Transportation/Shifting of Airfield Crash Fire Tender (ACFT) on low floor truck – trailer from Dibrugarh Airport (Assam) to Hollongi Airport (Arunachal Pradesh)"

2. <u>TWO ENVELOPE SYSTEM</u>

Quotations should be submitted in two separate envelopes.

ENVOLOPE - A - Technical Bid - Containing the following documents: -

- (i) Copy of GST registration
- (ii) Copy of Permanent Account Number (PAN)
- (iii) Proof of valid certificate of establishment, registered with any Govt. Authorities as Transporter/ copy of valid Trade License for transportation business issued from appropriate govt authority
- (iv) Copy of Unconditional cum declaration as per annexure-I duly sealed and signed. (Page no. 5)
- (v) Copy of NIQ (either downloaded from AAI website <u>www.aai.aero</u> or obtained from AAI Technical department) duly signed by the bidder unconditionally accepting terms & conditions (Page -1 to 4).

ENVOLOPE - B - Price Bid - Containing the following document: -

(i) Un- conditional price bid in prescribed format as per Annexure – II (Page-7). Any conditional offer shall be rejected out rightly.

Both the envelopes super scribing Envelope- A (Technical Bid) & Envelope-B (Price Bid) shall be separately sealed and placed in a master envelope. The master envelope shall also be sealed and super scribed with the name of the work and submitted to In-charge (Tech), Airports Authority of India, Technical Dept., Dibrugarh Airport, Dibrugarh-786012. Offers not adhering to two envelope system or unsigned offer shall be rejected out rightly.

Envelope- B shall be opened after evaluation of basic documents of Envelope -A and the bidders shall be accordingly intimated about the date of opening of Envelope -B.

3.1 The rate quoted shall be inclusive of all taxes, freight charges, loading/unloading charges, E-way bill charges, Ramp Facility charges for loading/unloading, toll tax charges, parking charges, night halt charges, Transit Insurance cover charges, Interstate permit charges, waiting charges and all other incidental charges and Exclusive of GST. GST shall be paid on actuals by AAI.

3.2 The rates shall be valid for acceptance for 90 days from the date of opening of technical bid.

3.3 The bidders are requested to offer their best-discounted rates. No extra payment will be made other than the quoted amount. AAI shall not provide Form C or D.

3.4 In the event of the date of opening of technical bid or price bid is postponed due to administrative or technical reasons the same shall be opened on the next working day. The bidders can be present during opening of technical and price bid if they wish to.

3.5 AAI is not bound to accept lowest quotation and reserves the right to accept or reject any or all quotation without assigning any reason there-of, and to call for any other details or information from any of the bidder.

3.6 AAI shall not be responsible for any postal delay and offers received beyond stipulated date and time shall not be considered.

3.7 Bidders may inspect ACFT's along with its accessories for assessing the quantum of work during the office working hours (1000 Hours to 1600 Hours) before submission of the bid. The bidders are required to find out the exact route to be followed, the height restrictions en-route, the toll taxes and other requisite documents, and the total distance to be covered before submitting the quotation. No query shall be accepted after submission of bid.

3.8 All-time extensions, corrigenda, addenda, amendments, clarifications etc. if any to the NIQ document will be posted on AAI website. Bidders should regularly visit website to keep themselves up dated.

3.9 The evaluation criteria for comparison of rates for the purpose of identifying the lowest bidder shall be on the basis of lowest quoted amount.

3.10 Payment will be made within 15 days through RTGS after completion of work and on submission of the following documents: -

- i. Bills in duplicate
- ii. Satisfactory receipt of ACFT with all accessories as per list by authorized AAI official at the receiving airport-Hollongi Airport.

3.11 Successful bidder shall also protect and fully indemnify the AAI from any claims from successful bidder's work men/employees or from any person or

bodies/ companies etc. for any act of commission or omission while executing the order.

3.12 Successful bidder shall be responsible for compliance with all requirements under the laws and shall protect and indemnify completely the AAI from any claims/penalties arising out of any infringements.

3.13 Bidder shall not pay any bribe to any officer of AAI for awarding this contract at any stage during its execution or at the time of payment of bills, and further if any officer of AAI asks for bribe/gratification, he shall immediately report it to Appropriate Authority of AAI.

3.14 In case of any dispute arising, the decision of Airport Director, AAI, Dibrugarh Airport shall be final and binding to both the parties. Legal disputes, if any, shall be settled within the jurisdiction of courts in Dibrugarh.

4.0 SPECIAL TERMS & CONDITIONS:

4.1 The Scope of Work covers **"Transportation/Shifting of Airfield Crash Fire Tender (ACFT) on low floor truck – trailer from Dibrugarh Airport** (Assam) to Hollongi Airport (Arunachal Pradesh)"

4.2 Measurements of ACFT are as follows:

Overall Length	:	10100 mm			
Overall Width	:	2550 mm			
Overall Height	:	3780 mm			
Ground Clearance(unloaded): 350 mm					
Distance between front tyre to front bumper: 1500 mm					
Distance between rear tyre to rear bumper: 2180 mm					
Weight	:	25000 Kg (Approx.)			

4.3 The ACFT should reach at Hollongi Airport in 7 days after the award of work.

4.4 The ACFT is Third Party insured by AAI.

4.5 Transit risk insurance cover for an amount of Rs. 25,00,000/- towards the above mentioned ACFT has to be submitted before commencement of the trip. Exact date of commencement of trips will be communicated within 1 or 2 days before the start of the trip

4.6 The transporter shall ensure that the ACFT with all its accessories is transported in appropriately insured vehicle/trailer having valid registration, permit and motor insurance and all precautions are taken during transportation, loading/unloading, holding the equipment within the trailer, safeguarding with cushions & paddling on front/rear wheels and no damage is caused to ACFT. The bidder shall employ skilled man power. Good quality packing material shall be used to protect the ACFT from any damage during transportation. The ACFT shall be secured firmly on the trailer by using suitable chains/fasteners.

4.7 The transporter shall make the necessary arrangements of skilled driver and required labour at Dibrugarh Airport and Hollongi Airport. The transporter will inform

The time by which the equipment is expected to arrive at a destination (Hollongi Airport, Arunachal Pradesh) and AAI's representative will be available at the given time at predetermined place for supervision of loading/unloading.

4.8 Loading of ACFT to trailer and Unloading of ACFT from trailer shall be the sole responsibility of the transporter. All tools, equipments, manpower and other facility if required shall be arranged by the transporter only and the cost towards such arrangements shall be borne by him. No charges other than quoted amount shall be paid by AAI. AAI's representatives may available for the supervision of loading/unloading of ACFT.

4.9 Successful bidder will be required to submit the relevant documents & information of the trailer & driver such as RC-copy, valid insurance copy of trailer, Valid Driving License of driver for record purpose.

4.10 The driver of the trailer or the Escort should carry a cell phone at their own cost, on which he can be contacted by AAI officials and nothing extra shall be payable on this account.
