## **SECTION-II**

### **Terms & Conditions:**

1. **SCOPE OF WORK:** Transportation **(through Truck /Trailer)** of 01 No. AgniVijay (ACFT) **(as per Description in Annexure I)** from **Tezu Airport to Hollongi Airport.**

2. **RATE:**

- i. **The quoted rates shall be net inclusive of transportation,** Loading and Unloading of the ACFT Vehicle, cost incurred towards obtaining permits, if any, transit Insurance (road /Marine as applicable), charges of truck /trailer, etc. **but exclusive of GST and no extra payment will** be made on any accounts.
- ii. The rate quoted shall remain valid for a period of 90 days and no escalation / deviation shall be accepted under any circumstances.
- iii. TDS and other taxes as applicable shall be deducted from the bill. In case of any downward revision of rates during the execution of work, it shall be intimated to AAI and necessary discounts shall be passed on to AAI while raising the bills/invoice.

3. **Public Procurement Policy for MSEs Bidder(s):**

The benefit of MSEs shall be available only for goods produced/services rendered, for which they are registered. MSEs seeking exemptions and want to avail the benefits under Public Procurement Policy should submit self-attested copies of valid Registration Certificate issued by MSME or any other body specified by MSME clearly mentioning the details such as goods produced/services rendered & its validity, failing which they run the risk of their bids being passed over as ineligible for the benefits applicable to MSEs.

4. The Transporter / Carrier / Freightier is advised to study the Dimensions / Details of machine / Goods to be Transported given in Annexure-I, Financial Bid (Annexure –III) and Unconditional Acceptance Letter (Annexure –II). The bidders are requested to offer their competitive rates. The rates quoted in Annexure-III should be inclusive of all other charges such as ramp facility for Loading and unloading of complete machine, Transportation, loading and unloading of material / Goods / Vehicle at Airport(s) and other incidental charges like Toll, Transit Insurance etc; excluding of GST. No extra payment will be made other than the quoted amount.
5. Before Quoting the rate, the equipment can be inspected at the site, if bidders wish to do so. Transporter should ensure all RTO compliance for their deployed Truck-Trailer and driver till completion of the job.
6. Transparent cellophane tape should be fixed on the quoted rates.
7. In the event of the date of opening of technical bid or price bid is postponed due to administrative or technical reasons the same shall be opened on the next working day.
8. **Evaluation of price bids** will be based on **overall L-1 status.** In case rate offered by two or more firms are same, AAI may on its discretion decide suitably to award the work to any of the lowest agency. No query shall be entertained in this regard and decision of AAI shall be final, and binding on all the bidders.

9. Preference to MSME bidders shall be applicable as per norms laid by Govt. of India.
10. AAI is not bound to accept lowest quotation and reserves the right to accept or reject any or all quotation without assigning any reason thereof, and to call for any other details of information from any of the bidder.
11. The firm/bidder should not submit more than one offer.
12. The bidders can be present during opening of bid, if it is wish to do so.
13. All-time extensions, corrigendum, addendum, amendments, clarifications etc. if any to the NIQ document will be posted on AAI website. Bidders should regularly visit website to keep themselves updated.
14. Quotation enclosed in a sealed envelope should be sent to this office on or before the last date and time for Bid Submission. AAI is not responsible for any postal delay and offers received after stipulated date and time shall not be considered.
15. Time allowed for completion of work, i.e. Shifting/Transportation of Agni Vijay ACFT from Tezu Airport, to Hollongi Airport is 10 (Ten days), Commence from the third day after issue of work order by AAI.
16. Before commencement of the work/shifting of ACFT (Agni Vijay), mandatory transit Insurance of ACFT (Agni Vijay) as per Insured Declared Value (I.D.V.) as per general insurance and requisite/ mandatory documents needed, if any, should be obtained by the bidder at their own cost. Nothing extra shall be paid on account of this.
17. The work shall not be sublet / assigned directly or indirectly to any other agencies in whole or part. However, the same may be considered in case of emergency due to breakdown of the assigned contractor's truck/trailer or any other justified reason with prior written consent of the competent authority of the AAI.
18. On satisfactory completion of work, final bill shall be submitted to Airport Director, Tezu Airport, Airports Authority of India, Tezu-792001 along with the following Documents:
  - i. Final bill along with Invoice.
  - ii. Bank Account Details of agency for e-payment.
  - iii. Acknowledgement for Goods receipt duly signed and stamped / mail issued by the Airport Director/Concerned AAI Officer.
19. No advance/interim payment shall be made. Payment shall be made through NEFT / RTGS upon submission of Invoice, etc. completed in all respect after satisfactory completion of work.

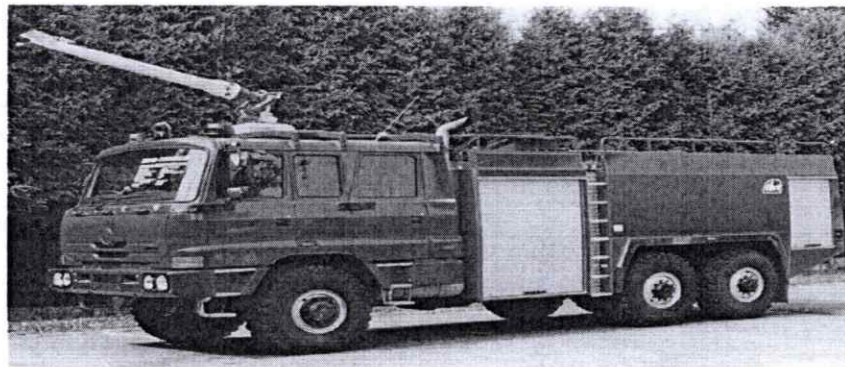
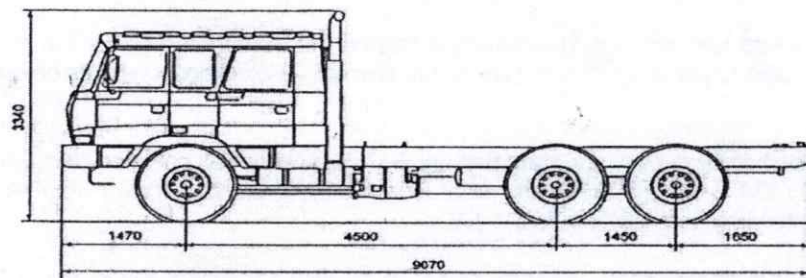
