3. Only insurance companies authorized by IRDA shall participate.
4. The quotation submitted by the insurance company will only be considered. The quotation submitted by the agents/brokers will not be considered.
5. The vehicle condition can be checked and will be made available for verification and correctness of information during working days till the last date of application. It is advice to go through before quoting the premium rates. The later claim will not be entertained.
6. The Airport Director, Airports Authority of India, Tirupati Airport reserves the right to accept / reject any OR all quotation without assigning any reason thereof.
7. Bidders other than Public Sector insurance Companies should submit IRDA Registration Certificate along with the BID.
8. The premium quoted will be evaluated on basis of L-1 bidder.
