1. Item rate / ~~EPC~~ e-tenders are invited through the e-tendering CPP Portal by Senior Manager (Engg– Elect.), RHQ-ER, Sub. Div. - I, (Bid Manager), Airports Authority of India, RHQ, ER, NSCBI Airport, Kolkata – 700052 on behalf of Chairman, Airports Authority of India from the eligible contractors / agency for the work of **“Supply of Electrical Store items like Ceiling Fan, Wall fan, Geysers etc. for ATS complex at NSCBI Airport, Kolkata. SH: - Supply of HT & LT cable.”** at an estimated cost of **Rs. 32,22,500/- (Excluding GST) (Rupees Thirty Two Lakh Twenty Two Thousand Five Hundred Only) with period of completion 02 (Two) Months.**

**A. Tender processing fee, EMD:**

- i) **Tender Fee of Rs. 1,180.00/- (i/c GST) including EMD of Rs. 64,450/-** is required to be paid online only through payment gateway provided at the CPP Portal itself and Documentary Proof regarding online payment of Tender Processing Fee amount to be submitted by the agency in CPP Portal along with Envelope I.

**B. Technical Bid containing the following: -**

- VIII. Scanned copy of 'Undertaking' regarding Blacklisting/Debaring on Company Letter Head. (Performa given in tender document).
- IX. Companies other than proprietary firm shall submit, scanned copy of Authorization Letter/ Power of Attorney along with copy of certificate of Incorporation of the Company under Companies Act showing CIN/LLPIN/Name of Directors of the Company & Copy of Board Resolution regarding Authority to assign Power of Attorney. Proprietary firm shall submit scanned copy of Authorization Letter/ Power of Attorney only if the tender is processed by a person other than Proprietor.
- X. PQ Performa duly filled (as per Annexure-B of tender document)
- XI. Scanned copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the tenderer during last three financial years ending on 31/03/2021.

**C. Qualifying requirements of contractors / tenderers containing the following: -**

- i) Should have satisfactorily completed (# Phase/Part Completion of the scope of work in a contract shall not be considered, **however pre-determined phasing of the work will be accepted**) **Three works**, each of **Rs. 12,89,000/-** or **Two works**, each of **Rs. 16,11,250/-** or **One work** of **Rs. 25,78,000/-** in single contract of similar nature of work **“Supply of LT/HT cables”** during last seven years ending on last date of submission of bid as mentioned in critical data sheet.

**In case of composite work, the amount against the similar work as mentioned above shall be considered for evaluation.**

**“The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid i.e. last date of submission of bid as mentioned in critical data sheet.”**

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. **Tenderers showing work experience certificate from non-government /non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.**

- ii) Should have annualized average Financial Turnover of **Rs. 9,66,750/-** against works executed during last three years ending 31st March of the previous financial year. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the tenderer should be submitted along with the application. Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- iii) The tenderers should have a minimum net worth of **Rs. 4,83,375/-** issued by certified Chartered Accountants.

Scanned copy of all the Documents of Envelope-I mentioned above shall be submitted on the CPP portal. Tender processing fee is required to be paid online through Payment Gateway on CPP Portal on or before bid submission end date & time mentioned in CRITICAL DATA SHEET.

**EMD Rs. 64,450/-** and Tender cost of **Rs. 1,180/-** shall be accepted only through Payment Gateway of CPP Portal.

**Scanned copy of all the Documents of Envelope-I mentioned above shall be submitted on the CPP portal.**

**Envelope – II: The Financial e-Bid through CPP portal Bids Opening Process is as below: -**

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenders. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modification by the tenderer, the bid will be rejected.

**3. Bid Submission: -**

The tenderer shall submit their application only at CPP portal <https://etenders.gov.in/eprocure/app>. Tenderer/Contractor are advised to follow the instructions provided in the tender document for online submission of bids. Tenders are required to upload the digitally signed file of scanned documents as per para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in deducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

4. Not more than one tender shall be submitted by one tenderer of tenderers having business relationship. Under no circumstance will father and his son(s) or other close relation who have business relationship with one another (i.e.

when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

5. Tenderer who has downloaded the tender form Central Public Procurement Portal (CPPP) website <http://etenders.gov.in/epoocure/app>, shall not tamper / modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered / modified in any manner, tender will be completely rejected and tenderer is liable to be banned from doing business with AAI.

**6. Bids Opening Process is as below: -**

**Envelope –I (Tender processing fee, EMD, Technical bid and Pre-qualification):**

Envelope-I containing documents as per Para 2 (A), (B) and (C) (uploaded by the tenderers) shall be opened on date & time mentioned in **CRITICAL DATA SHEET**.

If the bidder has any query related to the Bid Document of the work, they should use ‘**Seek clarification**’ on CPP portal to seek clarifications. No other means of communication in this regard shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope-I, he will be asked to provide it through CPP portal or email if required. The tenderer shall upload the requisite clarification/ documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly. The intimation regarding acceptance / rejection of their bids will be intimated to the tenderers through CPP portal.

**Refund of EMD**

The refund of EMD to the tenderers who fail to qualify in the eligible / technical criteria, shall be intimated within 10 days of their rejection. For all tenderers who qualify and their financial bids are opened, the refund of EMD of all such tenderers except L – 1, shall be processed within 10 days of opening of the financial bid.

**Envelope –II (Financial Bid):**

Envelope –II containing financial bid of the tenderers found to be meeting the technical criteria and qualifying requirements shall be opened on date & time mentioned in **CRITICAL DATA SHEET**. **(In case the date and time for opening of Envelope-II (Financial bid) is required to be changed, the same shall be intimated through CPP Portal).**

7. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
8. AAI reserves the right to disallow the working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain / Temporary or Permanent debarment / black listing by any department of AAI or Central/State Govt. Depts./PSUs/World Bank/ADB etc. **AAI reserves the right to verify the credential submitted by the tenderer at any stage (before or after the award the work). If at any stage, any information / documents submitted by the applicant is found to be incorrect / false or have some discrepancy which disqualifies the tenderer then AAI shall take the following action:**
  - a) **Forfeit the entire amount of EMD submitted by the tenderer.**
  - b) **The tenderer shall be liable for debarment from tendering in AAI, including termination of the contract apart from any other appropriate contractual / legal action.**

10. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.
