Notice Inviting Ouotation for shifting of XBIS machine (Oty-02) & DFMD (Oty-02) from Muirpur to Hollongi Airport and ETD (make: MS TECH, qty-01) from Varanasi Airport to Hollongi Airport including Packing of 04 items, Loading, Unloading, Transportation on door to door delivery basis.- reg.

The Jt. General Manager (CNS), Airports Authority of India, LBSI Airport, Varanasi - 221006, invites sealed quotation on behalf of the Airport Director, Airports Authority of India, LBSI Airport, Varanasi-221006 from reputed Travel Agencies/transporters, etc. for transportation of various items from Muirpur/Varanasi Airport to Hollongi Airport, as per item and Consignee details as mentioned in **ANNEXURE-A** of this NIQ document, with the following terms & conditions as stated below:

Following documents are required to be submitted by the Bidders:

- 1. Self-attested copy of GST Registration certificate.
- 2. Self-attested copy of PAN Card.
- 3. Self-attested copy of Firm registration certificate.
- 4. Duly signed NIQ Document (Page 1-5).
- 5. Filled and signed Price Bid as per ANNEXURE-B (Page 5).
 - Envelope 1(document) will contain document from Serial no. 1 to 4.
 - Envelope 2 (financial bid) will contain document from Serial no. 5.
 - Master Envelope (Envelope 1 & Envelope 2) will contain both Envelope 1&2.

Interested parties shall submit their quotation in sealed master envelope super scribing on the top "Quotation for Shifting of XBIS Machine (QTY 02) & DFMD (QTY-02) from Muirpur Airport to Hollongi Airport, Arunachal Pradesh and ETD (MS TECH, Qty-01) from Varanasi Airport to Hollongi Airport including Packing of 04 items/Loading/Transportation/Unloading" and send the same to the Jt. General Manager (CNS), Airports Authority of India, L.B.S.I. Airport, Varanasi, Uttar Pradesh-221006 on or before 23.05.2022 up to 1100 hrs. The Agency/firm or its representative can be present at the time of opening of quotations.

TERMS & CONDITIONS:

- 1. The evaluation criteria for comparison of rates for the purpose of deciding the lowest bidder (L-1) shall be on the basis of lowest quoted Total Basic Amount **excluding GST**, in the Price Bid (ANNEXURE-B). **GST will not be counted for deciding the L1 bidder in opening of the financial bid**.
- 2. The Basic rate quoted shall be inclusive of all charges like loading, transportation, unloading, labour charges, road permit and any other miscellaneous & incidental expenditure for transportation of various items ie (XBIS Machine/DFMD) from Muirpur Airport to Hollongi Airport & (ETD) from Varanasi Airport to Hollongi Airport, as per items and Consignee details mentioned in ANNEXURE- A, except GST. GST shall be extra as applicable.
- 3. Transit Insurance for the various items as mentioned in Annexure-A shall be provided by the AAI, before the commencement of the transportation journey.

- 4. In the event of the date of opening of Bid being postponed due to administrative or technical reasons, the same shall be opened on the next working day.
- 5. Rates quoted should be valid for a minimum period of 90 days for acceptance from the date of opening of Bids.
- 6. Quotations received after the stipulated date and time due to postal delay or otherwise shall not be considered under any circumstance and rejected outright by AAI.
- 7. Quotation submitted by bidders who are black-listed/debarred by CBI/AAI/ Undertaking/ Dept. like Railways, Defense or any Govt. of India/State Govt. are liable to be rejected at any time without showing any cause during the process.
- 8. All time extensions, corrigenda, addenda, amendments, clarifications, etc., if any, with respect to the NIQ document, will be posted on the AAI website. Bidders should regularly visit the website to keep themselves updated.
- 9. Only one quotation will be accepted from a single bidder, either a firm or an individual. The proprietor of the company or firm will be considered as a single party and one legal entity.
- 10. Payment shall be released by Airports Authority of India, LBSI Airport, Varanasi within 30 days of successful receipt of various items as per ANNEXURE-A at Consignee location in full quantity and endorsement by Consignee regarding the same. Payment will be released on L1 price + **applicable** GST.
- 11. It shall be the responsibility of the Agency/Bidder to deliver all the items in good condition at the Consignee Location.
- 12. The vehicle arranged by the Contractor for transportation of the items shall be fit in all respect for operation in accordance with Motor Vehicle Act, Rules and existing laws as applicable from time to time and must be equipped with valid documents, i.e., Registration Certificate, Insurance Certificate, PUC Certificate, Fitness Certificate, Road Permit and Road tax fees paid up to date during the period of contract. As the Consignment contains various electrical/electronic/mechanical parts, the vehicle should have a closed carrying-body to prevent the equipment from either rain or sun.
- 13. The driver of vehicle assigned for duty shall hold a valid driving license and abide by all the rules laid down by Transport Authority or any other authority relevant to the subject and should always strictly follow the traffic rules and regulations, so as to ensure smooth transportation of the Consignment. The driver must have a mobile phone available with him for smooth coordination and service execution and the same should be always in working condition and no separate charges shall be paid by the AAI for the same.
- 14. The contractor shall assign the job of driving of hired vehicle only to qualified, experienced and licensed drivers and also assume full responsibility for the safety and security of the Consignment (various Fire Services items) while running the vehicle by ensuring safe driving. AAI shall have no direct or indirect liability arising out of such neglect, rash or impetuous driving which is an offense under relevant section of IPC and any loss caused to AAI have to be compensated by the Contractor.
- 15. The contractor is directly responsible for injuries / death of vehicle driver or any person employed by him as well as to the third-party occupants or other users arising due to any accident or otherwise of vehicle during the transportation period. At any point of time, AAI will not be responsible for any loss / damage either to the person or to the vehicle arising out of

accident of the vehicle for performing the contractual obligations.

- 16. The contractor shall intimate the probable date and time of arrival of the Transportation vehicle at the Airport and shall monitor the movements of trucks so as to be in a position to apprise the location whenever needed by the AAI.
- 17. The Contractor shall indemnify the AAI against any loss/claims/liabilities in case of any accident of his truck during loading/unloading of consignment at site or its transportation.
- 18. After successful delivery of the various items at Consignee location, bill should be submitted in triplicate along with the following documents for initiating necessary payment action:
- (a) Copy of PAN card
- (b) Copy of GST Registration certificate
- (c) Bank account details along with Cancelled Cheque for e-payment.
- 19. **LIQUIDATED DAMAGES**: Delivery should be completed within Thirty (15) days of receipt of the Supply/Work order, at Hollongi Airport, Arunachal Pradesh, as mentioned in ANNEXURE-A. If the Agency fails to complete the delivery within this stipulated period, a penalty calculated @ 0.5 (half) per cent per week for the contract cost executed shall be recovered as liquidated damages. The total damages shall not exceed 10 (Ten) per cent of the Contract value. The liquidated damages shall be calculated on the base contract value without the Govt. taxes and duties.
- 20. **FORCE MAJEURE**: If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, earth quake, explosions, epidemics, quarantine restrictions, bandh, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such on performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of AAI as to whether the services have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option to terminate the contract.
- 21. Airports Authority of India reserves the right to accept or reject any quotation without assigning any reason there-of, and to call for any other details or information from any of the Bidder.
- 22. In case of any dispute, the decision of The Airport Director, Airports Authority of India, L.B.S.I. Airport, Varanasi (U.P.) 221006 will be final and binding on the both the parties.
