- 4. In case GST is not applicable for a bidder then the bidder shall attach the details of his/her company's turnover during any one of the last three completed financial years, duly certified by a Chartered Accountant.

1. Duly filled and signed Financial Bid with Company Seal (Annexure – D)

The Technical Bids will be opened first at 1530 Hrs. and the Financial Bids of the technically qualified bidders will be opened at 1600 Hrs. on 07/06/2022.
