- 1.0 Sealed Item Rate Quotations are invited for **"COMPREHENSIVE INSURANCE POLICY FOR NEWLY PROCURED TRUCK MOUNTED EMERGENCY RESCUE STAIRS AT CHENNAI AIRPORT"** by the Assistant General Manager (Tech) on behalf of Airport Director, Airports Authority of India, Chennai Airport, Chennai-16 in two envelope system from **IRDAI registered Insurance Companies or their branch offices in Chennai.**
- 1.1 **Insurance agent/broker/intermediary shall not be allowed to participate in the NIQ.**
- 2.0 Quotation shall be submitted in two separate envelopes, as indicated below:-

Offers not adhering to two envelope system or unsigned offer shall be rejected.

3.0 OTHER TERMS & CONDITIONS

- i) **The vehicle as mentioned in Annexure – I shall be insured under Comprehensive Insurance Policy.**
- ii) The Truck Mounted Emergency Rescue Stairs Invoice copy is enclosed for your reference.
- iii) The insurance premium shall be quoted excluding GST as per the format (Annexure-I). GST shall be paid extra as applicable.
- iv) **The insurance policy period shall be for one year.**
- v) Bidder(s) can visit and inspect the listed vehicles document if required at the premises of MT Section, AAI, Chennai Airport during the working day/hours (Monday to Friday between 1000 hrs. to 1700 hrs.). Bidders may seek any clarification before submission of the Bid by mtchnapt@aai.aero
- vi) In case of any dispute arising out of this quotation, the decision of the Airport Director, AAI, Chennai Airport will be binding on both sides.
- vii) The successful Bidder shall provide two sets of insurance policy copies to AAI.
- viii) Successful Bidders are requested to give bank details (e-payment format) for payment of premium by AAI through RTGS.
- ix) The evaluation criteria for identification of successful Bidder shall be on the basis of **lowest premium rate quoted** for issue of insurance policy (excl. GST).
- x) AAI is not bound to accept lowest quotation and reserves the right to accept or reject any or all quotation without assigning any reason thereof, and to call for any other details or information from any of the Bidder.
- xi) AAI shall not be responsible for any postal delay and offers received beyond stipulated date and time shall not be considered.
