## सामान्य नियम एवं शर्तें GENERAL TERMS AND CONDITION

1. Quotations should be submitted in accordance with Two envelopes system as mentioned below. Both the envelopes super scribing Envelope- A & Envelope-B shall be separately sealed and placed in a master envelope. The master envelope shall also be sealed and super scribed with the Name of the Work and submitted to The Airport Director, Airports Authority of India, Tuticorin Airport, and Tuticorin-628103. Envelope- B shall be opened after evaluation of documents of Envelope – A. Only Nationalized Insurance Companies authorized by IRDA shall participate.

If any clarification is needed from the bidder about the deficiency in Bidder's documents in Envelope- A, Bidder shall be asked to provide shortfall documents via Post. The bidder shall submit the requisite clarification / shortfall documents within time specified by AAI, failing of which result in Agency disqualification during Technical Bid Evaluation.

- 2. Bidder is advised to study General Terms & Condition, Vehicle Details (Annexure-I), Unconditional Acceptance Letter (Annexure III) and Checklist (Annexure-IV).
- 3. Quotation received from Agent / Broker will not be entertained. Only Nationalized Insurance Companies authorized by IRDA shall participate, other offers shall be rejected out rightly.
- 4. The firm should not submit more than one offer.
- 5. The complete NIQ document including details of vehicles (Annexure-I) and Financial Bid (Annexure-II) can be obtained from O/o the Airport Director, Airports Authority of India, Tuticorin Airport, except Saturday & Sunday, on any working days between the hours of 09:30 Hrs to 17:00 Hrs up to 09.06.2022. The NIQ documents can also be downloaded from the Tender sections of website of Airports Authority of India (<a href="https://www.aai.aero">www.aai.aero</a>).
- 6. The scanned copies of existing Insurance policies, RC of vehicles if required, may be obtained via e-mail on **votk.tech@aai.aero** from In-Charge, Technical Department, AAI, Tuticorin Airport.
- 7. Before submitting the quotation if desired, The Company may send their representative to inspect the vehicle and documents at Airport premises except for Saturday & Sunday, on any working day from 26.05.2022 to 09.06.2022 between 09:30 Hrs to 17:30 Hrs. It is advised to go through all the Terms & Conditions thoroughly before quoting the premium rates. The later claims will not be entertained.
- 8. The Company must sign in all pages Annexure I, II, III, IV with the company seal and date.
- 9. All vehicles are presently insured with Comprehensive Insurance policy cover and same to be renewed with the same Comprehensive Policy cover for the proposed period mentioned in the "Annexure-II".

- 10. For Vehicle Class "ACFT" (S.No. 1,2,3,7 of Annexure I), Bidder shall provide Insurance policies under either (i) Motor Act or (ii) Contractor Plant & Machinery Policy with Basic Cover (Accidental Damage Cover) of IDV Value & 3rd Party Coverage of Rs 10 lakhs. For Other Vehicles (S.No. 4,5,6,8,9 of Annexure I), Bidder shall provide Insurance policies under Motor Act only.
- 11. The item wise /vehicle insurance premium should be quoted in prescribed format of price/Financial-bid (Annexure-II) along with the full details of quotation for each vehicle on your company's letterhead should be enclosed as per IRDA norms and **NO Claim Bonus shall be included**.
- 12. Special discount on insurance premium for vehicle coming under category like Crash Fire Tender and Tractor which are exclusively plying within the Airport premises should be provided as applicable under insurance regulation.
- 13. The bidders are requested to offer their best-discounted rates. The rates quoted in Annexure II should be inclusive of GST and other charges if any. No extra payment will be made other than the quoted amount. AAI shall not provide Form C or D.
- 14. Transparent cellophane tape should be fixed on the quoted rates.
- 15. No Insurance Claims have been lodged to date on the current policies of 9 Nos of vehicles.
- 16. The evaluation criteria for comparison of rates to identify the lowest bidder shall be based on lowest quoted total amount, for each vehicle.
- 17. If any bidder is offering L-1 rates for 5 or more vehicles than opportunity will be extended to the same bidder to match the L-1 rates for remaining vehicles quoted by other bidders.
- 18. The IDV less than proposed IDV for 2022-23 (as per Annexure-II) will not be acceptable.
- 19. The voluntary excess should not be incorporated in the policy.
- 20. If rates are revised by IRDA after opening of Quotation, the difference in amount i.e. increase/decrease can be claimed by the successful bidder after presenting full justification.
- 21. The duly filled Quotation in the sealed envelope subscribing on the top "Quotation for Renewal of Insurance Polices of 9 Nos of A.A.I. Vehicles at Tuticorin Airport" and addressed to "The Airport Director, Airports Authority of India, Tuticorin Airport, Tuticorin -628 103" should reach this office on or before 10.06.2022 at 13:00 Hrs either by hand or Registered post.
- 22. Any quotation received after the date and time stated above shall not be entertained under any circumstances.
- 23. Airports Authority of India does not take responsibility for delay of submission of quotation send by post. Any delayed quotation shall not be considered.
- 24. Received quotations shall be opened by a committee of AAI executives on the same day i.e.10.06.2022 at 13:30Hrs at the o/o the Airport Director, AAI, Tuticorin Airport. The bidders can be present during the opening of Quotation if they wish to.
- 25. AAI is not bound to accept the lowest quotation and reserves the right to accept or reject any or all quotation without assigning any reason thereof and to call for any other details or information from any of the bidder
- 26. In the event of the date of opening of quotation is postponed due to administrative or technical reasons the same shall be opened on the next working day.
- 27. All-time extensions, corrigenda, addenda, amendments, clarifications etc. if any of the NIQ document will be posted on AAI website.
- 28. Bidders should regularly visit the website to be updated.
- 29. Rates offered in the NIQ shall be remain fixed during the entire period of contract.
- 30. Payment will be made only through NEFT/RTGS/Cheque.

- 31. On satisfactory completion of work/supply, the Collection Receipt shall be submitted to O/o Airport Director on the same day.
- 32. If any errors are found in Insurance Policies during inspection, the errored Insurance Policies shall not be accepted & same shall be replaced free of cost and submitted to O/o Airport Director, Tuticorin Airport within a week time.
