B. ENVELOPE – B – Price Bid – Containing the following document.

i) **Un- conditional price bid in prescribed format as per Annexure – B**

Both the envelopes super scribing Envelope- A (Technical Bid) & Envelope-B (Price Bid) shall be separately sealed and placed in a master envelope. The master envelope shall also be sealed and super scribed with the name of the work and Manually submitted or reach by post to **“The In-charge (CNS), Airports Authority of India, Dibrugarh Airport, Assam - 786012” on before 15-06-2022 up to 14:00 hrs.** Offers not adhering to two envelope system or unsigned offer shall be rejected out rightly. Envelope- B shall be opened after evaluation of basic documents of Envelope – A.

4. OTHER TERMS & CONDITIONS

- i. The rate quoted shall be inclusive of all other charges and taxes. No extra payment will be made other than quoted amount.
- ii. The rates shall be valid for acceptance for 45 days from the date of opening of technical bid.
- iii. The taxes and other charges if any should be clearly specified and in case it is not applicable the relevant row / column should indicate “Not Applicable” or “Nil” or “Included” and in the event it is left blank, it shall be deemed to have been included in the basic cost.
- iv. The bidders are requested to offer their best-discounted rates. The rates quoted in Annexure – B should be inclusive of Transportation, Loading & unloading charges and any other extra charges. GST shall be quoted separately in the Annexure-B. No extra payment will be made other than the quoted amount.
- v. In the event of the date of opening of technical bid or price bid is postponed due to administrative or technical reasons the same shall be opened on the next working day. The bidders can be present during opening of technical and price bid if they wish to. No separate intimation will be given in this regard.
- vi. AAI is not bound to accept lowest quotation and reserves the right to accept or reject any or all quotation without assigning any reason thereof, and to call for any other details or information from any of the bidders.
- vii. AAI shall not be responsible for any postal delay and offers received beyond stipulated date and time shall not be considered.

- viii. All-time extensions, corrigenda, addenda, amendments, clarifications etc. if any to the NIQ document will be uploaded on AAI website. Bidders should regularly visit website to keep themselves up dated.
- ix. The evaluation criteria for the purpose of identifying the lowest bidder shall be on the basis of lowest quoted total amount (inclusive of all charges) excluding GST and in case of identical quoted amount, the ordered quantity shall be divided equally wherever possible.
- x. The Scope of Work for SITC of GPS based Digital Clock is as per Annexure-D
- xi. Incomplete & ambiguous quotation will be rejected.
- xii. The work to be completed within 45 days from the date of issue of Work order.
- xiii. Liquidated Damages: A sum equivalent to 0.5 (half) per cent per week for the price of uncompleted portion / activity / delivery of contract cost executed / completed beyond delivery schedule is recovered as liquidated damages. The total damages shall not exceed 10 (Ten) per cent of the value of delayed activity/goods. The liquidated damages shall be calculated on the base cost without the Govt. taxes and duties.
- xiv. The calibration certificate issued by the successful bidder should be valid for minimum one year from the date of calibration.
- xv. Payment will be made within 30 days from the date of completion of the work through RTGS on receipt of GST Invoice, Bank Mandate, Cancelled cheque & other supporting documents at O/O CNS In-Charge, Dibrugarh Airport, Assam.
- xvi. **Applicable Laws:** This agreement shall be governed by and interpreted and construed in accordance with the laws of India. The courts situated at Guwahati only shall have jurisdiction to deal with and decide any legal matter and dispute arising out of this agreement. The purchaser shall not be responsible, in any way, for the consequence, direct or indirect, of an infringement by the contractor of its employees of the law or statute of the country in which this agreement is performed.
- xvii. **PAYING AUTHORITY:** The Airport Director, Airports Authority of India, Dibrugarh Airport, Mohanbari, Assam -786012.
- xviii. **Defence of Suits** If, any action in court is brought against the purchaser or an officer or agent of the purchaser for the failure or neglect on the part of the supplier to perform any acts, matters, covenants or things under the contract, or negligence on the part of the Supplier, his agents, representatives or his sub-suppliers, workmen, suppliers or employees, the supplier shall in all such cases indemnify and keep the purchaser, and/or his representative, harmless from all losses, damages, expenses or decrees arising all such action.
