#### TWO ENVELOPE SYSTEM

Quotations in the prescribed manner duly sealed are hereby invited for **Shifting/ Transportation of 01(one) LPDME, Make- Thales from Silchar Airport to Hirasar Airport, Gujarat and unloading at the site.** 

# 1. ENVELOPE - A - Technical Bid - Containing the following documents:

- i). Signed NIQ documents Page No 1 to 4
- ii). Unconditional Acceptance Letter Page No. 6 (Annexure II)
- iii). Self-attested Copy of GST Registration Certificate.
- iv). Self-attested copy of Firm registration certificate.

#### 2. ENVELOPE - B: Financial Bid-Containing the following document:

Unconditional Financial Bid in prescribed format as per Annexure - III (Page No. 7). Any conditional offer shall be rejected out rightly.

Both the envelopes super scribing **Envelope- A (Technical Bid)** & **Envelope-B (Financial Bid)** shall be separately sealed and placed in a **Master Envelope**.

The master envelope shall also be sealed and super scribed with the name of the work **Packing, Loading & Transportation of LPDME, Make- Thales from Silchar Airport to Hirasar Airport, Gujarat and unloading at the site** and submitted to "The Assistant General Manager (CNS), Airports Authority of India, Silchar Airport, Kumbhirgram - 788109". Offers not adhering to two envelope system or unsigned offer shall be rejected out rightly. The Technical Bid documents submitted in Envelope-A shall be evaluated first and the Financial Bid Envelope- B of Technically Qualified bidders shall be opened on the notified date and time.



#### **Terms & Conditions**

#### 1. SCOPE OF WORK:

- i. Shifting/ Transportation of 01(One) LPDME, Make- Thales along with Antennas, Cables, Modules, Batteries, manuals etc. from Silchar Airport to Hirasar Airport, Gujarat and unloading at the site by Truck. Work is inclusive of packing & loading with labour, forklift etc. at AAI, Silchar Airport, transportation & unloading at Hirasar, Gujarat Airport site in good condition without any damage.
- ii. Transporter should ensure all RTO compliance for their deployed Truck and Driver till completion of the job.
- iii. The bidder may visit the site, verify the items, ensure the dimensions, decide suitable packaging, size of container and transport vehicle.
- 2. Time allowed for completion of work is 10 (Ten days) from issue of work order by AAI.

#### 3. **RATE:**

- i. Quoted Rate quoted shall be inclusive of packing & loading at AAI, Silchar Airport, transportation & unloading at Hirasar, Gujarat Airport site including labour, forklift charges, transit insurance and all other incidental charges like Toll, parking, interstate permits etc.
- ii. The rate quoted shall be valid for a period of 90 days from the Bid opening date and no escalation / deviation shall be accepted under any circumstances.

#### 4. PAYMENT:

- i. No advance payment shall be made.
- ii. Payment shall be process within 20 days through **NEFT/RTGS** from the date of submission of Invoice in Original, Complete in all respect and on satisfactory completion of work along with acknowledgement of goods receipt duly sign stamped/ mail issued by the Airport Director/Concerned AAI Officer from last destination Airport.
- iii. TDS & other Taxes as applicable may be deducted from the bill.
- 5. In the event of the date of opening of Technical Bid or Price Bid is postponed due to administrative or technical reasons the same shall be opened on the next working day.
- 6. Evaluation of price bids will be based on overall L1 status. In case rate offered by two or more firms are same, AAI may on its discretion decide suitably to award the work to any of the lowest agency. No query shall be entertained in this regard and decision of AAI shall be final and binding on all the bidders.





- 7. Authority is not bound to accept lowest quotation and reserves the right to accept or reject any or all quotation without assigning any reason thereof, and to call for any other details of information from any of the Bidder.
- 8. The Firm/Bidder should not submit more than one offer.
- 9. The Bidders may be present during opening of Bid, if they wish to do so.
- 10. All time extensions, corrigendum, addendum, amendments, clarifications etc. if any regarding the NIQ document will be posted on AAI website.
- 11. Quotation enclosed in a sealed envelope should be sent to this office on or before the last date and time for Bid submission. AAI is not responsible for any postal delay and offers received after stipulated date and time shall not be considered.
- 12. Bidders may also submit their Bids before last date of submission through email also. The scanned copy of the Technical & Financial Bid shall be password protected. The bidder shall share the password of Technical Bid on the date of opening of the Technical Bid, similarly the password of Financial Bid shall be sent on the date of opening of the Financial Bid through email only.
- 13. The work shall not be sublet / assigned directly or indirectly to any other agencies in whole or part. However, the same may be considered in case of emergency due to breakdown of the assigned contractor's Truck or any other justified reason with prior written consent of the competent authority of the AAI.
