General Terms and Conditions

- 1. The applicant shall submit following documents:
 - a. Duly signed NIQ document
 - b. The agency shall have a running shop / work place for Hair cutting in Agra.
 - c. Agency has to quote their rate as per the condition of quotation un-conditionally. In Case of any condition put by the agency in quotation form, quotation will be rejected.
 - d. The quotation shall be submitted in sealed cover with writing name of work and name& Address of agency on cover.
 - e. Duly filled-in and signed unconditional acceptance letter (as per prescribed format attached with the NIQ).
 - f. Self-attested photocopy of PAN Card.
- 2. The criteria for selection of successful bidder shall be based on lowest quote.
- 3. The applicant shall be solely responsible to observe and comply with Labor laws in force for employment of such workers as may be considered in Agra U.P.
- 4. The duration of contract shall be for One year from the date of acceptance of work Order by the agency with a provision for extension of another one year on the same terms and conditions, subject to satisfactory performance, which will be granted without any escalation.
- 5. The service is required presently for 64 numbers of CISF personnel. If the CISF personnel will be increased during the currency of contract period due to commencement of more flights from/to Civil Air Terminal, Agra the additional amount on pro-rata basis shall be payable exceeding 64 numbers.
- **6.** The necessary tools for the said services shall be arranged by the service provider at his own cost including all consumables like Shaving Cream, Antiseptic Lotion and Blades etc. as required.
- 7. Service provider shall ensure that the most safe materials and tools are used for the services and an experienced barber is deployed for rendering safe services.
- 8. The barber would be required to carry-out the hair cutting at least thrice in a week at CISF Unit Line (presently at Agra Air Terminal,) or at any other location as decided from time to time.
- 9. AAI Agra Air Terminal shall pay to the successful bidder; the rates quoted by him on monthly basis by 10th of every month, on submission of bill (after deduction of income tax, work tax and recoveries if any).
- 10. The successful bidder shall be issued work order and same should require to be acknowledged within FIVE DAYS of issue of letter of intent. 10% of the amount for one year shall be deposited with AAI as Security Deposit by the successful party, which shall be

- refunded after expiry of the contract without any interest.
- **11.** The bill submitted by the party shall be duly verified by the office of Commandant, CISF, Agra Air Terminal, on monthly basis for processing of payment.
- **12.** AAI Agra Air Terminal, shall not be responsible for any kind of compensation due to dispute between agency and its employee.

13.

- a. Cover No.1 shall contain the following documents :
 - i. Declaration of the agency have a running shop / work place for Hair cutting in Agra with complete Shop/ work place address on notarized non judicial stamp paper of value Rs. 50/- .
 - ii. Duly filled-in and signed unconditional acceptance letter (as per prescribed format attached with the NIQ).
 - iii. Self-attested photocopy of PAN Card.
- b. Cover No.2 (Price Bid) shall contain in separate cover. "Duly-Signed & Stamped Price-Bid (Annexure II)".

NOTE:

- 1. Cover No 2 shall contain un-conditional price bid only. Corrections, Insertion or over-writing, if any, must be signed and stamped by the contractor.
- 2. Both Cover No. 1 (Technical Bid) and Cover No.2 (Price Bid) shall be submitted in Master Envelop in sealed condition
- 3. Cover No. 1 shall be opened first. The offers from those parties who are unable to unconditionally accept AAI's NIQ conditions or who fail to deposit the required valid documentary proof of eligibility criteria will be rejected and Cover No 2 containing tender documents shall not be opened.
- 4. The NIQs of firm/ parties who shall be found technically qualified shall be eligible for opening of his/ their Cover no. 2 (Price Bid).
- 5. The bidder shall ensure timely submission of NIQs.
- 6. AAI, reserves the right to terminate the contract without assigning any reason thereof by giving 07 days notices in writing.
