Sealed Quotations are invited for the “**Supply of Automotive Pneumatic Tyres (Tubeless)**” by CIC, Airports Authority of India, Jaipur Airport, Jaipur - 302029, in two envelope systems from the Manufacturers/Authorized Distributors/ Authorized Dealers.

2. TWO ENVELOPE SYSTEM:

Quotations should be submitted in two separate envelopes as per the details given below.

A. ENVOLOPE – A - Technical Bid – Containing the following documents

- Copy of GST registration certificate.
- Copy of NIQ –PageNo.1and 2 duly signed by the bidder accepting the Terms & Conditions.
- Valid Authorized dealership/Distributorship certificate from the OEM as the case may be.

B. ENVOLOPE – B – Price Bid – Containing the following document.

- Un-conditional price bid in prescribed format as per Annexure – I (Page No. 3). Any conditional offer shall be rejected.

Both the envelopes super-scribing Envelope-A (Technical Bid) & Envelope-B (Price Bid) shall be separately sealed and placed in a master envelope. The master envelope shall also be sealed and super scribed with the name of the work and submitted to **Asst. Manager (Tech.) Airports Authority of India, Dept. of Technical (MT Section), Jaipur Airport, Jaipur - 302029**. Offers not adhering to two envelope systems or unsigned offer shall be rejected out rightly.

Envelope- B shall be opened after evaluation of basic documents of Envelope – A.

3. OTHER TERMS & CONDITIONS:

- Offered Tyres should be from reputed manufactures like CEAT, JK, MRF, BRIDGESTONE, GOODYEAR etc. complying with ISI mark.
- Warranty for all tyres should not be less than one year. Valid proof should be submitted in this regard.
- The rate quoted shall be all inclusive except GST.
- GST should be clearly specified in relevant row/column and in case it is not applicable the relevant row / column should indicate “Not Applicable” or “Nil” or “Included” and in the event it is left blank, it shall be deemed to have been included in the basic cost.
- The bidders are requested to offer their best-discounted rates. The rates quoted in Annexure – I (Page No.: 3) should be inclusive of other charges like transportation charges etc if any. No extra payment will be made other than the quoted amount.
- The rates shall be valid for acceptance for **45 days** from the date of opening of technical bid.
- Transparent cellophane tape must be fixed on the quoted rates.**

- 3.8. In the event of the date of opening of technical bid or price bid is postponed due to administrative or technical reasons, the same shall be opened on the next working day. The Bidders or their authorized Representative can participate in the opening of Technical and Price Bid if they wish to.
- 3.9. AAI is not bound to accept the lowest quotation and reserves the right to accept or reject any or all the quotations without assigning any reason thereof and also to call for any other details or information from any of the Bidder.
- 3.10. AAI shall not be responsible for any postal delay and offers received beyond stipulated date and time shall not be considered.
- 3.11. Any extensions, corrigenda, addenda, amendments, clarifications etc. if any to the NIQ document will be posted on AAI website www.aai.aero/tender/tendersearch. Bidders should regularly visit the website to keep themselves updated.
- 3.12. The evaluation criteria for identifying the Successful Bidder shall be on the basis of **overall lowest quoted amount excluding GST** and in case quoted amounts are the same, the ordered quantity shall be divided equally wherever possible.
- 3.13. Firms having authorized dealership of more than one OEM shall submit only **one offer** by choosing any one of the brand / make failing which the bid shall be rejected. Only those material (product make) shall also be accepted for which rates have been quoted and accepted by AAI.
- 3.14. Only one quotation shall be accepted from a single bidder either a firm or an individual. The propriety of the company or firm will be considered as single party and one legal entity.
- 3.15. Payment will be made within 25 days through the NEFT/RTGS from the receipt of material in correct quantity and good condition, along with the bill at Dept. of Technical (MT Section Jaipur Airport).
- 3.16. Delivery of material shall be within **15 days** from the date of Purchase Order. In case the delay exceeds 15 days, AAI shall reserve the right to cancel the order.
