  - 1.1 **E-Tendering Participation Requirements:** The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

#### 1.2. **REGISTRATION:**

- 1.2.1. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <a href="http://etenders.gov.in/eprocure/app">http://etenders.gov.in/eprocure/app</a>) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 1.2.2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 1.2.3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

- 1.2.4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 1.2.5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 1.2.6. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

#### 1(a) **Scope of Work:**

#### 1(b) Eligibility

- 1. Insurer must be registered with IRDA having Permanent Account Number.
- 2. Should have annualized average financial GWP of **Rs. 100 crore** against policy premium executed during last three years ending **31st March** of the previous financial year. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the firm should be submitted along with the application. Firms showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- 3. Insurer shall be in the field of insurance for 7 years and shall have the experience in Aviation insurance.

#### 2. TERMS AND CONDITIONS.

- 2.1 Hull all risk, indicating the sum insured.
- 2.2 Hull War risk, indicating the sum insured.
- 2.3 **Third party Liability Limit (without any deductible)** Property damage/loss, loss of life, Bodily injury for each aircraft Rs.20.00 crores any one accident / anyone occurrence **subject to automatic re-instatement** of limit of liability upon occurrence of loss during the policy period as per the existing policy.
- 2.4 **Passenger Liability**: This will include Passengers & pilots (9 passengers including pilots for Dornier aircraft and 06 passengers including pilots for B-300 aircraft) admitted liability of Rs.10,00,000/- each person/ each accident against full legal discharge or legal liability in the event of non-acceptance of such admitted liability. Passengers

include AAI employees whose names will be contained in manifest or otherwise as deemed passengers.

#### Note:

Passenger's admitted liability may increase from Rs. 10 lakhs against each person as per Statutory requirement for which additional premium if any, shall be on pro-rata basis in proportion to the sum increased over & above Rs.10 lakhs for each during the policy period depending upon the amendment, if any in the Carriage by Air Act.

#### 2.5 **Search & Rescue Expenses Clause**

a) Underwriters liability shall not exceed Rs.2.5 Crores subject to automatic reinstatement of limit of liability (although it is not mentioned in the existing policy) in respect of any one search and rescue operations upon occurrence of any loss during the policy period. The policy will also cover reimbursement of medical, traveling expenses / transportation of next of kin (relatives), retrieval of bodies, its repatriation to home locations and funeral expenses etc. incurred in case of an accident both for passengers & crew members including travel expenses of AAI personnel (technical / non- technical) and other outside agencies (as reimbursement) on actual basis. This also includes reimbursement of transportation charges by any mode of transportation related to the wreckage including labour charges, escorting expenses etc., from the accident site to repairers shop in case of accidents.

#### b) Medical and Rehabilitation related expenses.

The policy shall cover under AVN 80 to pay all reasonable expenses incurred within one year from the date of accident for necessary medical, surgical, ambulance, hospital, professional nursing, repatriation /rehabilitation and funeral expenses to or for each person (manifested or non-manifested) including crew members who sustains bodily injury, sickness or disease caused by accidents whilst in entering or alighting from the Aircraft if the aircraft is being used by the insured or with his permission subject to maximum of **Rs. 50 lakhs per incident / accident.** 

#### 2.6 Unlicensed Landing Grounds

Policy will cover the insured aircraft and assured liability arising from the use of unlicensed landing grounds.

#### 2.7 Aircraft HULL/ Liabilities Policy

The Company (Insurance Co.) will in addition pay:-

- (a) In the event of the aircraft (if insured herein for risks of flight) through force Majeure alighting in any place from which it is unable to take off again, the reasonable cost of dismantling the aircraft, removal to the nearest aerodrome / repair agency and reassembling even if the aircraft has sustained no damage and also pay reasonable emergency expenses necessarily incurred by the insured for the immediate safety of the aircraft including watch & ward expenses, if any.
- (b) In the event of damage to the aircraft as covered by this Policy, the reasonable expenses incurred by the Insured with the written consent of the Company in respect of:-

- i) Maintenance of watch on the damaged aircraft and safeguarding it from further loss or damage, reimbursement of additional insurance premium, if any for special coverage as per the eventuality.
- ii) If insured herein for risks of flight, the necessary test flights and
- **iii**) Such proportion of the cost of obtaining a new Certificate of Airworthiness as shall apply to the period from the date of accident to the date of expiry of the current Certificate of Airworthiness.

The total liability of the Company in respect of (a) and (b) above shall not exceed 10 percent of the total agreed value as shown in of the Schedule of existing policy or actual whichever is less.

#### 2.8 **Aircraft Lay-up returns**

Refund of premium where the lay-up is for 30 consecutive days or more after adjusting annual ground risk premium for all aircrafts for the actual period of lay-up for each aircraft without any reduction clearly mentioning the premium rate of Ground Risk against each type of aircraft.

#### 2.9 Claims Settlement

- (i) Claims payable, if any, under the Policy/Policies to a foreign party/parties, shall be paid in foreign currency by the Insurance Company.
- (ii) Death claims of passengers including crew members shall be paid / settled by the Insurers against necessary undertakings to be given by AAI within 60 days of submission of necessary claims by AAI.
- (iii) Claims regarding in-house repairs /replacement under Hull / Inventory, the cost of repair shall be actual landed cost to the insured at the site of repair of the necessary material, spare parts, equipments, testing & calibration fees, freight, cartage, Octroi / taxes etc plus the actual labour cost and 20% of overheads of such total repair cost. The agreed Labour rates per hour shall for in-house repairs / overhaul for claim purpose which are inclusive of depreciation / amortization on test-tools, work shop equipments, ground support equipments and other in-house workshop facilities be at the following rates:-
  - (a) Engineers Rs. 3000/-per hour
  - (b) Technician Rs. 1500/- per hour.
  - (c) Pilot Rs. 25,000/- per day.
- In case of claims the insurer shall pay 50% of the initial estimates of repairs/replacement of damaged parts under Hull policies within 30 days of submitting the initial estimates by the AAI. Claim expenses for last five year are NIL for all the aircraft.
- 2.10 The profit commission / discount on renewal of the policy on the same terms and conditions.
- 2.11 Excess deductible amount and the clause may be defined clearly.
- 2.12 The quotes should indicate premium to be paid for operation in India and Asia Pacific region.
- 2.13 One Set of Policies duly stamped along with five copies shall be submitted incorporating all the terms and conditions of the tender within 60 days from the award

of contract. Draft policies will be submitted to AAI within 30 days from the award of contract. However, Certificate of coverage in respect of HAR/HWR and other liability risks etc incorporating the details of aircrafts with registration numbers, Sums Assured against each etc will be issued immediately on receipt of the premium on or before 10<sup>th</sup> **September**, **2022**.

2.14 Any dispute shall be subject to New Delhi jurisdiction only.

- 2.15 Bidder will have no right to cancel the policy before the expiry of the policy period unless notice in writing not less than 30 days in advance is given to AAI and in such a case the pro-rata refund of the premium shall be made to AAI for the un-expired period against each policy along with a notice of cancellation.
- 2.16 If the successful Bidder fails to commence the policy on the due date of renewal, AAI at its sole discretion, will have the right to cancel the contract and seek compensation for all the direct and consequential costs of cancellation **including claim for difference of premium which AAI may be bound to pay to the next bidder and also** right to de-empanel such insurance company from bidding in future.
- 2.17 Guidelines issued by IRDA / TAC from time to time with regard to insurer's responsibility and liability towards insured shall be automatically applicable to this insurance contract to the extent they improve upon the stipulation of this tender form.

#### 3. **Period of Contract**

The period of Contract is for one year & can be renewed for further period of one year with mutual agreed terms and conditions.

#### 4. **Payment:**

The payment will be made **through ECS/Cheque** for successful bidder within 21 days of the date of submission of the Invoice/Bill.
