

ESIC, EPF paid to the Statutory Authorities & Bonus amount paid to workers by the contractor shall be reimbursed by AAI on actual basis on submission of documentary evidences. The rates shall be remained firm throughout the contract period or extended period of contract (if any).

In case of change in rate of tax or any provision relating to levy of tax resulting in increase in burden of tax on the contractor, the contractor shall be entitled to receive any compensation for such increase in quantum of tax payable by the contractor. 

#### **CLAUSE 1 A**

## Recovery of Security **Deposit**

The person/persons whose tender(s) may be accepted (hereinafter called the contractor) shall permit AAI at the time of making any payment to him for work done under the contract to deduct a sum at the rate of 5% of the gross amount of each running and final bill till the sum deducted alongwith the sum already depositedasearnestmoney, willamount to security deposit of 5% of the tendered value of the work. Earnest money shall be adjusted first in the security deposit and further recovery of security deposit shall commence only when the update amount of security deposit starts exceeding the earnest money. Such deductions will be made and held by way of Security Deposit unless he/they has/have deposited the amount of Security at the rate mentioned above in the form of fixed deposit receipts or guarantee bonds of any Scheduled Bank but not Co-operative or Gramin Bank. In case a fixed deposit receipts or Guarantee Bonds of any Bank furnished by the contractor to the AAI as part of the security deposit and the Bank is unable to make payment against the said fixed deposit receipt or Guarantee Bond, the loss caused thereby shall fall on the contractor and the contractor shall forthwith on demand furnish additional security to the AAI to make good the deficit. In works where condition of submission of performance guarantee is not applicable, the security deposit at the rate of 10% (Ten Percent) of gross amount of each running bill shall be deducted in stead of 5%, till the sum to be a considered of the considerwith the sum already deposited as earnest money will amount to security deposit of 10% of the contract value of work. Other conditions shall remain samestated above. All compensations or the other sums of money payable by the contractor under the terms of this contract may be deducted from, or paid by the sale of a sufficient part of his security deposit or from the interest arising therefrom, or from any sums which may be due to or may become due to the contractor by AAI on any account whatsoever and in the event of his Security Deposit being reduced by reason of any such deductions or sale as aforesaid, the contractor shall within 10 days make good in fixed deposit receipts or Guarantee Bonds tendered by the Scheduled Banks (but not any Co-operative or Gramin bank) (if deposited for more than 12 months) endorsed in favour of the Airports Authority of India, any sum or sums which may have been deducted from, or raised by sale of his security deposit or any part thereof. The security deposit shall be collected from the running bills of the contractor at the rates mentioned above and the Earnest money deposited at the time of tenders will be treated as part of the Security Deposit. The security deposit as deducted above can be released against bank guarantee is sued by any Scheduled Bank (but not from Cornel and Cornel andoperative / Gramin Bank), on its accumulations to a minimum of Rs. 5 lakh

subject to the condition that amount of such bank guarantee, except last one, shall not be less than Rs. 5lakh.

Note 1: Provided further that the validity of Bank Guarantee including the one given against the earnest money shall be in conformity with provisions contained in the clause 17 which shall be extended from time to time depending upon extension of contract under provision of Clause 2 & Clause5.

**Note 2:** Note 1 above shall be applicable for both clause 1 and 1 A.



# Compensation for Delay

If the contractor fails to maintain the required progress in terms of clause 5 or to complete the Work and clear the site on or before the contract or justified extendeddateofcompletionasperclause5(excludinganyextensionunderclause 5.5) as well as any extension granted under clause 12 and 15, he shall, without prejudice to any other right or remedy available under the law to the AAI on account of such breach, pay as compensation the amount calculated at the rates stipulated below as the authority specified in schedule 'F' may decide on the amount of Tendered Value of the work for every completed day/month (as determined)thattheprogressremainsbelowthatspecifiedinClause5orthatthe work remains incomplete. This will also apply to items or group of items for which a separate period of completion has been specified.

## i) Compensation for delay of work

If the completion of work is delayed due to reasons attributed to contractor, AAI shall be entitled for compensation for delay as detailed below:

- i. For works costing uptoRs. 20.00 Lac: 1.0% (one percent) of tendered value per weekofdelayorlesseramountasdecided by the competent authority subject to a maximum of 10% of contractvalue.
- ii FortheworkscostingmorethanRs20Lac a. For the works having completion period less than 2 years

0.5% (half percent) of tendered value per week of delay or lesser amount as decided by the competent authority subject to a maximum of 10% of the tendered value.

# b. For the works having completion period more than 2 years

0.5% of tendered value per fortnight ofdelay or lesser amount as decided by the competent authority subject to a maximum of 10% of the tenderedvalue.

Providedalwaysthatthetotalamountofcompensationfordelaytobepaidunder this condition shall not exceed 10% of the Tendered Value of work or of the Tendered Value of the Sectional part of work as mentioned in schedule 'F' for which a separate period of completion is originally given.

IncasenocompensationhasbeendecidedbytheauthorityinSchedule'F'during theprogressofwork,thisshallbenowaiverofrighttolevycompensationbythe said authority if the work remains incomplete on final justified extended date of completion. If the Engineer in Charge decides to give further extension of time allowing performance of work beyond the justified extended date, the contractor shall be liable to pay compensation for such extended period. If any variation in amount of contract takes place during such extended period beyond justified extendeddateandthecontractorbecomesentitledtoadditionaltimeunderclause 12, the net period for such variation shall be accounted for while deciding the periodforlevyofcompensation. However, during such further extended period beyond the justified extended period, if any delayoccurs by events undersub clause 5.2, the contractor shall be liable to pay compensation for such delay.



Provided that compensation during the progress of work beyond the justified extended date of completion for delay under this clause shall be for nonachievement of sectional completion or part handing over of work on stipulated / justified extended date for such part work or if delay affects any other works / services. This is without prejudice to right of action by Engineer-in-Charge under clause 3 for delay in performance and claim of compensation under that clause.In case action under clause 2 has not been finalized and the work has been determined under clause 3, the right of action under this clause shall remain post determination of contract but levy of compensation shall be for days theprogress is behind the schedule on date of determination, as assessed by the authority in schedule'F', afterdueconsideration of justified extension. The compensation for delay, if not decided before the determination of contract, shall be decided after of determination of contract.

The amount of compensation may be adjusted or set-off against any sumpayable to the' Contractor under this or any other contract with AAI. In case, the contractordoesnotachieveaparticularmilestonementionedinscheduleF,orthe scheduled milestone(s) in terms of Clause 5.4, the amount shown against that milestone shall be withheld, to be adjusted against the compensation levied as above. With-holding of this amount on failure to achieve a milestone, shall be automatic without any notice to the contractor. However, if the contractor catches with the progress of work on the subsequent milestone(s), the withheld amount shall be released. In case the contractor fails to make up for the delay in subsequent milestone(s), amount mentioned against each milestone missed subsequently also shall be withheld. However, no interest, whatsoever, shall be payable on such withheldamount.

Provided always that provision of the Clause 2A shall be applicable only when so provided in 'Schedule F'. This clause shall be applicable for the work which estimated cost put to tender is Rs. 50.00 Cr. and above for pavement workand Rs.100.00 Cr. and above for building work.

  - After giving notice to the contractor to measure up the work of the contractorandtotakesuchwhole,orthebalanceorpartthereof,asshall be unexecuted out of his hands and to give it to another contractor or anyothermeanstocompletethework. The contractor, whose contractis determined as above, shall not be allowed to participate in the tendering process for the balance work. In the event of above courses being adoptedbytheEngineer-in-Charge,thecontractorshallhavenoclaimto compensation for any loss sustained by him by reasons of his having purchased or procured any materials or entered into any engagementsor made any advances on account or with a view to the execution of the work or the performance of the contract. And in case action is taken under any of the provision aforesaid, the contractor shall not be entitled to recover or be paid any sum for any work thereof or actually performed under this contract unless and until the Engineer-in-Charge hascertifiedinwritingtheperformanceofsuchworkandthevalue payable in respect thereof and he shall only be entitled to be paid the value so certified.

## **CLAUSE 3 A**

In case, the work cannot be started due to reasons not within the control of the contractor within 1/8th of the stipulated time for completion of work or one monthwhicheverishigher,eitherpartymayclosethecontractbygivingnoticeto the other party stating the reasons. In such eventuality, the Earnest Money DepositandthePerformanceGuaranteeofthecontractorshallberefundedwithin 30days.

Neither party shall claim any compensation for such eventuality. This clause is not applicable for any breach of the contract by either party.

However in case of works costing lesser than Rs. 5.00 Lacs Engineer-in-Charge may decide for adopting computerized measurement if required, except as otherwise provided, ascertain and determine by measurement the value of work done in accordance with the contract. All measurements of all items having financial value shall be entered by the contractor and compiled in the shape of the Computerized Measurement Book having pages of A-4 size as per



theformatofthedepartmentsothatacompleterecordisobtainedofallthe items of works performed under thecontract.

All such measurements and levels recorded by the contractor or his authorised representative from time to time, during the progress of the work, shall be got checked by the contractor from the Engineer-in-Charge or his authorised representative asperinterval or program fixed inconsultation with Engineer-in-

Chargeorhisauthorisedrepresentative. Afterthenecessary corrections made by the Engineer-in- Charge, the measurement sheets shall be returned to the contractor for incorporating the corrections and for resubmission to the Engineer-in-Charge for the dated signatures by the Engineer-in-Charge and the contractor or their representatives in token of their acceptance.

Whenever bill is due for payment, the contractor would initially submit draft computerized measurement sheets and these measurements would be got checked/test checked *from* the Engineer-in-Charge and/or his authorized representative. The contractor will, thereafter, incorporate such changes as may be done during these checks/test checks in his draft computerized measurements, and submitto the department acomputerized measurement book,

duly bound, and with its pages machine numbered. The Engineer-in-Charge and/or his authorised representative would thereafter check this MB, and record the necessary certificates for their checks / testchecks.

The final, fair, computerized measurement book given by the contractor, duly bound, with its pages machine numbered, should be 100% correct, and no cuttingoroverwritinginthemeasurementswouldthereafterbeallowed. If a larger error is noticed, the contractor shall have to submit a fresh computerized MB with its pages duly machine numbered and bound, after getting the earlier MB cancelled by the department. Thereafter, the MB shall be taken in the records of Engineer-in-charge, and allotted a number as per the Register of Computerized MBs. This should be done before the corresponding bill is submitted to the Engineer-in-charge for payment. The contractor shall submit two spare copies of such computerized MB's for the purpose of reference and record by the various officers of thedepartment.

The contractor shall also submit to the department separately his computerized Abstract of Cost and the bill based on these measurements, duly bound, and its pages machine numbered along with two spare copies of the "bill. Thereafter, this bill will be processed by the Engineer-in-charge and allotted a number as perthecomputerized recordinthes a measurement book meant formeasurements.

The contractor shall, without extra charge, provide all assistance with every appliance, labour and other things necessary for checking of measurements / levels by the Engineer-in-charge or his representative.

Exceptwhereanygeneralordetaileddescriptionoftheworkexpresslyshowsto the contrary, measurements shall be taken in accordance with the procedure set forth in the specifications notwithstanding any provision in the relevant Standard Method of measurement or any general of local custom. In the case of item which are not covered by specifications, measurements shall be taken in accordance with the relevant standard method of measurement issued by the Bureau of Indian Standards and if for any item no such standard is available then a mutually agreed method shall befollowed.

The contractor shall give not less than seven days' notice to the Engineer-in-Charge or his authorized representative of the work before covering up or otherwise placing beyond the reach of checking and / or test checking the measurement of any work in order that the same be checked and / or test checked and correct dimensions thereof be taken before the same is covered up or placed beyond the reach of checking and / or test checking measurementand shallnotcoverupandplacebeyondreachofmeasurementanyworkwithout



consent in writing of the Engineer-in-charge or his authorized representative of the work who shall within the aforesaid period of seven days inspect the work, andifanyworkshallbecovereduporplacedbeyondthereachofcheckingand / or test checking measurements without such notice having been given or the Engineer-in charge's consent being obtained in writing the same shall be uncovered at the contractor's expense, or in default thereof no payment or allowance shall be made for such work or the materials with which the same was executed.
Engineer-in-chargeorhisauthorisedrepresentativemaycauseeitherthemselves or through another officer of the department to check the measurements recorded by contractor and all provisions stipulated herein above shall be applicable to such checking of measurements orlevels.  It is also a term of this contract that checking and/or test checking the measurements of any item of work in the measurement book and/or its payment in the interim, on account of final bill shall not be considered as conclusive evidence as to the sufficiency of any work or material to which it relates nor shall it relieve the contractor from liabilities from any over measurement or defects noticed till completion of the defects liability period.

No payment shall be made for work, estimated to cost Rs. One lac or less till after the whole of the work shall have been completed and certificate of completion given. For works estimated to cost over Rs. One lac, the interim or running account bills shall be submitted by the contractor for the work executed on the basis of such recorded measurements on the format of the Department in triplicate on or before the date of every month fixed for the same by the Engineer-in-Charge. The contractor shall not be entitled to be paid any such interim payment if the gross work done together with net payment/adjustment of advances for material collected, if any, since the last such payment is less than the amount specified in Schedule 'F', in which case the interim bill shall be prepared on the appointed date of the month after the requisite progress is achieved. Engineer-in- Charge shall arrange to have the bill verified by taking or causing to be taken, where necessary, the requisite measurements of the work. In the event of the failure of the qontractor to submit the bills, Engineer-in-Charge shall prepare or cause to be prepared such bills in which event no claims whatsoever due to delays on payment including that of interest shall be payable to the contractor. Payment on account of amount admissible shall be made by the Engineer-in-Charge certifying the sum to which the contractor is considered entitled by way of interim payment at such rates as decided by the Engineer-in-Charge. The amount admissible shall be paid by 10th working day after the day of presentation of the bill by the Contractor to the Engineer-in-Charge or his Asstt. Manager / Manager (Engg.) together with the account of the material issued by the department, or dismantled materials, if any. In the case of works outside the headquarters of the Engineer- in-Charge, the period of ten working days will be extended to fifteen working days.

All such interim payments shall be regarded as payment by way of advances against final payment only and shall not preclude the requiring of bad, unsound and imperfect or unskilled work to be rejected, removed, taken away and reconstructed or re-erected. Any certificate given by the Engineer-in-charge relating to the work done or materials delivered forming part of such payment, may be modified or corrected by any subsequent such certificate(s) or by the final certificate and shall not by itself be conclusive evidence that any work or materials to which it relates is are in accordance with the contract and



specifications. Any such interim payment, or any part thereof shall not in any respect conclude, determine of affect in any way powers of the Engineer-incharge under the contract or any of such payments be treated as final settlement and adjustment of accounts or in any way vary or affect the contract.

Pending consideration or extension of date of completion, interim payments shallcontinuetobemadeashereinprovidedwithoutprejudicetotherightofthe department to take action under the terms of this contract for delay in the completion of work, if the extension of date of completion is not granted by the competentauthority.

The Engineer-in-Charge in his sple discretion on the basis of a certificate from the Asstt Manager / Manager (Engg) to the effect that the work has been completed up to the level in question make interim advance payments without detailed measurements for work done (other than foundations, items to be covered under finishing items) up to lintel level (including sunshade etc.) and slablevel, for each floorworking out at 75% of the assessed value. The advance payments so allowed shall be adjusted in the subsequent interim bill by taking detailed measurements thereof.

## Completion Certificate and Completion Plans

Within ten days of the completion of the work, the contractor shall give notice of such completion to the Engineer-in-Charge and within thirty days of the receiptofsuchnotice,theEngineer-in-Chargeshallinspecttheworkandifthere is no defect in the work, shall furnish the contractor with a final certificate of completion, otherwise a provisional certificate of physical completion indicating defects(a)toberectifiedbythecontractorand/or(b)forwhichpaymentwillbe made at reduced rates, shall be issued. But no final certificate of completion shall be issued, nor shall the work be considered to be complete for 'Civil Construction Works' until the contractor shall have removed from the premises on which the work shall be executed all scaffolding, surplus materials, rubbish and all huts and sanitary arrangements required for his/their work people on the site in connection with the execution of the works as shall have been erected or constructed by the contractor(s) and cleaned off the dirt from all wood work. doors, windows, walls, floor or other parts of the building, in, upon, or about which the work is to be executed or of which he may have had possession for the purpose of the execution; thereof, and not until the work shall have been measured by the Engineer-in-charge. If the contractor shall fail to comply with the requirements of this Clause as to removal of scaffolding, surplus materials and rubbish and all huts and sanitary arrangement as aforesaid and cleaning off dirt on or before the date fixed for the completion of work, the Engineer-incharge may at the expense of the contractor remove such scaffolding, surplus materials and rubbish etc., and dispose of the same as he thinks fit and clean off such dirt as aforesaid, and the contractor shall have no claim in respect of scaffolding or surplus materials as a foresaid except for any sum actually realizedthe salethereof.

## **CLAUSE 10**

## Materials supplied by Authority

Materials which Authority will supply are shown in Schedule 'B' which also stipulates quantum, place of issue and rate(s) to be charged in respect thereof. The contractor shall be bound to procure them from the Engineer-in-charge.

As soon as the work is awarded, the contractor shall finalise the programme for the completion of work as per clause 5 of this contract and shall give his estimates of materials required on the basis of drawings/ or schedule of quantities of the work. The contractor shall give in writing his requirement to the Engineer-in-charge, which shall be issued to him keeping in view the progressofworkasassessedbytheEngineer-in-Chargeinaccordancewiththe agreed phased programme of work indicating monthly requirements of various materials. The contractor shall place his indent in writing for issue of such materials at least 7 days in advance of hisrequirement.

Such materials shall be supplied for the purpose of the contract only and the value of the materials so supplied at the rates specified in the aforesaid schedule shall be set off or deducted, as and when materials are consumed in items of work (including normal wastage) for which payment is being made to the contractor, form any sum then due or which may therefore become due to the contractor under the contract or otherwise or from the security deposit. At the time of submission of bills, the contractor shall certify that balance of materials supplied is available at site in original goodcondition.

The contractors hall submital ong with every running bill (on account or interim bill) material-wise reconciliations tatements supported by complete calculations



reconciling total issue, total consumption and certified balance (diameter / section-wise in the case of steel) and resulting variations and reasons thereof. Engineer-in-charge shall (whose decision shall be final and binding on the contractor) be within his rights to follow the procedure of recovery in clause 42 at any stage of the work if reconciliation is not found to be satisfactory.

The contractor shall bear the cost of getting the material issued, loading, transporting to site, unloading, storing under cover as required, cutting assembling and joining the several parts together as necessary. Notwithstanding anything to the contrary contained in any other clause of the contract and all stores/materialssosuppliedtothecontractororprocuredwiththeassistanceof AAI shall remain the absolute property of Authority and the contractorshall be the trustee of the stores/ materials, and the said stores/ materials shall not be removed/ disposed off from the site of the work on any account and shall be at all times open to inspection by the Engineer-in-charge or his authorised agent. Any such stores / materials remaining unused shall be returned to the Engineerin-charge in as good a condition in which they were originally supplied at a place directed by him, at a place of issue or any other place specified by him as he shall require, but in case it is decided not to take back the stores / materials the contractor shall have no claim for compensation on any account of such stores / materials so supplied to him as aforesaid and not used by him or forany wastage in or damage to in such stores /materials.

On being required to return the stores / materials, the contractor shall hand over the stores/ materials on being paid or credited such price as the Engineer-incharge shall determine, having due regard to the condition of the stores/ materials. The price allowed for credit to the contractor, however, shall be at the prevailing market rate not exceeding the amount charged to him, excluding the storage charge, if any. The decision of the Engineer-in-charge shall be final and conclusive. In the event of breach of the aforesaid condition, the contractor shall inadditiontothrowinghimselfopentoaccountforcontraventionofthetermsof thelicensesorpermitand/orforcriminalbreachoftrust,beliabletoAuthority for all advantages or profits resulting or which in the usual course would have resultedtohimbyreasonofsuchbreach.Providedthatthecontractorshallinno case be entitled to any compensation or damages on account of any delay in supply or non-supply thereof all or any such materials and stores provided further that the contractor shall be bound to execute the entire work if the materials are supplied by the Authority within the original scheduled time for completion of thereof or schedule time plus 6 months the work plus 50% whicheverismoreifthetimeofcompletionofworkexceeds12months,butifa partofthematerialsonlyhasbeensupplied within the aforesaid period, then the contractorshallbeboundtodosomuchoftheworkasmaybepossiblewiththe materials and stores supplied in the aforesaid period. For the completion of the restofthework, the contractors hall be entitled to such extension of time as may determined by the Engineer-in-charge whose decision in this regard shall be final and binding on the contractor.

The contractor shall see that only the required quantities of materials are got issued. Any such material remaining unused and in perfectly good / original condition at the time of completion or determination of the contract shall be returned to the Engineer-in-charge at the stores from which it was issued or at a place directed by him by a notice in writing. The contractor shall not be entitled for loading transporting, unloading and stacking of such unused material except for the extralead, if any involved, beyond the original place of issue.





## Materials to be provided by the contractor and Mandatory Tests

- 1. Thecontractorshall,athisownexpense,provideallmaterials,required for the works other than those which are stipulated to be supplied by the Authority.
- 2. The contractor shall, at his own expense and without delay; supply to the Engineer in- charge samples of materials to be used on the work and shall get these approved in advance. All such materials to be provided by the contractor shall be in conformity with the specifications laid down or referred to in the contract. The contractor shall, if requested by the Engineer-in-charge furnish proof, to the satisfaction of the Engineer-in-charge that the materials so comply. The Engineer-in-charge shall within thirty days of supply of samples or within such further period as he may require intimate to the Contractor in writing whether samples are approved by him or not. If samples are not approved, the Contractor shall forthwith arrange to supply to the Engineer-in charge for his approval, fresh samples complying with the specifications laid down in the contract. When materials are required to be tested in accordance with specifications, approval of the Engineer-in-charge shall be issued after the test results are received.
- 3. The contractor shall at his risk and cost submit the samples of materials to be tested or analyzed and shall not make use of or incorporate in the work anymaterialsrepresented by the sample suntil the required tests or analysis have been made and materials finally accepted by the Engineer-in-charge.
- 4. If any additional tests apart from mandatory tests specified in the contract are required to be carried out at the instance of AAI or any other advisory body, to ensure conformity of the item to the contract specifications, the cost of such tests shall be borne by AAI. In case the material / equipment fails in the above tests, the expenditure incurred by AAI on testing of such material or equipment along with incidental charges borne by AAI (if any) shall be recovered from the dues of the contractor and action shall betaken under Clause 16 and other relevant clauses of thecontract.
- 5. The contractor shall not be eligible for any claim or compensation either arising out of any delay in the work or due to any corrective measures requiredtobetakenonaccountofandasaresultoftestingofmaterials.
- 6. The contractor shall, at his risk and cost, make all arrangements and shall provide all facilities as the Engineer-in-charge may require for collecting and preparing the required number of samples for such tests at such time and to such place or places as may be directed by the Engineer-in-charge and bear all charges and cost of testing unless specifically provided for otherwise elsewhere in the contract or specifications. The Engineer-in-charge or his authorised representative shall at all times have access to the works and to all workshops and places where work is being prepared or from where materials manufactured, articles or machinery are being obtained for the works and the contractor shall afford every facility and every assistance in obtaining the right to suchaccess.

The Engineer-in-charge shall have full powers to require the removal from the premises of all materials which in his opinion are not in accordance with the specifications and in case of default, the Engineer-in-charge shall be at liberty to employ at the expense of the contractor, other persons to remove the same without being answerable or accountable for any loss or damagethatmayhappenorarisetosuchmaterials. Engineer-in-charge shall call books of account and other relevant documents from the contractor to satisfy himself about reasonability of increase in prices of materials and wages. The contractor shall, within a reasonable time of his becoming aware of any alteration in the price of any such materials and/ or wages of labour, give notice thereof to the Engineer-in-charge stating that the same is given pursuant to this condition together with all information relating thereto which he may be in position to supply.

For this purpose, the labour component of 85% of the value of the work executed during period under consideration shall not exceed the percentage as specified in Schedule F, and the increase / decrease in labour shall be considered on the minimum daily wages in rupees of any unskilled mazdoor, fixed under any law, statutory rule or order.

The contractor shall comply with the provisions of the contract and with the care and diligence execute and maintain the works and provide all labour and materials, tools and plants including for measurements and supervision of all works, structural plans and other things of temporary or permanent nature required for such execution and maintenance in sofar as the necessity for providing these, is specified or is reasonably inferred from the contract. The contractor shall take full responsibility for adequacy suitability and safety of all the works and methods of construction.

The contractors hall have no claim to any payment of compensation or otherwise what so ever, on account of any profit or advantage which he might have derived from the execution of the works in full but which he did not derive in consequence of the foreclosure of the whole or part of the works. The contractor shall be paid at contract rates, full amount for works executed at site and, in addition, a reasonable amount as certified by the Engineer-in-Charge for the items hereunder mentioned which could not be utilized on the work to the full extent in view of the foreclosure;

In addition, cost of transportingsuchmaterialsfromsitetoAAIstores,ifsorequiredbyAAI, shall bepaid.

The contractor shall, if required by the Engineer- in-Charge, furnish to him, books of account, wage books, time sheets and other relevant documents and evidence as may be necessary to enable him to certify the reasonable amount payable under this condition.

The reasonable amount of items on (i), (iv) and (v) above shall not be in excess of 2% of the cost of the work remaining incomplete on the date of closure, i.e. total stipulated cost of the work as per accepted tender less the cost of work actuallyexecutedunderthecontractandlessthecostofcontractor'smaterialsat site taken over by the AAI as per item (ii) above. Provided always that against any payments due to the contractor on this account or otherwise, the Engineer- in-Charge shall be entitled to recover or be credited with any outstanding balances due from the contractor for advance paid in respect of any tool, plants and materials and any other sums which at the date of termination were recoverable by the AAI from the contractor under the terms of the contract.

In the event of action being taken under clause 13 to reduce the scope of work, the contractormay furnish fresh Performance Guarantee on the same conditions, in the same manner and at the same rate for the balance tendered amount and initially valid upto the extended date the completion or stipulated date of completion if no extension has been granted plus 180 days beyond that. Wherever, such a fresh Performance Guarantee is furnished by the contractor, the Engineer in Chargemay return the previous Performance Guarantee.

- iii. Fails to complete the work(s) or items of work with individual dates of completion, on or before the date(s) so determined, and does not complete them within the period specified in the notice given in writing in that behalf by the Engineer-in-Charge.
- b. TheEngineer-in-Chargewithoutinvokingactionunderclause3may,without prejudicetoanyotherrightorremedyagainstthecontractorwhichhaveeither accrued or accrue thereafter to AAI, by a notice in writing to take the part work / part incomplete work of any item(s) out of his hands and shall have powersto:
  - Takepossessionofthesiteandanymaterials, constructional plant, implements, stores, etc., thereon; and/or
  - ii. Carryoutthepartwork/partincompleteworkofanyitem(s)byany means at the risk and cost of thecontractor.



- c. The Engineer-in-Charge shall determine the amount, if any, is recoverable from the contractor for completion of the part work/ part incomplete work of any item(s) taken out of his hands and executed at the risk and cost of the contractor, the liability of contractor on account of loss or damage suffered by AAI because of action under this clause shall not exceed 10% of the tendered value of the work.
- d. In determining the amount, credit shall be given to the contractor with the valueofworkdoneinallrespectinthesamemannerandatthesamerateasif it had been carried out by the original contractor under the terms of his contract, the value of contractor's material staken over and incorporated in the work and use of plant and machinery belonging to the contractor. The certificate of the Engineer-in-Charge as to the value of work done shall be final and conclusive against the contractor provided always that action under this clause shall only be taken after giving notice in writing to the contractor. Provided also that if the expenses incurred by the department are less than the amount payable to the contractor at his agreement rates, the difference shall not be payable to the contractor.
- e. Any excess expenditure incurred or to be incurred by AAI in completing the part work/ part incomplete work of any item(s) or the excess loss of damages suffered or may be suffered by AAI as aforesaid after allowing such credit shallwithoutprejudicetoanyotherrightorremedyavailabletoAAIinlawor per as agreement be recovered from any money due to the contractor on any account, and if such money is insufficient, the contractor shall be called upon inwritingandshallbeliabletopay thesamewithin30days.
- f. Ifthecontractorfailstopaytherequiredsumwithintheaforesaidperiodof30 days, the Engineer-in-Charge shall have the right to sell any or all of the contractors' unused materials, constructional plant, implements, temporary building at site etc. and adjust the proceeds of sale thereof towards the dues recoverable from the contractor under the contract and if thereafter there remains any balance outstanding, it shall be recovered in accordance with the provisions of the contract/provisions of law.

In the event of above course being adopted by the Engineer-in-Charge, the contractor shall have no claim to compensation for any loss sustained by him by reason of his having purchased or procured any materials or entered into any engagementsormadeanyadvanceonanyaccountorwithaviewtothe execution of the work or the performance of the contract.

# Suspension of Work

- i. The contractor shall, on receipt of the order in writing of the Engineer-in-Charge, (whose decision shall be final and binding on the contractor) suspend theprogressoftheworksoranypartthereofforsuchtimeandinsuchmanner as the Engineer-in- Charge may consider necessary so as not to cause any damage or injury to the work already done or endanger the safety thereof for any of the following easons:
  - a. on account of any default on the part of the contractoror;
  - b. forproperexecution of the works or part thereof for reasons other than the default of the contractor; or

The contractor shall, during such suspension, properly protect and secure the workstotheextentnecessaryandcarryouttheinstructionsgiveninthatbehalf by the Engineer-in-Charge.



# ii. If the suspension is ordered for reasons (b) and (c) in sub-para (i) above (but not attributed to contractor):

- a. the contractor shall be entitled to an extension of time equal to the period of every such suspension PLUS 25% for completion of the item or group of items of work for which a separate period of completion is specified in the contract and of which the suspended work forms apart, and;
- b. If the total period of all such suspensions in respect of an item or groupof itemsorworkforwhichaseparateperiodofcompletionisspecifiedinthe contractexceedsthirtydays,thecontractorshall,inaddition,beentitledto such compensation as the Engineer-in-Charge may consider reasonablein respect of salaries and/or wages paid by the contractor to his employees and labour at site, remaining idle during the period of suspension, adding thereto 2% to cover indirect expenses of the contractor provided the contractor submits his claim supported by details to the Engineer-in-Chargewithinfifteendaysoftheexpiryoftheperiodof30days.
- c. If the works or part thereof is suspended on the orders of the Engineer-in-Charge for more than three months at a time, except when suspension is ordered for reasons (a) in sub-para (i) above, the contractor may after receipt of such order serve a written notice on the Engineer-in-Charge requiring permission within fifteen days from receipt by the Engineer-incharge of the said notice, to proceed with the work or part thereof in regard to which progress has been suspended and if such permission is notgranted within that time, the contractor, if he intends to treat the suspension, where it affects only a part of the works as on omission of such part by AAI or where it affects whole of the works, as an abandonmentoftheworksby AAI, shall withinten days of expiry of such period of 15 days give notice in writing of his intention to the Engineer- in-Charge. In the event of the contractor treating the suspension as an abandonment of the contract by AAI, he shall have no claim to payment of any compensations on account of any profit or advantage which he might have derived from the execution of the work in full but which he could not derive in consequence of the abandonment. He shall, however, beentitledtosuchcompensation,astheEngineer-in-Chargemayconsider reasonable, in respect of salaries and/or wages paid by him to his employees and labour at site, remaining idle in consequence adding to the total thereof 2% to cover indirect expenses of the contractor provided the contractor submits his claim supported by details to the Engineer-in-Chargewithin 30 days of the expiry of the period of 3 months.

The contractor shall not be entitled to claim any compensation from AAI for the losses suffered by him on account of delay by AAI in the supply of materials in Schedule 'B' where such delay is covered by the difficulties relating to supply of wagons, forcemajeure or any reasonable cause beyond the control of AAI.

This clause 15 A will not be applicable for works where no material is stipulated for issue by AAI.

Decision of the Engineer-in-Charge to be conveyed in writing in respect of the same will be final and binding on the contractor.

Provided that in the case of road work, if in the opinion of the Engineer-in-charge, half of the security deposit is sufficient, to meet all liabilities of the contractor under this contract, half of the security deposit will be refundable after six months and the remaining half after twelve months of the issue of the said certificate of completion or till the final bill has been prepared and passed whichever islater.

In case of Maintenance and Operation works of E&M services, the security deposit deducted from contractors shall be refunded within one month from the dateoffinal paymentor within one month from the dateoff on the maintenance contract whichever is earlier.

The contractor shall also supply without charge the requisite number of persons with the means and materials, necessary for the purpose of setting out works, and counting, weighing and assisting the measurement for examination at any time and from time to time of the work or materials. Failing his so doing, the same may be provided by the Engineer-in-charge at the expense of the contractor and the expenses may be deducted, from any money due to the contractor, under this contract or otherwise and / or from his security deposit or the proceeds of sale thereof, or of a sufficient portions thereof.

- 3. Conditions for the grant of MaternityLeave: Nomaternityleavebenefitshallbeadmissibletoawomanunlessshehasbeen employed for a total period of not less than six months immediatelypreceding the date on which she proceeds onleave.
- 4. The contractor shall maintain a register of Maternity (Benefit) in the Prescribed Form as shown in appendix III and IV, and the same shall be kept at the place of work.

(s) requiring that the said Rules be complied with and the amenities prescribed thereinbeprovided to the work-people within areason able time to be specified in notice. If the contractor (s) shall fail within the period specified in the notice to comply with and/ observe the said Rules and to provide the amenities to the work-peopleasaforesaid, the Engineer-in-Chargeshall have the power to provide the amenities hereinbefore mentioned at the cost of the contractor (s). Except where otherwise provided in the contract, all questions and disputes relating to the meaning of the specifications, design, drawings and instruction here-in before mentioned and as to the quality of workmanship or materials used ontheworkorastoanyotherquestion, claim, right, matterorthing what so ever, in any way arising out of or relating to the contract, designs, drawings, specifications, estimates, instructions, orders or these conditions or otherwise concerning the work or the execution or failure to execute the same whether arising during the of the work or after the cancellation, termination. progress completionorabandonmentthereofshallbedealtwithasmentionedhereinafter:

i. If the contractor considers any work demanded of him to be outside the requirement of the contract, or disputes any drawing, record or decisiongiven in writing by the Engineer-in-Charge or if the Engineer in Charge considers any act or decision of the contractor on any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable and is disputed such party shall promptly within 15 days of the arising of the disputes request the Executive Director (Engg.)/Regional Executive Director/Member (Plg) /Chairman, AAI as the case may be, who shall refer the dispute to Dispute Redressal Committee (DRC) within 15 days alongwith alistofdisputeswithamountsclaimedifany, inrespectofeach such disputes. Dispute Redressal Committee (DRC) shall give the opposing party two weeks for written response, and give its decision within a period of 60 days extendable by 30 days by consent of both the parties from the receipt of reference from the Executive Director (Engg.)/Regional Executive Director/Member (Plg) /Chairman, AAI. Provided that no party shall be represented before the Dispute Redressal Committee by an advocate / legal counsel etc.

If the Dispute Redressal Committee (DRC) fails to give its decision within aforesaid period or any party is dis-satisfied with the decision of Dispute Redressal Committee (DRC) or expiry of time limit given above, then either party may within a period of 30 days from the receipt of the decision of Dispute Redressal Committee (DRC), give notice to the Executive Director (Engg.)/Regional Executive Director/Member (Plg) /Chairman, AAI as the case may be for appointment of Arbitrator on prescribed proforma as per Appendix-XVII. under intimation to the other party.

- i. The contractor shall not employ coal mining or controlled area labour falling under any category whatsoever or in connection with the work or recruit labour from area within a radius of 32 km (20 miles) of the controlled area. Subject as above the contractor shall employ imported labour only i.e., deposit imported labour or labour imported by contractors from area, from which import is permitted.
- ii. Where ceiling price for imported labour has been fixed by State or Regional Labour Committees not more than that ceiling price shall be paid to the labour by the contractor.
- iii. The contractors hall immediately remove any labourer who may be pointed



out by the Engineer-in-Charge as being a coal mining or controlled area labourer. Failure to do so shall render the contractor liable to pay to AAI a sum calculated at the rate of Rs.10/- per day per labourer. The certificate of the Engineer-in -Charge about the number of coal mining or controlled area labourer and the number of days for which they worked shall be final and binding upon all parties to this contract.

The price allowed to the contractor however shall not exceed the amount charged to him excluding the elementofstoragecharges. The decision of the Engineer-in-Chargeshall befinal conclusive. In the event of breach of the aforesaid condition, the contractor shallinadditiontothrowinghimselfopentoactionforcontraventionoftheterms of the license or permit and / or for criminal breach of trust, be liable to AAI for allmoneys, advantages or profits resulting or which in the usual course would have resulted to him by reason of such breach.

TheContractorshallarrangeathisownexpensealltools,plant,machineryand equipment(hereinafter referred to as T&P) required for execution of the work except for the Plant & Machinery listed in Schedule 'C' and stipulated for issuetothecontractor.IfthecontractorrequiresanyitemofT&Ponhirefrom the T&P available with the AAI over and above the T&P stipulated for issue, the AAI will, if such item is available, hire it to the contractor at rates to be agreed upon between him and the Engineer-in-charge. In such a case, all the conditions hereunder for issue of T & P shall also be applicable to such T&P as is agreed to beissued.
- ii. Plant&MachinerywhensuppliedonhirechargesshowninSchedule'C'shall bemadeoverandtakenbackatthedepartmentalequipmentyard/shedshown in Schedule 'C' and the contractor shall bear the cost of carriage from the placeofissuetothesiteofworkandback. The contractorshall beresponsible to return the plant and machinery with condition in which it was handed over to him, and he shall be responsible for all damage caused to the said plant and machinery at the site of work or elsewhere in operation and otherwise during transit including damage to or loss of plant and for all losses due to his failure to return the same soon after the completion of the work for which it was issued. The Engineer-in-charge shall be the sole judge to determine the liability of the contractor and its extent in this regard and his decision shall be final and binding on the contractor.



- iii. The plant and machinery as stipulated above will be issued as and when available and if required by the contractor. The contractor shall arrange his programme of work according to the availability of the plant and machinery andnoclaim, whatsoever, will be entertained from him for any delay in supply by the department.
- iv. The hire charges shall be recovered at the prescribed rates from and inclusive ofthedatetheplantandmachinerymadeoveruptoandinclusiveofthedateof return in good order even though the same may not have been working for any cause except major breakdown due to no fault of the contractor or faulty use requiring more than three working days continuously (excluding intervening holidays and Sundays) for bringing the plant in order. The contractor shall immediately intimate in writing to the Engineer-in-charge when any plant or machinery gets out of order requiring major repairs as aforesaid. The Engineer-in- charge shall record the date and time of receipt of such intimation in the log sheet of the plant or machinery. Based on this if the breakdown before lunch period or major breakdown will be computed consideringhalfaday'sbreakdownonthedayofcomplaint.Ifthebreakdown occurs in the post lunch period of major breakdown will be computed starting from the next working day. In case of any dispute under this clause, the decision of the Executive Director (Engg) /General Manager (Engg) shall be final and binding on the contractor.
- v. Thehirechargesshownaboveareforeachdayof8hours(inclusiveoftheone hour lunch break) or partthereof.
- vi. Hirechargeswillincludeserviceofoperatingstaffasrequiredandalsosupply of lubricating oil and stores for cleaning purposes. Power fuel of approved type, firewood, kerosene oil etc. for running the plant and machinery and also the full time chowkidar for guarding the plant and machinery against any loss or damage shall be arranged by the contractor who shall be fully responsible for the safeguard and security of plant and machinery. The contractor shall on or before the supply of plant and machinery sign an agreement indemnifying the Department against any loss or damage caused to the plant and machinery either during transit or at site ofwork.
- vii. Ordinarily, no plant and machinery shall work for more than 8 hours a day inclusive of one hour lunch break. In case of an urgent work however, the Engineer-incharge may, at his discretion, allow the plant and machinery to be worked for more than normal period of 8 hours a day. In that case, the hourly hire charges for overtime to be borne by the contractor shall be 50% more than the normal proportionate hourly charges (1/8th of the daily charges) subject to a minimum of half day's normal charges on any particular day. For working out hire charges for over time, a period of half an hour and above will be charged as one hour and a period of less than half an hour will beignored.
- viii. The contractor shall release the plant and machinery every seventh day for periodical servicing and / or wash out which may take about three to four hours or more. Hire charges for full day shall be recovered from the contractor for the day of servicing / wash out irrespective of the period employed inservicing.
- ix. The plant and machinery once issued to the contractor shall not be returned by him on account of lack of arrangements of labour and materials, etc. on his part, the same will be returned only when they are required for major repairs or when in the opinion of the Engineer-in-charge, the work or a portion of work for which the same was issued iscompleted.
- x. LogBookforrecordingthehoursofdailyworkforeachoftheplantand machinerysuppliedtothecontractorwillbemaintainedbytheDepartment andwillbecountersignedbythecontractororhisauthorisedagentdaily.In



- casethecontractorconteststhecorrectnessoftheentriesand/orfailstosign the Log Book, the decision of the Engineer-in-charge shall be final and binding on him. Hire charges will be calculated according to the entries in theLogBookandwillbebindingonthecontractor.Recoveryonaccountof hire charges for road rollers shall be made for the minimum number of days worked out on the assumption that a roller can consolidate per day and maximumquantityofmaterialsorareasurfacingasnotedagainsteachinthe annexed statement (see attachedannexure).
- xi. Inthecaseofconcretemixers,thecontractorsshallarrangetogetthehopper cleaned and the drum washed at the close of the work each day or each occasion.(a)Incaserollersforconsolidationareemployedbythecontractor himself, log book for such rollers shall be maintained in the same manneras isdoneincaseofdepartmentalrollers,maximumquantityofanyitemstobe consolidatedforeachroller-dayshallalsobesameasinAnnexuretoClause 34(x). For less use of rollers, recovery for the less roller days shall be made at the stipulated issuerate.
- xii. The contractor shall be responsible to return the plant and machinery in the conditionin which it was handed overtohim and he shall be responsible for all damage caused to the said plant and machinery at the site of work or elsewhere in operation or otherwise or during transit including damage to or loss of parts, and for all losses due to his failure to return the same soon after the completion of the work for which it was issued. The Engineer-in-charge shall be the sole judge to determine the liability of the contractor and its extent in this regard and his decision shall be final and binding on the contractor.
- xiii. The contractor will be exempted from levy of any hire charges for the number of days he is called upon in writing by the Engineer-in-charge to suspend execution of the work, provided AAI's plant and machinery in question have, in fact, remained idle with the contractor because of the suspension.
- xiv. In the event of the contractor not requiring any item of plant and machinery issued by AAI though not stipulated for issue in Schedule 'C' any time after taking delivery at the place of issue, he may return it after two days written notice or at any time without notice if he agrees to pay hire charges for two additionaldayswithout,inanyway,affectingtherightoftheEngineer-incharge to use the said plant and machinery during the said period of two days as he likes including hiring out to a third party.

# Condition relating to use of asphaltic materials

- i. The contractor undertakes to make arrangement for the supervision of the work by the firm supplying the tar or bitumenused.
- i. The contractor shall collect the total quantity of tar or bitumen required for the work as per standard formula, before the process of painting is started and shall hypothecate it to the Engineer-in-Charge. If any bitumen or tar remains unused on completion of the work on account of lesser use of materials in actual execution of for reasons other than authorised changes of specifications and abandonment of portion of work, a corresponding deduction equivalent to the cost of unused materials as determined by the Engineer-in-Charge shall be made and the material return to the contractors. Although the materials are hypothecated to AAI, the contractor undertakes the responsibility for their proper watch, safe custody and protection against all risks. The materials shall not be removed from site of work without the consent of the Engineer-in-Charge inwriting.



iii. The contractor shall be responsible for rectifying defects noticed within a year from the date of completion of the work and the portion of the security deposit relating asphaltic work shall be refunded after the expiry of this period.

Contractors Superintendence, Supervision, Technical staff & Employees i.The contractor shall provide all necessary superintendence during execution of theworkandallalongthereafterasmaybenecessaryforproperfulfillingof the obligations under the contract.

The Contractor shall immediately after receiving letter of acceptance of the tender and before commencement of the work, intimate in writing to the Engineer-in-Charge, thename(s), qualifications experience, age, address(s) and other particulars along with certificates, of the principal technical representativetobechargeoftheworkandothertechnicalrepresentative(s) who will be supervising the work. Minimum requirement of such technical representative (s) and their qualifications and experience shall not be lower than specified in schedule 'F". The Engineer-in-Charge shall within 3 days of receipt of such communication intimate in writing his approval or otherwise of such a representative (s) to the contractor. Any such approval mayatanytimebewithdrawnandincaseofsuchwithdrawal,thecontractor shall appoint another such representative (s) according to the provisions of this clause. Decision of the tender accepting authority shall be final and binding on the contractor in this respect. Such a principal technical representativeandothertechnicalrepresentative(s)shallbeappointedbythe contractor soon after receipt of the approval from Engineer-in-charge and shall be available at site before start ofwork.

All the provisions applicable to the principal technical representative under the clause will also be applicable to other technical representative(s). The principal technical representative and other technical representative (s) shall be present at the site of work for supervision at all times when any construction activity is in progress and also present himself/themselves, as required to the Engineer-in-Charge and / or his designated representative to take instructions. Instructions given to the principal technical representative or other technical representative (s) shall be deemed to have the same force as if these have been given to the contractor. The Principal Technical Representative and other technical representatives shall be actually available atsitefullyduringallstagesofexecutionwork,duringrecording/checking / test checking of measurements of works whenever so required by the Engineer-in-Charge and shall also note down instructions conveyed by the Engineer-in-Chargeorhisdesignatedrepresentative(s)inthesiteorderbook and shall affix his/their signature in token of noting down the instructions and in token of acceptance of measurements / checked measurements / test checked measurements. The representative (s) shall not look after any other work. Substitutes, duly approved by engineer - in-Charge of the work in similar manner as aforesaid shall be provided in event of absence of any of the representative (s) by more than two days. If the Engineer-in-Charge, whose decision in this respect is final and binding on the contractor, is convinced that no such technical representative (s) is/are effectively appointed or is/are effectively attending or fulfilling the provision of this clause, a recovery (non-refundable) shall be effected from the contractoras



specified in Schedule 'F' and the decision of the Engineer-in- Charge as recorded in the site order book and measurement recorded checked/test checked in Measurement Books shall be final and binding on the contractor. FurtherifthecontractorfailstoappointsuitabletechnicalPrincipaltechnical representative and / or other technical representative (s) and if such appointedpersonsarenoteffectively presentorareabsentbymorethantwo days without duly approved substitute or do not discharge their responsibility satisfactorily, the Engineer-in-Charge shall have full powers to suspend the execution of the work until such date as suitable technical representative(s) is/are appointed and the contractor shall be held responsible for the delay so caused to the work. The contractor shall submit acertificateofemploymentofthetechnicalrepresentative(s)(intheformof copy of Form- 16 or CPF deduction issued to the Engineer employed by him) along with every running account bill / final bill and shall produce evidenceifatanytimessorequiredbytheEngineer-in-Charge.

- ii. The contractor shall provide and employ on the site only such technical assistants as are skilled, and experienced in their respective fields and such foremenandsupervisorystaffasarecompetenttogivepropersupervisionto the work. The contractor shall provide and employ skilled, semi-skilled and unskilledlabourasisnecessaryforproperandtimelyexecutionofthework. The Engineer-in-Charge shall be at liberty to object to and require the contractor to remove from the works any person who in his opinion misconducts himself, or is incompetent or negligent in the performance of his duties or whose employment is otherwise considered by the Engineer-in Charge to be undesirable. Such person shall not be employed again atworks site without the written permission of the Engineer-in-Charge and the persons so removed shall be replaced as soon as possible by competent substitutes.
- iii. The contractor shall not change his engineer/supervisory staff afterapproval of the Engineer-In-Charge. If Contractor wants to replace any of his staff due to unavoidable circumstances, he will seek permission of Engineer-In-Charge indicating reasons for such change, qualification and experience of thealternativeemployeesuggestedbyhim. Thequalification and experience of the alternative staff shall not be inferior to the person employed earlier.

#### **CLAUSE 37**

# Levy/Taxes/ Royalty/Land License fee payableby Contractor

#### 1. Taxes:

- a. Rates to be quoted by the parties should be inclusive of all taxes, duties, CESS, fee, royalty charges etc. levied under any statute but exclusive of GST for all theitems

The contractor shall deposit royalty and obtain necessary permit for collectionofstone,sand,redbajri,kankaretc.fromthelocalauthorityin the matter and will abide by the notification issued by Central Govt. / State Government / Local State Authorities as applicable from time to time in this regard. The contractor is also bound to allow deductionfrom hisbillsanydifferenceinstatutorytaxes/royaltyandpenaltyproposedby Local State Authorities to AAI till finalization of settlement of all demands in this regard by Central / StateGovt.
- b. This will also be applicable to forest produce.
- c. If pursuant to or under any law, notification or order any royalty, cess or the like becomes payable by the AAI and does not any time become payable by the contractor to the State Government. Local authorities in respectofanymaterialusedbythecontractorintheworkstheninsucha case, it shall be lawful to the AAI and it will have the right and be entitled to recover the amount paid in the circumstances as aforesaid from dues of thecontractor.

#### 3. License fee forland

- a. The contractor shall be liable to pay license fee for the land allotted by AAI for installation of plants, labour camp, cement godown and site office at AAI prevailing rates of license fee for unpaved land at the time of call oftender.
- b. In addition a security deposit at the rate of Rs 500/- per sqm in the form of DD/BG shall also be deposited by the contractor. In case contractor do not deposit security deposit same shall be deducted from Ist Running AccountBill.
- Such security deposit shall be released only after allotted land has been fully vacated by the contractor to entire satisfaction of Engineer-in-Charge.

# Integrity Pact and Independent External Monitor.

Signing of Integrity Pact (As per Appendix XVIII) is mandatory for every bidder/contractor if provided so in Schedule F.

All tenderers shall have to submit an undertaking as per Appendix XVIII along with tender documents. AAI shall appoint Independent External Monitor(s) to oversee effective implementation of Integrity Pact for such works/supplies. For thispurpose,apanelofIndependentExternalMonitorsshallbeconstitutedbythe Authority in concurrence with Central Vigilance Commission(CVC).

- i. The Contractor/Supplier shall have to act in accordance with the conditions laid down in the integrity pact.
  - a. Signing of Integrity Pact is mandatory for every Bidder/Contractor in this procurement/bid process the signed original pact to be send to the office of Bid Manager and should reach before the due date mentioned in NIT.
    - b. The Bidder/contractor shall commit itself to ensure taking all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage as specified in section 3 of the integrity pact.
  - c. Any breach of the aforesaid provisions by the Bidder or any one employed by it or acting on its behalf (whether with or without the knowledge of the Bidder) shall entitle the authority to take all or any one of the action as specified in section 6 of the integrity pact.
- ii. In case any violation of above conduct is established, AAI reserves right to take following actions.

In case any item is executed for which standard co-efficient for the consumption of cement or bitumen are not available in the above mentioned schedule / statement or cannot be derived from the same shall be calculated on the basisofstandardformulatobelaiddownbytheEngineer-in-Charge.
  - b. Theoretical quantity of steel reinforcement or structural steel sections shall be taken as the quantity required as per design or as authorised by Engineer-in- Charge, including authorisedlappages, chairs etc. plus 3% wastage due to cutting into pieces, such theoretical quantity being determined and compared with the actual issues each diameter-wise, section wise and category wiseseparately.
  - c. Theoretical quantity of G.I. & C.I. or other pipes, conduits, wires and cables pig lead and G.I. / M.S. sheets shall be taken as quantity actually required and measures plus 5% for wastage due to cutting into pieces (except in the case of G.I./M.S. sheets it shall be 10%), such determination & comparison being made diameter-wise & categorywise.
  - d. For any other material as per actualrequirements.
- ii. Over the theoretical quantities of materials so computed a variation shall be allowed as specified in Schedule 'F'. The difference in the net quantities of material actually issued to the contractor and the theoretical quantities includingsuchauthorisedvariation, if not returned by the contractor or if not fully reconciled to the satisfaction of the Engineer-in-Charge within fifteen days of the issue of written notice by the Engineer-in-Charge to this effect shall be recovered at the rates specified in Schedule 'F', without prejudice to the provision of the relevant conditions regarding return of materials governing the contract. Decision of Engineer-in-Charge in regard to theoretical quantities of materials, which should have been actually used as per the Annexure of the standard schedule of rates and recovery at rates specified in Schedule 'F' shall be final and binding on the contractor. For non scheduled items, the decision of the Engineer in charge regarding theoretical quantities of materials which should have been actually used, shall be final and binding on the contractor.
- g. The said action under this clause is without prejudice to the right of the AAI to take action against the contractor under any other conditions of contract fornotdoingtheworkaccordingtotheprescribedspecifications.
- h. For materials brought by the contractor for use in item of work at site, similar theoretical consumption shall be prepared and submitted to the Engineer-in-Charge for verification. If it is found that material consumed in theworkislessthanthetheoreticalconsumptionaftertakingintoaccount permissibleminusvariation, therecovery for corresponding material shall be effected as per rates specified in schedule 'F' under Clause 42.



## Compensation during warlike situations / act of terrorism

The work (whether fully constructed or not) and all materials, machines, tools and plants scaffolding, temporary buildings and other things connected therewith shall be at the risk of the contractor until the work has been delivered to the Engineer-in-Chargeandacertificatefromhimtothateffectobtained.Intheevent of the work or any materials properly brought to the site for incorporation in the work being damaged or destroyed in consequence of hostilities or warlike operation or act of terrorism, the contractor shall when ordered (in writing) by the Engineer-in-Charge to remove any debris from the site, collect and properly stack or remove in store all serviceable materials salvaged from the damaged work and shall be paid at the contract rates in accordance with the provision of this agreement for the work of clearing the site of debris, stacking or removal of serviceable material and for reconstruction of all works ordered by the Engineerin-Charge, such payments being in addition to compensation upto the value of the work original executed before being damaged or destroyed and not paid for.  $In case of works damaged or destroyed but not already measured and paid for, the {\it the transfer of the tran$ compensation shall be assessed by the Engineer-in charge upto Rs.5,000/- and by the Executive Director Engg. concerned for a higher amount. The contractor shall be paid for the damages / destruction suffered and for restoring the material at the rate based on analysis of rates tendered for in accordance with the provision of the contract. The certificate of the Engineer-in- Charge regarding the quality and quantity of materials and the purpose for which they were collected shall be final and binding on all parties to this contract.

Provided always that no compensation shall be payable for any loss in consequence of hostilities or warlike operation (a) unless the contractor had taken all such precautions against air raid as are deemed necessary by the A.R.P. Officers or the Engineer-in- Charge (b) for any material etc. not on the site of the work or for any tools plant, machinery, scaffolding, temporary building and other things not intended for the work.

In the event of the contractor having to carry out reconstruction as aforesaid, he shall be allowed such extension of time for its completion as is considered reasonable by the Engineer – in - charge.

The contractor shall comply with the provisions of the Apprentices Act, 1961 and the rules and orders issued thereunder from time to time. If he fails to do so, his failurewillbeabreachofthecontractandtheExecutiveDirectorEngg./General Manager (Engg.) may, in his discretion, cancel the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation by him of the provisions of the said Act.

# Release of security deposit after labour clearance

Security Deposit of the work shall not be refunded till the contractor produces a clearance certificate from the Labour Officer. As soon as the work is virtually complete the contractor shall apply for the clearance certificate to the Labour Officer under intimation to the Engineer-in-Charge. The Engineer-in-Charge, on receipt of the said communication, shall write to the Labour Officer to intimate if any complaint is pending against the contractor in respect of the work. If no complaint is pending, on record till after 3 months after completion of the work and / or no communication is received from the Labour Officer to this effect till six months after the date of completion, it will be deemed to have received the clearance certificate and the Security Deposit will be released if otherwise due.



# Contractor's Liability and Insurance of Works

- i. From commencement to completion of the Works, the Contractor shall take full responsibility for the case thereof and for taking precautions to prevent loss or damage and to minimize loss or damage to the greatest extent possible and shall be liable for any damage or loss that may happen to the Works or any part thereof and all AA l's T & P from any cause whatsoever (save and except the Excepted Risks) and shall at his own cost repair and make good the same so that at completion, the Works and all AAI's T & P shall be in good order and condition and in conformity in every respect with therequirementsoftheContractandinstructionsoftheEngineer-in-Charge.
- ii. IntheeventofanylossordamagetotheWorksoranyPartthereofortoany T & P, to any material or articles at the Site from any of the Excepted Risks the following provisions shall haveeffect:
  - a. The Contractor shall, as may be directed in writing by the Engineer-in-Charge, remove from the Site any debris and so much of the works as shall have been damaged, taking to AAI's store such AAI's T & P, articles and/or materials as may bedirected;
  - The contractor shall, as may be directed in writing by the Engineer-in-Charge, proceed with the erection and completion of the Works under and in accordance with the provisions and Conditions of the Contract;

- iii. Provided always that the Contractor shall not be entitled to payment under the above provisions in respect of so much loss or damage as has been occasioned by any failure on his part to perform his obligation under the Contractornottakingprecautionstopreventlossordamageorminimizethe amount of such loss ordamage.
- iv. Without limiting its obligations and responsibilities under other clauses of General Conditions of Contracts, the contractor at his own cost shallinsure, in the joint name of AAI and the contractor, against all losses or damages from whatever cause, arising (other than the accepted risks) for which he is responsible under the terms of the contract and in such manner that the AAI and the contractor are covered during the period of construction of works and any loss or damage occasioned by the contractor in the course of any operation carried out by them for the purpose of complying with its obligations of defects liability clause hereof;
  - a. All works including temporary works to their full value executed from time totime.
  - b. The construction materials and equipments to their full value brought on the site by the contractor.
- v. The Contractor shall indemnify and keep indemnified AAI against alllosses and claims for injuries or damage to any persons or any property what so ever which may arise out of or in consequence of the construction and maintenance of Works and against all claims, demands proceedings, damage costs, charges and expenses what so ever in respect of or in relation thereto.
- vi. Before commencing execution of the work, the Contractor shall, without in any way limiting his obligations and responsibilities under this condition, insureathisowncostagainstanydamage,lossorinjurywhichmayoccurto any AAI property, or to any person for at least the minimum amount of Rs. 1.00 lakh with unlimited number of occurrences (including any employeeofAAI)byorarisingoutofcarryingoutoftheContract.
- vii. The contractor shall at all times indemnify AAI against all claims, damages or compensation under the provisions of Payment or Wages Act,1936,



Minimum Wages Act, 1948, Employer's Liability Act, 1938, the Workmen's Compensation Act, 1923, Industrial Disputes Act, 1947 and the Maternity Benefit Act, 1961 or any modifications thereof or any other law relating thereto and rules made there under from time to time or as a consequenceofanyaccidentorinjurytoanyworkmanorotherpersonsinor about the Works, whether in the employment of the Contractor or not, his agents or servants, and also against all costs, charges and expenses of any suit, action or proceedings arising out of such accident or injury and against all sum or sums which may with the consent of the Contractor be paid to compromise or compound any claim. Without limiting his obligations and liabilities as above provided, the Contractor shall insure against all claims, damagesorcompensationpayableundertheWorkmen'sCompensationAct, 1923oranymodificationthereoforanyotherlawrelatingthereto.

- viii. All insurance mentioned above shall be effected with any subsidiary of the General Insurance Company of India or by a company approved by the Insurance Regulatory Authority of India.
- ix. The aforesaid insurance policy / policies shall provide that they shall not be cancelled till the Engineer-in-Charge has agreed to their cancellation in writing.
- x. The Contractor shall prove to the Engineer-in-Charge from time to time that he has taken out all the insurance policies referred to above and has paid the necessary premiums for keeping the policies alive till expiry of the Defects Liability Period. A self-certified copy of such policies is required to be submitted to the Engineer-in-charge.
- xi. The Contractor shall ensure that similar insurance policies are taken out by his subcontractors (if any) and shall be responsible for any claims or losses toAAIresultingfromtheirfailuretoobtainadequateinsuranceprotectionin connection thereof. The contractor shall produce or cause to be produced by his subcontractor (if any) as the case may be, the relevant policy or policies and premiums receipts as and when required by the Engineer-in-Charge. A self-certified copy of such policies is required to be submitted to the Engineer-in-charge.
- xii. If the Contractor and/or his subcontractor (if any) shall fail to effect and keep in force the insurance referred to above or any other insurance which he/they may be required to effect under the terms of the Contract then and in any such case AAI may, without being bound to, effect and keep in force any such insurance and pay such premium or premius as may be necessary for that purpose and from time to time deduct the amount so paid by AAI from any moneys due or which may be come due to the Contractor or recover the same as a debt due from the Contractor.
- xiii. In case contractor takes Contractor All Risk (CAR) Policy in joint name of AAI and Contractor for full tendered value along with third party liability (max of 10% of tendered value or as applicable as per Insurance Regulatory Authority of India) then there is no requirement fortaking separate insurance by sub-contractors.

However, workmen compensation policy is required to be taken separately by main contractor and sub-contractor for workers employed by them.

# **SAFETY CODE**

- 1. Suitable Scaffolds should be provided for workmen for all works that cannot safely be done from the ground, or from solid construction except such short period work as can be done safelyfromladders. Whenaladderisused, an extramazdoorshall been gaged for holding the ladder and if the ladder is used for carrying materials as well suitable footholds and hand-hold shall be provided on the ladder and the ladder shall be given an inclination not steeper than 1/4 to 1 (1/4 horizontal and 1 vertical).
- 2. Scaffolding of staging more than 3.6m (12ft.) above the ground or floor, swung orsuspended from an overhead support or erected with stationary support shall have a guard rail properly attached or bolted, braced and otherwise secured at least 90 cm. (3ft.) high above the floor or platform of such scaffolding on staging and extending along the entire length of the outside and ends thereof with only such opening as may be necessary for the delivery of materials. Such scaffolding or staging shall be so fastened as to prevent it from swaying from the building orstructure.
- 3. Workingplatforms,gangwaysandstairwaysshouldbesoconstructedthattheyshouldnotsag unduly or unequally, and if the height of the platform or the gangway or the stairway is more than 3.6 m (12ft.) above ground level or floor level, they should be closely boarded, should haveadequatewidthandshouldbesuitablyfastenedasdescribedin(2)above.
- 4. Every opening in the floor of a building or in a working platform shall be provided with suitable means to prevent the fall of person or materials by providing suitable fencing or railing whose minimum height shall be 90cm.(3ft.)
- 5. Safe means of access shall be provided to all working platforms and other working places. Every ladder shall be securely fixed. No portable single ladder shall be over 9m. (30ft.) in length while the width between side rails in rung ladder shall in no case be less than 29 cm. (11 ½ ") for ladder upto and including 3m. (10ft.) in length. For long ladders, this width should be increased at least ¼" for each additional 30cm. (1 foot) of length. Uniform step spacing of not more than 30cm shall be kept. Adequate precautions shall be taken to prevent danger from electrical equipment. No materials on any of the site or work shall be so stacked or placed as to cause danger or inconvenience to any person or the public. The contractor shall provide all necessary fencing and lights to protect the public from accident and shall be bound to bear the expenses of defence of every suit, action or other proceedings at law that may be brought by any person for injury sustained owing to neglect of the above precautions and to pay any damages and cost which may be awarded in any such suit, action or proceedings to any such person on which may, with the consent of the contractor, be paid to compensate any claim by any suchperson.
- 6. a. Excavation and Trenching All trenches 1.2 m. (4ft.) or more in depth, shall at all times be supplied with at least one ladder for each 30m. (100ft.) in length or fraction thereof, LaddershallextendfrombottomoftheTrenchtoatleast90cm(3fts)abovethesurfaceof the ground. The side of the trenches which are 1.5 m. (5 ft.) or more in depth shall be stepped back to give suitable slope or securely held by timber bracing, so as to avoid the danger of sides collapsing. The excavated material shall not be placed within 1.5 m. (5ft.) of the edges of the trench or half of the depth of the trench whichever is more. Cutting shall be done from top to bottom. Under no circumstances, undermining or undercutting shall bedone.



#### b. Safety Measures for digging bore holes: -

- If the bore well is successful, it should be safely capped to avoid caving and collapse
  of the bore well. The failed and the abandoned ones should be completely refilled to
  avoid caving and collapse;
- ii. During drilling, Sign boards should be erected near the site with the address of the drilling contractor and the Engineer-in-charge of thework;
- iii. Suitable fencing should be erected around the well during the drilling and after the installation of the rig on the point of drilling, flags shall be put 50 Mtr all around the point of drilling to avoid entry ofpeople/animals;
- iv. After drilling the bore well, a cement platform (0.50 Mtr x 0.50 Mtr x 1.20 Mtr) 0.60 Mtr above ground level and 0.60 Mtr below ground level should be constructed around the wellcasing;
- v. Afterthecompletionoftheborewell,thecontractorshouldcaptheborewellproperly by welding steel plate, cover the bore well with the drilled wet soil and fix thorny shrubsoverthesoil. This should be done even while repairing the pump;
- $vi. \quad After the bore well is drilled the entires ite should be brought to the ground level;\\$
- Demolition Before any demolition work is commenced and also during the progress of the work.
  - i) All roads and open areas adjacent to the work site shall either be closed or suitably protected.
  - ii) No electric cable or apparatus which is liable to be a source of danger or a cable or apparatus used by the operator shall remain electrically charged.
  - iii) All practical steps shall be taken to prevent danger to persons employed from risk of fire or explosion or flooding. No floor, roof or other part of the building shall be so overloaded with debris or materials as to render itunsafe.
- 8. All necessary personal safety equipment as considered adequate by the Engineer-in-Charge should be kept available for the use of the person employed on the site and maintained in a condition suitable for immediate use, and the contractor should take adequate steps to ensure properuseofequipmentbythoseconcerned. The followings afety equipment shall invariably be provided.
  - Workers employed on mixing asphaltic materials, cement and lime mortars shall be provided with protective footwear and protectivegoggles.
  - ii) Those engaged in white washing and mixing or stacking of cement bags or any material whichisinjurioustotheeyesshallbeprovidedwithprotectivegoggles.
  - iii) Thoseengagedinweldingworksshallbeprovidedwithwelder'sprotectiveeye-shields.
  - iv) Stone breaker shall be provided with protective goggles and protective clothing and seated at sufficiently safeintervals.
  - v) When workers are employed in sewers and manholes, which are in active use, the contractors shall ensure that the manhole covers are opened and ventilated at least for an hourbeforetheworkersareallowedtogetintothemanholes, and themanholes soopened shall be cordoned of fwith suitable railing and provided with warning signals or boards to prevent accident to the public. In addition, the contractor shall ensure that the following safety measures are adhered to:-
  - a) Entry for workers into the line shall not be allowed except under supervision of the Sr. Superintendent (Engg.) or any other higherofficer.
  - b) Atleast5to6manholesupstreamanddownstreamshouldbekeptopenforatleast2to3 hoursbeforeanymanisallowedtoenterintothemanholeforworkinginside.
  - c) Before entry, presence of toxic gases should be tested by inserting wet lead acetate paper whichchangescolourinthepresenceofsuchgasesandgivesindicationoftheirpresence.



- d) Presence of Oxygen should be verified by lowering a detector lamp into the manhole. In case, no Oxygen is found inside the sewer line, workers should be sent only with oxygen kit
- e) Safety belt with rope should be provided to the workers. While working inside the manholes, such rope should be handled by two men standing outside to enable him to be pulled out duringemergency.
- f) Theareashouldbebarricadedorcondonedoffbysuitablemeanstoavoidmishapsofany kind. Proper warning signs should be displayed for the safety of the public whenever cleaning works are undertaken during night orday.
- g) Nosmokingoropenflamesshallbeallowedneartheblockedmanholebeingcleaned.
- h) The malba obtained on account of cleaning of blocked manholes and sewer lines should beimmediately removed to avoid accidents on account of slipper ynature of the malba.
- i) Workers should not be allowed to work inside the manhole continuously. He should be given rest intermittently. The Engineer-in-Charge may decide the time upto which a worker may be allowed to work continuously inside themanhole.
- j) GasmaskswithOxygenCylindershouldbekeptatsiteforuseinemergency.
- k) Air-blowers should be used for flow of fresh air through the manholes. Whenever called for, portable air blowers are recommended for ventilating the manholes. The Motors for these shall be vapour proof and of totally enclosed type. Non sparking gas engines also could be used but they should be placed at least 2 meters away from the opening and on the leeward side protected from wind so that they will not be a source of friction on any inflammable gas that might bepresent.
- l) The workers engaged for cleaning the manholes / sewers should be properly trained before allowing to work in themanhole.
- m) The workers shall be provided with Gumboots or non-sparking shoes bump helmets and gloves non sparking tools safety lights and gas masks and portable air blowers (when necessary). They must be supplied with barrier cream for anointing the limbs before working inside the sewerlines.
- n) Workmen descending a manhole shall try each ladder stop or rung carefully before putting his full weight on it to guard against insecure fastening due to corrosion of the rung fixed to manholewell.
- o) If a man has received a physical injury, he should be brought out of the sewer immediately and adequate medical aid should be provided tohim.
- p) The extent to which these precautions are to be taken depend on individual situation but the decision of the Engineer-in-Charge regarding the steps to be taken in this regardinan individual case will be final.
- (vi) The Contractor shall not employ men and women below the age of 18 years on the work of painting with products containing leadin any form. Wherever men above the age of 18 are employed on the work of lead painting, the following precaution should be taken:
- a) No paint containing lead or lead products shall be used except in the form of paste or readymadepaint.
- b) Suitable face masks should be supplied for use by the workers when paint is applied in theformofsprayorasurfacehavingleadpaintisdryrubbedandscrapped.
- c) Overall shall be supplied by the contractors to the workmen and adequate facilities shall be provided to enable the working painters to wash during and on the cessation of work.
- 9. An additional clause (viii)(i) of AAI Safety Code (iv) the Contractor shall not employ women andmenbelowtheageof18ontheworkofpaintingwithproductcontainingleadinanyform, wherever men above the age of 18 are employed on the work of lead painting, the following principles must be observed for suchuse:
  - i) White lead, sulphate of lead or product containing these pigment, shall not be used in painting operation except in the form of pastes or painting operation except in the form of pastes or painting operation.
  - ii) Measures shall be taken, wherever required in order to prevent danger arising from the application of a paint in the form ofspray.



- iii) Measuresshallbetaken,whereverpracticable,topreventdangerarisingoutoffromdust caused by dry rubbing down andscraping.
- iv) Adequate facilities shall be provided to enable working painters to wash during and on cessation ofwork.
- v) Overallshallbewornbyworkingpaintersduringthewholeofworkingperiod.
- vi) Suitable arrangement shall be made to prevent clothing put off during working hours being spoiled by paintingmaterials.
- vii) Cases of lead poisoning and suspected lead poisoning shall be notified and shall be subsequently verified by medical manappointed by competent authority of AAI.
- viii) AAI may require, when necessary medical examination ofworkers.
- ix) Instructions with regard to special hygienic precautions to be taken in the painting trade shall be distributed to workingpainters.
- 10. When the work is done near any place where there is risk of drowning, all necessary equipments should be provided and kept ready for use and all necessary steps taken for prompt rescue of any person in danger and adequate provision, should be made for prompt firstaidtreatmentofallinjurieslikelytobeobtainedduringthecourseofthework.
- 11. Useofhoistingmachinesandtackleincludingtheirattachments,anchorageandsupportsshall conform to the following standards or conditions:
  - (a) These shall be of good mechanical construction, sound materials and adequate strength and free from patent defects and shall be kept repaired and in good working order.
    - (b)Everyropeusedinhoistingorloweringmaterialsorasameansofsuspensionshallbe of durable quality and adequate strength, and free from patentdefects.
  - ii) Every crane driver or hoisting appliance operator shall be properly qualified and no person under the age of 21 years should be in charge of any hoisting machine including any scaffolding winch or give signals tooperator.
  - iii) Incaseofeveryhoistingmachineandofeverychainringhook, shackleswivelandpulley block used in hoisting or as means of suspension, the safe working load shall be ascertained by adequate means. Every hoisting machine and all gear referred to above shallbeplainlymarkedwiththesafeworkingload. Incaseofahoistingmachinehavinga variable safe working load each safe working load and the condition under which it is applicableshallbeclearlyindicated. Nopartofanymachineoranygearreferredtoabove in this paragraph shall be loaded beyond the safe working load except for the purpose of testing.
  - iv) Incaseofdepartmentalmachines,thesafeworkingloadshallbenotifiedbytheElectrical Engineer-in-Charge.Asregardscontractor'smachinesthecontractorsshallnotifythesafe working load of the machine to the Engineer-in-Charge whenever he brings any machinerytositeofworkandgetitverifiedbytheelectricalEngineerconcerned.
- 12. Motors, gearing, transmission, electric wiring and other dangerous parts of hoisting appliances should be provided with efficient safeguards. Hoisting appliances should be providedwithsuchmeansaswillreducetotheminimumtheriskofaccidentaldescentofthe load. Adequate precautions should be taken to reduce to the minimum the risk of any part of a suspended load becoming accidentally displaced. When workers are employed on electrical installations which are already energized, insulating mats, wearing apparel, such as gloves, sleeves and boots as may be necessary should be provided. The worker should not wear any rings, watches and carrykeys or other materials which are good conductors of electricity.
- 13. All scaffolds, ladders and other safety devices mentioned or described herein shall be maintainedinsafeconditionandnoscaffold,ladderorequipmentshallbealteredorremoved while it is in use. A dequate washing facilities should be provided a tornear places of work.



- 14. These safety provisions should be brought to the notice of all concerned by display on a notice board at a prominent place at work spot. The person responsible for compliance of the safety code shall be named therein by the contractor.
- 15. Toensureeffectiveenforcementoftherulesandregulationsrelatingtosafetyprecautionsthe arrangements made by the contractor shall be open to inspection by the Labour Officer or Engineer-in- Charge of the department or their
- 16. Notwithstanding the above clauses from (1) to (15), there is nothing in these to exempt the contractorfromtheoperationsofanyotherActorRulesinforceintheRepublicofIndia.



### MODEL RULES FOR THE PROTECTION OF HEALTH AND SANITARY ARRANGEMENTSFOR WORKERS EMPLOYED BY AAI OR ITS CONTRACTORS

### 1. APPLICATION

These rules shall apply to all buildings and construction works in charge of AAI in which twenty or more workers are ordinarily employed or are proposed to be employed in any day during the period during which the contract work is in progress.

### 2. **DEFINITION**

Work place means a place where twenty or more workers are ordinarily employed in connection with construction work on any day during the period during which the contract work is in progress.

### 3. FIRST-AIDFACILITIES

- (i) At every work place, there shall be provided and maintained, so as to be easily accessible during working hours, first-aid boxes at the rate of not less than one box for 150 contract labour or part thereof ordinarily employed.
- (ii) Thefirst-aidboxshallbedistinctlymarkedwitharedcrossonwhitebackgroundand shall contain the followingequipment.
- (a) Forworkplacesinwhichthenumberofcontractlabouremployeddoesnotexceed50 Each first –aid box shall contain the followingequipments:
- 1. 6 small sterilizeddressings
- 2. 3 medium size sterilizeddressings
- 3. 3 large size sterilizeddressings
- 4. 3 large sterilized burndressings
- 5. 1(30ml)bottlecontainingatwopercentalcoholicsolutionofiodine.
- 1(30ml)bottlecontainingsalvolatilehavingthedoseandmodeofadministration indicated on thelabel.
- 7. 1 snakebitelancet.
- 8. 1 (30 gms) bottle of potassium permanganatecrystals.
- 1 pairscissors.
- 10. 1copyofthefirst-aidleafletissuedbytheDirectorGeneral,FactoryAdviceService and Labour Institute, Government ofIndia.
- 11. 1 bottle containing 100 tablets (each of 5 gms) of aspirin.
- 12. Ointment forburns.
- 13. A bottle of suitable surgical antiseptic solution.
- (b) Forworkplacesinwhichthenumberofcontractlabourexceed 50. Each first-aidbox shall contain the following equipments.
- 1. 12 small sterilizeddressings.
- 2. 6 medium size sterilizeddressings.
- 3. 6 large size sterilizeddressings
- 4. 6 large size sterilized burndressings.
- 5. 6 (15 gms) packets sterilized cottonwool.
- 6. 1 (60 ml). Bottle containing two per cent alcoholic solutioniodine.
- 7. 1(60ml)bottlecontainingsalvolatilehavingthedoseandmodeofadministration indicated on thelabel.
- 8. 1 roll of adhesiveplaster.
- 9. 1 snake bitelancet.
- 10. 1 (30 gms) bottle of potassium permanganatecrystals.
- 11. 1 pairscissors.
- 12. 1copyofthefirst-aidleafletissuedbytheDirectorGeneralFactoryAdviceService and Labour Institute / Government ofIndia.
- 13. A bottle containing 100 tablets (each of 5 gms) of aspirin.



- 14. Ointment forburns.
- 15. A bottle of suitable surgical antiseptic solution.
- (iii) Adequate arrangements shall be made for immediate recoupment of the equipment when necessary.
- (iv) Nothing except the prescribed contents shall be kept in the First-aidbox.
- (v) Thefirst-aidboxshallbekeptinchargeofaresponsiblepersonwhoshallalwaysbereadily available during the working hours of the workplace.
- (vi) a person in charge of the First-aid box shall be a person trained in First-aid treatment in the workplaceswherethenumberofcontractlabouremployedis 150 ormore.
- (vii) In work places where the number of contract labour employed is 500 or more and hospital facilities are not available within easy distance from the works. First-aid posts shall be established and runby a trained compounder. The compounder shall be ond utyand shall be available at all hours when the workers are atwork.
- (viii) Where work places are situated in places which are not towns or cities, a suitable motor transport shall be kept readily available to carry injured person or person suddenly takenill to the nearesthospital.

### 4. DRINKINGWATER

- i) In every work place, there shall be provided and maintained at suitable places, easily accessible to labour, a sufficient supply of coldwater fit for drinking.
- ii) Wheredrinkingwaterisobtainedfromanintermittentpublicwatersupply,eachworkplace shallbeprovidedwithstoragewheresuchdrinkingwatershallbestored.
- iii) Everywatersupplyorstorageshallbeatadistanceofnotlessthan50feetfromanylatrine drain or other source of pollution. Where water has to be drawn from an existing well which is within such proximity of latrine, drain or any other source of pollution, the well shallbeproperlychlorinatedbeforewaterisdrawnfromitfordrinking. Allsuchwellsshall beentirelyclosedinandbeprovidedwithatrapdoorwhichshallbedustandwaterproof.
- iv) A reliable pump shall be fitted to each covered well, the trap door shall be kept locked and openedonlyforcleaningorinspectionwhichshallbedoneatleastonceamonth.

### 5. WASHINGFACILITIES

- i) In every work place adequate and suitable facilities for washing shall be provided and maintained for the use of contract labour employed therein.
- ii) Separate and adequate cleaning facilities shall be provided for the use of male and femal workers.
- Such facilities shall be conveniently accessible and shall be kept in clean and hygienic condition.

### 6. LATRINES ANDURINALS

- i) Latrinesshallbeprovidedineveryworkplaceonthefollowingscalenamely:
  - a) Wherefemaleareemployed, the reshall be at least one latrine for every 25 females.
  - b) Wheremalesareemployed,thereshallbeatleastonelatrineforevery25males.
- ii) Provided that, where the number of males or females exceeds 100, it shall be sufficient if there is one latrine for 25 males or females as the case may be upto the first 100, and one for every 50thereafter.
- iii) Everylatrineshallbeundercoverandsopartitionedoffastosecureprivacy, and shall have a proper door and fastenings.
- iv) Construction of latrines: The inside walls shall be constructed of masonry or some suitable heat-resistingnonabsorbentmaterialsandshallbecementwashedinsideandoutsideatleast onceayear, Latrinesshallnotbeofastandardlowerthanboreholesystem.



- v) (a) Where workers of both sexes are employed, there shall be displayed outside each block of latrine and urinal, a notice in the language understood by the majority of the workers "For Men only" or "For Women Only" as the case maybe.
  - (b) The notices hall also bear the figure of a man or of a woman, as the case may be.

the requirements of the Public HealthAuthorities.

- vi) Thereshallbeatleastoneurinalformaleworkersupto50andoneforfemaleworkersupto fifty employed at a time, provided that where the number of male or female workmen, as the case may be exceeds 500, it shall be sufficient if there is one urinal for every 50 males orfemalesuptothefirst500andonefor every100orpartthereafter.
- vii) (a)Thelatrinesandurinalsshallbeadequatelylightedandshallbemaintainedinaclean and sanitary condition at alltimes.

  (b)Latrinesandurinalsotherthanthoseconnectedwithaflushsewagesystemshallcomply with
- viii) Watershallbeprovidedbymeansoftaporotherwisesoastobeconvenientlyaccessiblein or near the latrines andurinals.
- ix) Disposal of excreta: Unless otherwise arranged for by the local sanitary authority, arrangements for proper disposal of excreta by incineration at the work place shall be made by means of a suitable incinerator. Alternately excreta may be disposed of by putting a layer of night soil at the bottom of a pucca tank prepared for the purpose and covering it with a 15 cm. Layer of waste or refuse and then covering it with a layer of earth for a fortnight (when it will turn tomanure).
- x) The contractor shall at his own expense, carry out all instructions issued to him by the Engineer-in-Charge to effect proper disposal of night soil and other conservancy work in respect of the contractor's workmen or employees on the site. The contractor shall be responsible for payment of any charges which may be levied by Municipal or Cantonment Authority for execution of such on hisbehalf.

### 7. PROVISION OF SHELTER DURINGREST

At every place there shall be provided, free of cost, four suitable sheds, two for meals and the other two for rest separately for the use of men and women labour. The height of each shelter shall not be less than 3 meters (10 ft.) from the floor level to the lowest part of the roof. These shall be kept clean and the space provided shall be on the basis of 0.6 sq.m. (6 sft) per head. Provided that the Engineer-in-Charge may permit subject to his satisfaction, a portion of the building under construction or other alternative accommodation to be used for the purpose.

### 8. CRECHES

- Ateveryworkplace,atwhich20ormorewomenworkersareordinarilyemployed,there shall be provided two rooms of reasonable dimensions for the use of their children under theageofsixyears.Oneroomshallbeusedasaplayroomforthechildrenandtheother astheirbedroom.Theroomsshallbeconstructedwithspecificationsasperclause19H
   (ii) a, b &c.
- ii) The rooms shall be provided with suitable and sufficient openings for light and ventilation. Thereshall be adequate provision of sweepers to keep the places clean.
- iii) The contractor shall supply adequate number of toys and games in the play room and sufficient number of cots and beddings in the bedroom.
- iv) The contractor shall provide one ayaa to look after the children in the crèche when the number of women workers does not exceed 50 and two when the number of women workers exceed 50.
- v) Theuseoftheroomsearmarkedascrèchesshallberestrictedtochildren,theirattendants and mothers of thechildren.



### 9. CANTEENS

- In every work place where the work regarding the employment of contractor labour is likely to continue for six months and where in contract labour numbering one hundred or moreareordinarilyemployed, an adequate can teen shall be provided by the contractor for the use of such contract labour.
- ii) The canteen shall be maintained by the contractor in an efficientmanner.
- iii) Thecanteenshallconsistofatleastadininghall,kitchen,storeroom,pantryandwashing places separately for workers andutensils.
- iv) Thecanteenshallbesufficientlylightedatalltimeswhenanypersonhasaccesstoit.
- v) The floor shall be made of smooth and impervious materials and inside walls shall be limewashedorcolourwashedatleastonceineachyear. Provided that the inside walls of the kitchen shall be lime washed every fourmonths.
- vi) The premises of the canteen shall be maintained in a clean and sanitary condition.
- vii) Waste water shall be carried away in suitable covered drains and shall not be allowed to accumulate so as to cause anuisance.
- viii) Suitablearrangementsshallbemadeforthecollectionanddisposalofgarbage.
- ix) Thedininghallshallaccommodateatatime30percentofthecontractlabourworkingat atime.
- x) The floor area of the dining hall, excluding the area occupied by the service counter and any furniture except tables and chairs shall not be less than one square metre (10 sft) per diner to be accommodated as prescribed in sub-Rule(ix).
- xi) (a) A portion of the dining hall and service counter shall be partitioned off and reserved forwomenworkersinproportiontotheirnumber.(b)Washingplacesforwomenshallbe separate and screened to secure privacy.
- xii) Sufficienttablesstools, chairsorbenches shall be available for the number of diners to be accommodated as prescribed in sub-Rule(ix).
- xiii) (a) 1. There shall be provided and maintained sufficient utensils crockery, furniture and anyother equipment necessary for the efficient running of the canteen.
  - 2. The furniture utensils and other equipments hall be maintained in a clean and hygienic condition.
  - (b) 1. Suitable clean clothes for the employees serving in the canteen shall be provided and maintained.
  - 2. Aservicecounter, if provided, shall have top of smooth and impervious material.
  - 3. Suitablefacilities including an adequate supply of hot watershall be provided for the cleaning of utensils and equipments.
- xiv) Thefoodstuffsandotheritemstobeservedinthecanteenshallbeinconformitywiththe normal habits of the contractlabour.
- xv) The charges for food stuffs, beverages and any other items served in the canteen shall be basedon'NoProfit,Noloss'andshallbeconspicuouslydisplayedinthecanteen.
- xvi) Inarrivingatthepriceoffoodstuffs,andotherarticleservedinthecanteen,thefollowing items shall not be taken into consideration as expenditure namely:
  - a) The rent of land andbuilding.
  - b) Thedepreciationandmaintenancechargesforthebuildingandequipments provided for thecanteen.
  - c) Thecostofpurchase,repairsandreplacementofequipmentsincludingfurniture, crockery, cutlery andutensils.
  - d) Thewaterchargesandotherchargesincurredforlightingandventilation.
  - e) Theinterestandamountsspentontheprovisionandmaintenanceofequipments provided for thecanteen.
- xvii) The accounts pertaining to the canteen shall be audited once every 12 months by registered accountants and auditors.



### 10. ANTI-MALARIALPRECAUTIONS

The contractors hall at his own expense, conform to all anti-malarial instructions given to him by the Engineer-in-Charge including the filling up of any borrow pits which may have been dug by him.

**11.** The aboverules shall be incorporated in the contracts and innotices inviting tenders and shall form an integral part of the contracts.

### 12. AMENDMENTS

AAI may, from time to time, add to or amend these rules and issue directions - it may consider necessary for the purpose of removing any difficulty which may arise in the administration thereof.



### **AIRPORTS AUTHORITY OF INDIA**

### **Contractor's Labour Regulations**

### 1. SHORTTITLE

These regulations may be called the AAI Contractors Labour Regulations.

### 2. **DEFINITIONS**

- (i) **Workman** means any person employed by AAI or its contractor directly or indirectly through a subcontractor with or without the knowledge of the AAI to do any skilled, semiskilled or unskilled manual, supervisory, technical or clerical work for hire or reward, whetherthetermsofemploymentareexpressedorimpliedbutdoesnotincludeanyperson:-
- a) Who is employed mainly in a managerial or administrative capacity:or
- b) Who, being employed in a supervisory capacity draws wages exceeding five hundred rupeespermensemorexerciseseitherbythenatureofthedutiesattachedtotheofficeor byreasonofpowersvestedinhim,functionsmainlyofmanagerialnature:or
- c) Whoisanoutworker,thatistosay,persontowhomanyarticleormaterialsaregivenout by or on behalf of the principal employers to be made up cleaned, washed, altered, ornamental finished, repaired adopted or otherwise processed for sale for the purpose of the trade or business of the principal employers and the process is to be carried out either in the home of the out worker or in some other premises, not being premises under the control and management of the principal employer. No person below the age of 14 years shall be employed to act as aworkman.
- (ii) Fair Wages means wages whether for time or piece work fixed and notified under the provisions of the Minimum Wages Act from time to time.
- (iii) **Contractors** shall include every person who undertakes to produce a given result other than a mere supply of goods or articles of manufacture through contract labour or who supplies contract labour for any work and includes asubcontractor.
- (iv) Wages shall have the same meaning as defined in the Payment of Wages Act.
- 3. i) Normally working hours of an adult employee should not exceed 9 hours a day. The working day shall be so arranged that inclusive of interval for rest, if any, it shall not spread over more than 12 hours on anyday.
  - ii) When an adult worker is made to work for more than 9 hours on any day or for more than 48 hours in any week, he shall be paid over time for the extra hours put in by him at double the ordinary rate ofwages.
  - iii) a) Every worker shall be given a weekly holiday normally on a Sunday, in accordance with the provisions of the Minimum Wages (Central) Rules 1960 as amended from time to timeirrespectiveofwhethersuchworkerisgovernedbytheMinimumWagesActornot.
  - b) Where the minimum wages prescribed by the Central/State Government under the Minimum Wages Act are not inclusive of the wages for the weekly day of rest, the worker shallbeentitledtorestdaywagesattherateapplicabletothenextprecedingday,providedhe hasworkedunderthesamecontractorforacontinuousperiodofnotlessthan6days.
  - c) Where a contractor is permitted by the Engineer-in-Charge to allow a worker to work on a normal weekly holiday, he shall grant a substituted holiday to him for the whole day on one ofthefivedaysimmediatelybeforeorafterthenormalweeklyholidayandpaywagestosuch workerfortheworkperformedonthenormalweeklyholiday atovertimerate.

### 4. DISPLAY OF NOTICE REGARDING WAGESETC.

The contractor shall before he commences his work on contract, display and correctly maintain and continue to display and correctly maintain in a clear and legible condition in conspicuous places on the work, notices in English and in the local Indian languages spoken by the majority of the workers giving the minimum rates of wages fixed under Minimum Wages Act, the actual wages being paid, the hours of work for which such wage are earned, wages periods, dates of payments of wages and other relevant information as per Appendix' VIII'.



### 5. PAYMENT OFWAGES

- (i) The contractors hall fix wage periods in respect of which wages shall be payable.
- (ii) No wage period shall exceed onemonth.
- (iii) Thewagesofeverypersonemployedascontractlabourinanestablishmentorbyacontractor where less than one thousand such persons are employed shall be paid before the expiry of seventh day and in other cases before the expiry of tenth day after the last day of the wage period in respect of which the wages are payable.
- (iv) Where the employment of any worker is terminated by or on behalf of the contractor the wagesearnedby himshallbepaidbeforetheexpiry of the secondworking day from the date on which his employment is terminated.
- (v) All payment of wages shall be made on a working day at the work premises and during the working time and on a date notified in advance and in case the work is completed before the expiry of the wage period, final payment shall be made within 48 hours of the last working day.
- (vi) Wagesduetoeveryworkershallbepaidtohimdirectortootherpersonauthorisedbyhimin thisbehalf.
- (vii) All wages shall be paid in current coin or currency or inboth.
- (viii) WagesshallbepaidwithoutanydeductionsofanykindexceptthosespecifiedbytheCentral Government by general or special order in this behalf or permissible under the Payment of Wages Act1956.
- (ix) A notice showing the wages period and the place and time of disbursement of wages shall be displayed at the place of work and a copy sent by the contractor to the Engineer-in-Charge underacknowledgement.
- (x) It shall be the duty of the contractor to ensure the disbursement of wages in the presence of the Senior Superintendent Engg or authorised representative of the Engineer-in-Charge who willberequiredtobepresentattheplaceandtimeofdisbursementofwagesbythecontractor toworkmen.

Note: In case of payment of wages paid through bank, the contractor shall submit a copy of bank statement for relevant period duly signed by him.

### 6. FINES AND DEDUCTIONS WHICH MAY BE MADE FROMWAGES

- (i) Thewagesofaworkershallbepaidtohimwithoutanydeductionofanykindexceptthe following:
  - a) Fines
  - b) Deductions for absence from duty i.e. from the place or the places where by the terms of hisemploymentheis required towork. The amount of deductions hall be in proportion to the period for which he was absent.
  - c) Deduction for damage to or loss of goods expressly entrusted to the employed person for custody, or for loss of money or any other deduction which he is required to account, where such damage or loss is directly attributable to his neglect ordefault.
  - d) Deductionforrecoveryofadvancesorforadjustmentofoverpaymentofwages, advances granted shall be entered in aregister.
  - e) AnyotherdeductionwhichtheCentralGovernmentmayfromtimetotimeallow.

On termination of employment for any reason whatsoever the contractor shall issue to the workman whose services have been terminated, a **Service certificate** in Form XV of the CL(R&A) Central Rules 1971.

### 11. PRESERVATION OF LABOURRECORDS

All records required to be maintained under Regulations Nos. 6 & 7 shall be preserved in original for a period of three years from the date of last entries made in them and shall be made available for inspection by the Engineer-in-Charge or Labour Officer or any other officers authorised by the Ministry of Urban Development in this behalf.

### 12. POWEROFLABOUROFFICERTOMAKEINVESTIGATIONSORENQUIRY

The Labour Officer or any person authorised by Central Government on their behalf shall have power to make enquiries with a view to ascertaining and enforcing due and proper observance of Fair Wage Clauses and the Provisions of these Regulations. He shall investigate into any complaint regarding the default made by the contractor or subcontractor in regard to such provision.

### 13. REPORT OF LABOUROFFICER

The Labour Officer or other persons authorised as aforesaid shall submit a report of result of hisinvestigationorenquirytotheEngineer-in-Chargeconcernedindicatingtheextent,ifany, to which the default has been committed with a note that necessary deductions from the contractor's bill be made and the wages and other dues be paid to the labourers concerned.In caseanappealismadebythecontractorunderClause13oftheseregulations,actualpayment to labourers will be made by the Engineer-in-Charge after G.M. Engg. has given his decision on suchappeal.

(i) Engineer-in-Charge shall arrange payments to the labour concerned within 45 days from thereceiptofthereportfromtheLabourOfficerortheG.M.Engineerasthecasemaybe.

### 14. APPEAL AGAINST THE DECISION OF LABOUROFFICER

Any person aggrieved by the decision and recommendations of the Labour Officer or other person so authorised may appeal against such decision to the Engineer-in-Charge concerned within 30 days from the date of decision, but subject to such appeal, the decision of the officer shall be final and binding upon the contractor.

- a) An officer of an association of employers of which he is amember.
- b) Anofficerofafederationofassociationsofemployerstowhichassociationreferredtoin Clause (a) isaffiliated.
- c) Where the employers is not a member of any association of employers, by an officer of association of employer connected with the industry in which the employer is engaged or by anyotheremployer,engagedintheindustry inwhichtheemployerisengaged.
- (iii) Nopartyshallbeentitledtoberepresentedbyalegalpractitionerinanyinvestigationor enquiry under these regulations.

### 16. INSPECTION OF BOOKS ANDSLIPS

The contractors hall allow in spection of all the prescribed labour records to any of his workers or to his agent at a convenient time and place after due notice is received or to the Labour Officer or any other person, authorised by the Central Government on his behalf.

### 17. SUBMISSION OFRETURNS

The contractor shall submit periodical returns as may be specified from time to time.

### 18. AMENDMENTS

The Central Government/AAI may from time to time add to or amend the regulations and on any question as to the application/interpretation or effect of those regulations the decision of the General Manager (Engg.) concerned shall be final.

WHEREAS the Authority is desirous to make its business mechanism more transparent, thus to ensure strict adherence of the aforesaid objectives/goals, the Authority hereby adopts the instrument developed by the renowned international non-governmental organization "Transparency International" (T I ) headquartered in Berlin (Germany ). The Authority will appoint an Independent External Monitor (IEM) who will monitor the tender process and the execution of the contract for compliance with the principles mentionedabove.

AND WHEREAS the Bidder is submitting a tender to the Authority for .......InresponsetotheNIT(NoticeInvitingTender)dated......

Contractor is signing the contract for execution of ......NOW, therefore, To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to Enabling the Authority to obtain the desired said stores/equipment/execution of works at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and Enabling Authority to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the Authority will commit to prevent corruption, in any form, by its officials by following transparent procedures. The parties hereto hereby agree to enter into this Integrity Pact and agree asfollows:



### 1. Commitments of the Authority;

- 1.1 The Authority undertakes that no official of the Authority, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to thecontract.
- 1.2 The Authority will, during the pre-contact stage, treat all BIDDERs alike, and will provide to all BIDDERs the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERs.
- 1.3 All the officials of the Authority will report to the appropriate authority office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such abreach.
- In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the Authority with full and verifiable facts and the same is prima facie found to be correct by the Authority, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the Authority and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the Authority the proceedings under the contract would not be stalled.

### 1. Commitments of Bidders/Contractor.

The Bidder/Contractor commits itself to take all measures necessary to prevent corrupt practice, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following.

- The Bidder/Contractor will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange forany advantage in the bidding, evaluation, contracting and implementation of the contract.
- The Bidder/Contactor further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Authority for showingor



forbearing to show favour or dis favour to any person in relation to the contract or any other contract with the Authority.

- The Bidder / Contactor has not entered and will not enter with other bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specification, certifications, subsidiary contracts, submission or non-submission of bids or any actions to restrict competitiveness or to introduce cartelization in the biddingprocess.
- The Bidder/Contractor shall, when presenting his bid, disclose the name and address of agents and representatives and Indian BIDDERs shall disclose their foreign principals or associates.
- The Bidder/Contactor shall when presenting his bid disclose any and all the payments he has made or, is committed to or intends to make to agents/brokers or any other intermediary, in connection with thisbid/contract.
- The Bidder/Contractor further confirms and declares to the Authority that the BIDDER is the original manufacturer/integrator/ authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the Authority or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation orrecommendation.
- The Bidder/Contractor, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made or has committed to or intends to make to officials of the Authority or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon forsuch payments.
- The Bidder/Contractor will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- The Bidder/Contractor will not accept any advantage in exchange for any corrupt practice, unfair means and illegalactivities.
- The Bidder / Contactor shall not use improperly, for purposes of competition or personal gain ,or pass on to others, any information provided by the Authority as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The Bidder / Contractor also under takes to exercise due and adequate care lest any such information isdivulged.
- The Bidder/Contractor will inform to the Independent ExternalMonitor.
  - i) If he receives demand for an illegal/undue payment /benefit.



- ii) If he comes to know of any unethical or illegalpayment/benefit.
- iii) If he makes any payment to any Authority's associate(s)
- The Bidder/Contactor commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- The Bidder/Contactor shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.
- If the Bidder/Contractor or any employee of the Bidder/Contractor or any person acting on behalf of the Bidder/ Contractor, either directly or indirectly, is a relative of any of the officers of the Authority, or alternatively, if any relative of an officer of the Authority has financial interest/stake in the Bidder's/Contractor's firm, the same shall be disclosed by the Bidder/Contractor at the time filing of tender. The term 'relative' for this purpose would be as defined in Section 6 of the Companies Act1956.
- The Bidder/Contractor shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the Authority.
- That if the Bidder/ Contractor, during tender process or before the award of the contract or during execution of the contract/work has committed a transgression in violation of section 2 or in any other form such as to put his reliability or credibility as Bidder/Contractor into question, the Authority is entitled to disqualify him from the tender process or to terminate the contract for such reason and to debar the BIDDER from participating in future biddingprocesses.

### 2. PreviousTransgression

- 3.1 The Bidder/Contractor declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India that could justify Bidders's exclusion from the tenderprocess.
- 3.2 The Bidder/Contractor agrees that if it makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason and he may be considered for debarment for future tender/contractprocesses.
- 3.3 ThattheBidder/ContractorundertakestogetthisPactsignedbythesubcontractor (s) and associate(s) whose value of the work contribution exceeds Rs 0.5 Cr. (Rupees zero point five Cr.) and to submit the same to the Authority along-with the tender document/ contract before contractsigning.
- 3.4. That sub-contractor(s)/ associate(s) engaged by the Contractor, with the approval of the Authority after signing of the contract, and whose value of the work contributionexceedsRs0.5Cr.(RupeesZeropointfiveCr.)willberequiredto



sign this Pact by the Contractor, and the same will be submitted to the Authority before doing/ performing any act/ function by such subcontractor(s) / associate(s) in relation to the contract/work.

- 3.5 That the Authority will disqualify from the tender process all Bidder(s) who don't sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority
- 3.6 That if the Contractor(s) does/ do not sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority. Authority will terminate the contract and initiate appropriate action against suchContractor(s).
- 4. Earnest Money, Security Deposit, Bank Guarantee, Draft, Pay order or any other mode and its validity i/c Warranty Period, Performance Guarantee/Bond.

While submitting bid, the BIDDER shall deposit an EMD / SD / BG / DRAFT / PAY ORDER ETC I/C WARRANTY PERIOD, PG/BOND, VALIDITY etc., which is

as per terms and conditions and details given in NIT / tender documents sold to the Bidders.

- 5. Sanctions for Violations/Disqualification from tender process and exclusion from futureContacts.
- Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the Authority to take all or any one of the following actions, wherever required:
  - i) To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) wouldcontinue.
  - ii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
  - iii) If the Authority has disqualified / debarred the Bidder from the tender process prior to the award under section 2 or 3 or 4, the Authority is entitled to forfeit the earnest money deposited/bidsecurity.
  - iv) To recover all sums already paid by the Authority, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the Authority in connection with any other contract or any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.



- v) To en-cash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along withinterest.
- vi) To cancel all or any other Contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the Authority resulting from such cancellation/rescission and the Authority shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- vii) To debar the BIDDER from participating in future bidding processes for a minimum period of three years, which may be further extended at the discretion of the Authority.
- viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- ix) In case where irrevocable Letters of Credit have been received in respect of any contract signed by the Authority with the BIDDER, the same shall not beopened.
- x) Forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- xi) That if the Authority have terminated the contract under section 2 or 3 or 4 or if the Authority is entitled to terminate the contract under section 2 or 3 or 4, the Authority shall be entitled to demand and recover from the contractor damages equivalent to 5% of the contract value or the amount equivalent to security deposit or performance bank guarantee, whichever is higher.
- xii) That the Bidder / Contractor agrees and undertakes to pay the said amount without protest or demur subject only to condition that if the Bidder/Contractor can prove and establish to the satisfaction of the Authority that the disqualification / debarment of the bidder from the tender process or the termination of the contract after award of the contract has caused no damage to the Authority.
- The Authority will be entitled to take all or any of the actions mentionedat para 5.1 above.
- 5.3 (i) to (xii) of this Pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.



- That if the Bidder/Contractor applies to the Authority for premature revocation of the debarment and proves to the satisfaction of the Authority that he has installed a suitable and effective corruption prevention system and also restored/recouped the damage, if any, caused by him, the Authority may, if thinks fit, revoke the debarment prematurely considering the facts and circumstances of the case, and thedocuments/evidenceadducedbytheBidder/Contractorforfirsttimedefault.
- 5.5 That a transgression is considered to have occurred if the Authority is fully satisfied with the available documents and evidence submitted along with Independent External Monitor's recommendations/suggestions that no reasonable doubt is possible in thematter.
- The decision of the Authority to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent External Monitor(s) appointed for the purpose of this Pact.

### 6. Allegations against Bidders/Contractors/ Sub-Contractors/Associates:

That if the Authority receives any information of conduct of a Bidder/ Contractor or Sub- Contractor or of an employee or a representative or an associate of the Bidder, Contractor or Sub- Contractor which constitute corruption, or if the Authority has substantive suspicion in this regard, the Authority will inform the Vigilance Department for appropriate action.

### 7. Independent ExternalMonitor(s),

- 7.1. That the Authority has appointed competent and credible Independent External Monitor(s) for this Pact.
- 7.2 The task of the Monitor(s) is to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact. He will also enquire into any complaint alleging transgression of any provision of this Pact made by the Bidder, Contractor or Authority.
- 7.3. That the Monitor(s) is not subject to any instructions by the representatives of the parties and would perform his functions neutrally and independently. He will report to the Chairperson of the Board of the Authority.
- 7.4 That the Bidder / Contractor accepts that the Monitor(s) has the right to access without restriction to all project documentation of the Authority including that provided by the Bidder/Contractor. The Bidder/Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation including minutes of meeting. The same is applicable to Sub Contractors and Associates. The Monitor is under obligation to treat the information and documents of the Authority and Bidder/ Contractor / Sub- Contractors/ Associates withconfidentiality.
- 7.5. That as soon as the Monitor notices, or believes to notice, a violation of this Pact, he will so inform the management of the Authority and request themanagement



to discontinue or heal the violation, or to take other relevant action. The Monitor(s) can in this regard submit his recommendations/ suggestions. Beyond this, the Monitor(s) has no right to demand from the parties that they act in a specific manner, refrain from action or tolerateaction.

- 7.6 That the Authority will provide to the Monitor(s) sufficient information about all meetings among the parties related to the project provided such meetings could have an impact on the contractual relations between the Authority and the Contractor / Bidder. The parties offer to the Monitor(s) the option to participate in such meetings.
- 7.7 That the Monitor(s) will submit a written report to the Chairperson of the Board of the Authority within 2 weeks from the date of reference or intimation to him by the Authority and, should the occasion arise, submit proposals for correcting problematicsituations.
- 7.8 That if the Monitor(s) has reported to the Chairperson of the Board a substantiated suspicion of an offence under relevant Anti- Corruption Laws of India and the Chairperson has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Vigilance Department, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government ofIndia.
- 7.9 The word 'Monitor' would include singular andplural.

### 8. Facilitation of Investigation.

In case of any allegation of violation of any provisions of this Pact or payment of commission, the Authority or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of suchExamination.

### 9. Law and Place of Jurisdiction.

That this Pact is subject to provisions under Indian Law. The place of performance and jurisdiction is the Corporate Headquarter /the Regional Headquarter / office of the Authority, asapplicable.

### 10. Other LegalActions

- 10.1 That the changes and supplements as well as termination notice need to be made in writing.
- That if the Bidder / Contractor are a partnership or a consortium, this Pact must be signed by all the partners and consortium members or their authorized representatives.



### Pact duration(Validity) 11.

- 11.1 That this Pact comes into force when both the parties have signed it. It expires for the Contractor 12 months after the final payment under the respective contract, and for all other Bidders 3 months after the contract isawarded.





# SPECIAL CONDITIONS OF CONTRACT

### SPECIAL CONDITION OF CONTRACT

These special conditions of contract shall be read in conjunction with Airports Authority of India General conditions of contract, if there are any provisions in the special conditions of contract which are at variance with the provisions of general conditions of contract, the provision in these special conditions shall take precedence.

- 1. General Scope of Work: The Scope of work covers the following items:-
  - Operation & maintenance of 150 KLD capacity sewage treatment plant on round the clock (24 Hours) basis including replacement of material as mentioned in SOQ item no.04-08.
  - ii. Rewinding & repairing of sewage treatment plant pumps/ blowers/ motors of different capacity as and when required.
  - iii. Evacuating of dirt sand annually from 4nos. storage/sludge tank of STP.
  - iv. The bidder shall have to submit quarterly treated STP water report from reputed government / government approved laboratory indicating parameters like BOD, COD, PH, Total suspended solid, Oil & Greece etc. Nothing extra shall be paid to the bidder for this.
  - v. Periodical/ preventive maintenance/ up keeping works related to 150 KLD STP plant as per enclosed operation and maintenance schedule of SCC at page no.14-16.
- 2. Period of Contract: The service contract shall be for a period of 24 months from the date of handing over of site. The contract periods can be extended for further period of 6 (Six) Months on the same terms and conditions of the agreement. AAI reserves the right to terminate the contract fully or partially by giving 30 days notice in writing to the contractor. If in the opinion of the Engineer-in-charge, it is observed that the contractor is not doing the work satisfactorily as per the terms and conditions of contract then the contract can be terminated with immediate effect without giving any reasons thereof.
- 3. Entry Passes: The work site lies in restricted area. The contractor shall apply in writing in advance for issue of necessary entry passes of workmen engaged by him . The office/airport premises is an essential service covered under the maintenance of essential service Act and hence disruption of services rendered will be a statutory offence. The necessary police verification etc. as required for entry passes will be the responsibility of the contractor. All expenditure towards arranging security passes shall be borne by the Agency.
- 4. Security:- The contractor and his employees shall abide by security regulation framed by AAI/BCAS or Police Authorities. Any worker of the contractor, whose presence is found undesirable in AAI premises, shall not be allowed to work. The Contractor shall be fully responsible for the satisfactorily working of his staff. "If Contractor or his authorized representative or his employed workers are found violating any of security regulations, suitable action shall be taken by AAI as per prevailing rules".

All men and vehicles shall be permitted to enter the restricted/office area only on possession of the security passes. The contractor shall apply in writing in advance

before commencement of work for issue of security passes and shall submit a list of personnel concerned with their addresses. The contractor shall ensure that his men are deployed only in that area where the security passes issued is valid for. Passes shall be deposited back with Engineer-In-Charge on demand and in any case immediately after completion of work. The contractor or his staff/workmen shall observe all the rules promulgated from time to time by the concerned authorities. Any person found violating the security rules laid down by the authority will be expelled from the area without assigning any reason whatsoever and contractor shall have no claim on this account.

### 5. Statutory & Regulatory Clauses: -

The contractor has to discharge all the obligations as provided under various statutory enactment including the EPF/ ESI/Contract Labour (Regulation and abolition)/Minimum Wages / Payment of Wages / Payment of Bonus / Payment of Gratuity / Workmen's compensation / Works Contract and other relevant Acts, Rules and Regulations in force and as amended from time to time in the State, as applicable.

The engagement and employment of workers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be violation of this contract. AAI may ask the contractor to produce documents to verify that these provisions/laws are complied by the contractor.

The contractor has to follow the local security/safety rules & regulations and such instructions on restricted hours of work as may be imposed on him by the department / local authorities, while working in security restricted zones and no claim whatsoever on account of this, will be entertained.

The contractor has to deploy their staff to run the system on all days (365 days) including Sundays and Gazetted holidays in shift as per BOQ for which nothing extra shall be paid.

Contractor has to submit the details of staff such as, qualification documents and experience letters of the staff, the CV and passport size coloured photograph along with copy of police verification (not older than six months on the date of start of work) before engaging them on work. All the documents should be sell-attested by each worker and signed and stamped by contractor/agency. The decision of Engineer-incharge, to accept or reject any candidate on the basis of lack of experience, qualification, lack of skills required for job, will be final and binding on the Agency.

6. Uniform:- The contractor/ agency has to provide every year during the currency of the contract, 2 sets of uniform (pant and shirt), 1 pair of shoes & 3 pair of socks and a sweater to his staff of approved colour during the contract period, (within one month from the date of award) failing which, AAI recover an amount of Rs 200/- per person per week till the compliance of the same from the contractor's running/final bill. In the event of noncompliance of wearing uniform & shoes by workers on daily basis a recovery of Rs. 50/-per day per person shall be made from running bills. The workers should wear a badge on the left pocket of the shirt mentioning company's name.

- 7. No accommodation shall be arranged by the AAI for the staff / workers of the contractor. It is the responsibility of contractor to make his own arrangements for the facilities.
- **8. Rates: -** Prices shall be inclusive of any taxes, duties, cess, fee and charges etc levied under any statute but excluding GST. Goods & Service Tax (GST) shall be paid to contractor for any taxable supply / services / works against a valid tax invoice as per terms and conditions of the contract.

The prices quoted shall be exclusive of PF/ESI & Bonus. PF & ESI amount paid to the statutory authorities by the contractor shall be reimbursed on actual basis throughout the contract period on submission of the documentary evidence in next bill or after the final bill.

Bonus amount as per latest Govt. rules or 8.33% of annual salary whichever is higher will be paid to the deployed manpower by the contractor and the same shall be reimbursed on actual basis throughout the contract period on submission of the documentary evidence in next bill or after the final bill. In case of nonpayment of bonus necessary recovery/withheld against bonus from their RA Bill/Final bill shall be made as decided by EIC and appropriate action will be initiated by AAI against the contractor. The decision of EIC is the regard will be final and binding on the Agency.

The bidder has to submit quarterly STP test report as per SCC clause no. 1 (iv) at page no. 01 failing which a penalty @ Rs. 4000 per test report shall be levied and recovered from the running / final bill of the bidder.

### 9. PF & ESIC Contribution:-

- (i) The contractor shall register himself with Labour Licensing Authority and obtain Labour License Number in this regard.
- (ii) The contractor shall have to register with PF & ESIC (where ever applicable) for workmen engaged for the work & challans / deposit receipts of PF & ESI contribution shall be submitted in AAI office for verification/reimbursement, at the time of submission of bill.
- (iii) The PF dues (including EDLI and administrative charges) in respect of workers engaged by the contractor for AAI works to be deposited by the contractor every month by a challan and the documentary evidence in support of such payments along-with employee wise details of the PF contribution (both Employee's share and the employer's contribution) needs to be submitted to the Engineer in charge for the work/contract.
- (iv) ESI (where ever applicable) & EPF amount (contractor's contribution & administrative charges) paid to the statutory authorities by the contractor shall be reimbursed on actual basis on submission of documentary evidence.
- (v) If ESI not applicable, the agency shall provide Rs. 2.0 lacs Mediclame policy to each person engaged at the site. The premium paid shall be reimbursed on actual basis against production of documentary proof.
- (vi) The contractor has to deposit PF & ESI as applicable, failing which recovery/ withheld @ 26 % and 4% against PF and ESI (if applicable) respectively from their R.A bills/Final Bill shall be made.

### 10. Labour Wages:

- (i) The contractor has to pay the prevailing minimum wages issued by the office of Regional Labour Commissioner/Chief Labour Commissioner (whichever is higher), from time to time. However, the difference in minimum wages based on actual payment made to the labour and wages applicable at the time of submission of tender will be reimbursed including difference in EPF and ESI payment to the contractor on revision of minimum wages and no additional amount such as contractor's overhead & profit will be paid on this account.
  - In this regard the successful bidder shall submit an affidavit on non-judicial stamp paper of Rs.100 as per Annexure before award of the work.
- (ii) For the purpose of admitting the claim for reimbursement of statutory increase in wages paid by him, the contractor has to produce the required documentary evidence to the satisfaction of Engineer-In-Charge.
- (iii) The payment to the workmen's engaged by the contractor is to be paid through NEFT/ RTGS/ Cheque on or before 7th of every month irrespective of Saturday, Sunday and bank holidays. If any violation with respect to payment of wages for any two months in a contract period, necessary action for cancellation of contract, debarring of the agency for participating in future contracts in AAI shall be initiated. The agency will not be allowed to participate in any of the tendering process in AAI till finalization of the decision.
- **11. During** the contract period if any new installations are added I replaced or modified the existing ones in these areas, which do not warrant any additional manpower, the maintenance services for these installations are also to be provided by the contractor without any extra cost.
- **12. Qualification & Wages of Staff:-** The contractor should depute the persons as per the qualification given below for maintenance works. Each shift should be covered with highly skilled, skilled, Semi-skilled, Un- skilled persons as required as per BOQ & tender particular condition of contract.
  - (i) **Highly skilled manpower (Sr. Supervisor)** shall be Diploma holders with 04 year experience (Preferable) or Graduate engineer with min. 02 yrs of similar experience for overall supervision and administration of the contract and shall be paid extra allowance of Rs. 4000 per month in addition to the minimum wages
  - (ii) **Highly skilled manpower (Supervisor**) shall be Diploma holders with 02 years experience /Graduate with 01 year experience (Preferable) or ITI Holder in Electrician/AC refrigeration with 10 year experience for supervision of manpower & works and shall be paid extra allowance of Rs 2000 per month in addition to the minimum wages.
  - (iii) **Skilled manpower** shall be ITI holder in Electrician/AC mechanic/AC & Refrigeration/Fitter with minimum 1 year experience in similar works or wireman trade license with minimum 2 year experience in similar works /field and shall be paid as per minimum wages.
  - (iv) Semi-Skilled manpower shall have ITI holder in Electrician/AC

mechanic/AC & Refrigeration/Fitter / wireman license or 10th pass with five year experience of similar works and shall be paid as per minimum wages.

- (v) **Unskilled manpower** shall be minimum VIIIth Class pass with good physique & shall have basic knowledge of similar electrical works and shall be paid as per minimum wages.
- (vi) **Highly skilled manpower (Data Entry Operator)-** shall have Graduation with min. 2 years of work experienced with sound computer skills and shall be paid extra allowance of Rs. 2000 per month in addition to the minimum wages

However, EIC reserve the rights to relax above mentioned educational requirement and experience criteria for any specialized skilled person suitable to site requirements only after taking approval in writing from one rank higher than TS authority.

13. In case of absence of staff from duty recovery will be made by the department at the minimum wages rates, which shall be binding on the contractor.

i. Highly Skilled : As per daily wages.

ii. Skilled : As per daily wages.

iii. Semi-Skilled : As per daily wages.

iv. Un-Skilled : As per daily wages.

But apart from daily wages, an amount of Rs. 100/- will be recovered from the agency per person per shift tor absenteeism of any worker as a penalty.

The EIC has full rights to instruct the agency of expel/replace the person with the regular habit of taking unauthorized leaves frequently or continuously absent without proper justification, which may impact the morale of co-workers.

- **14.** The complete details of the installations under the scope of work are attached in Annexure "A" at page no. SCC 11 and Preventive Maintenance Schedule as per Annexure-'B' at page no. SCC 13 to SCC 14 of Specifications.
- 15. It is the responsibility of the contractor to maintain and ensure 100% serviceability of the equipments/installations under this contract, except for the reasons beyond the control of the contractor. The decision of engineer-in-charge is final and binding on the contractor in respect of establishment & "the reason beyond the control of the contractor". If the failure to maintain the serviceability of installations attributed to the contractors/agency, penalty to be imposed on the contractor as deemed fit by the Engineer in Charge.
- 16. In case the agency is not able to attend/rectify fault in the system within the stipulated time period, AAI reserves the rights to engage outside agency to check/inspect the faulty system. If the system is rectified by the outside agency or third party, the amount of checking, rectification along with suitable penalty towards delay in attending breakdown shall be recovered from the agency. Who otherwise is responsible for the up keeping of these equipments.
- 17. There shall be no liability on the part of the AAI to pay any compensation arising out of the labour dispute, accident etc. at site. The contractor will be fully responsible for

- safety, security and coordination of the workers deployed at AAI site. Noting extra will be paid to the Agency on this account.
- **18.** Contractor or his authorized representative shall visit the site at least once in one month and as and when called by the Engineer-in-Charge or his representative and will report about satisfactory working of all equipment.
- **19.** Any material taken out for the purpose of repair/rectification/replacement from the building or work premises shall have necessary permission from the EIC and security personnel/ Competent authority in the form of a Gate pass.
- **20.** The timings of operation & maintenance! upkeep work etc. shall be as decided by Engineer-in-charge from time to time depending upon operational & technical requirement.
- 21. If agency is doing any maintenance work as per schedule then they have to take prior approval for the same from EIC and also have coordination with other entities/wings (ATC/CNS/Airlines etc.) as required.
- 22. Handing/Taking over of the Equipment/Machines after contract:-

### i) For AMC Contract

All the equipments/installations/systems with accessories complete in all respect shall be checked by agency before taking over the site and the same has to be handed over AAI contractor in good running condition at the end of the contract. List of defects, if any notified during contract period shall be rectified by the agency before the closure of the contract. If the agency failed to rectify the defects, notified to him (during contract period) the EIC shall rectified the defects at the contractors risk & cost. The decision of EIC in this regard will be final & binding on the agency.

### ii) For CMC Contract

For items under Comprehensive Maintenance Contract (if any), the agency will check the installations thoroughly at the time of taking over and any defect found will be intimated to AAI in writing.

List of defects, If any, notified during contract period shall be rectified by the agency before the closure of the contract. If the agency failed to rectify the defects, notified to him (during contract period) the EIC shall rectified the defects at the contractors risk & cost. The decision of EIC in this regard will be final & binding on the agency.

- 23. For delay in attending maintenance schedules:- All the preventive maintenance works shall be done as per schedule and complete records in those regards has to be prepared and submitted to AAI engineers, failing which recovery of Rs. 5,000/— for monthly checks, Rs. 10,000/- for quarterly maintenance, Rs. 15,000/- for half yearly maintenance and Rs.20,000/- for yearly maintenance shall be made from the bills for each set/system of installations, subject to the shut down provided by AAI, which shall be Co— ordinate by the agency.
- 24. The contractor has to deploy their staff to run the system on all days as per BOQ & tender specification, terms & conditions. If there are some labours under a court case that need to be deployed by the agency as directed by E-I-C.
- **25.** The work shall be carried out as per specifications and relevant applicable standard including ISI/CPWD specification.

### 26. Safety & availability of Material: -

- (i) The firm/agency shall submit test certificates, wherever applicable as per CPWD/ISI manufacturers practice and the department reserves the right to get them independently checked for the material supplied by contractor as required.
- (ii) All debris due to works shall be removed and site shall be cleared by the contractor as soon as the task is completed. Non-removal of debris from site will attract a penalty of Rs. 500/- per day from the running bill/final bill.
- (iii) Issue of materials stipulated in the tender will be regulated to the actual needs from time to time. Unused materials shall be returned to the department failing which the recovery will be made at the penal rate is double the market rate. Any damage caused to the materials during transit or under storage will be to the contractor's account.
- (iv) If there is any requirement of material at site which is not included in the scope of work then contractor has to procure from market as per approved makes with EIC permission and close the complaint as soon as possible. Contractor will provide the tax invoice/ bill for the same and the payment for such material will be given along with 15% OH & CP in running/final bill as an extra item.
- **27. Guarantee:** In case of supply of any material, the tenderer shall guarantee the equipment/material against all defects as per manufacturer. Any defects arising during the guarantee period shall be rectified by the Tenderer at his own expenses to the satisfaction of the E-I-C.
- **28. Water/Electricity and Enquiry Room: -**The AAI will provide an enquiry room, water & electricity for maintenance purpose, free of cost.
- 29. Make of items: The contractor shall use / supply the material as per approved make of AAI or as per schedule of quantities or exact replacement of existing material suitable to site after taking permission from EIC/authorized representative in writing in case makes are not defined for particular material and the department reserves the right to accept or reject any other makes offered by the contractor. The contractor has to supply the materials as and when reqd./ordered by the Engineer-in-charge or his representative during the currency of the contract.

### 30. Terms of payment:-

The Running payments for the work done shall be released BI-Monthly by AAI only after salary payments to all workers & submitting the proof of disbursement and deducting the applicable taxes. The Security Deposit @ 10% shall be deducted from the running bills, which shall be released after successful completion of Defects Liability Period and proper handing over/taking over of all installations in perfect working condition to department officer/second agency as decided by EIC.

## The defects liability period shall be six (06) month reckoned from the certified date of completion.

The following documents as applicable shall be produced and self-attested photo copy shall be submitted by the contractor during each running bills.

i. Delivery challan / copy of invoice of all the material supplied.

- ii. Test Certificate to confirm that the materials meet the contract specification and relevant standard in all respects.
- iii. Monthly Challans of E.P.F. and E.S.I. deposits upto previous month.
- iv. Wages register signed by workers of each month.
- iv. Bonus details received and signed by workers.
- Log books & attendance register.

**Final Bill Payment: -**The total amount of final bill worked out at the accepted tender rates, if found to be more than the amount worked out at the quoted rate of second lowest, the contractor shall be paid lower of the two.

The agency shall submit final bill alongwith all the documents related with PF, ESIC & Bonus to AAI in addition to all maintenance schedule registers, documents etc. related to the work. The agency also formally hands over the list of equipments in good working condition, without any damage as handed over to them by AAI.

- **31.** The contractor shall be responsible for any damage caused to any equipments / building of AAI due to the negligence of the staff. The same shall be made good by the contractor at his cost.
- **32.** Agency has to submit the Preventive Maintenance Activity Plan within 15 days of award of work in line with the Preventive Maintenance Schedule, considering site requirement for approval of Engineer-in-Charge or his authorized representative.
- 33. The agency shall provide minimum 01 no. mobile phone with active SIM to the site in charge /authorized representative for official use during the currency of the contract. Nothing extra will be paid on this account.

### 34. Dismantled materials:

- (i) The contractor shall make entry of all the materials issued by AAI (if any) for the work, time to time in the material issue register (to be separately maintained by the contractor).
- (ii) After completion of the work necessary entries shall also be made in the register indicating the location where the materials are installed and the balance materials left out need to deposited to AAI store after completion of work.
- (iii) The dismantled materials shall be duly handed over to Engineer in charge or his authorized representative and necessary endorsement shall be obtained in both material issue register and also the dismantled material register.
- (iv) Dismantle material/spares received against replacement under ACMC contract shall be the property of the agency & same shall be removed from site periodically/ immediately after the completion of contract.

### 35. Equipment's For Night Working;

In case, it appears, at any stage that the work may not be completed within the stipulated period due to restricted working hours in the day in view of any reasons, the contractor shall execute the work during the night as and when required. Nothing extra shall be payable to contractor for working in night time.

**36. Consumables:-** All the consumables such as oil & lubricants, chemicals for laboratory testing, general consumables for sewage treatment plant, insulation tape,

test lamps, cotton waste, soap, dusters, grease, petroleum jelly, hack-saw blade, etc. will be provided by the contractor. Stationeries such as log books, work diaries to workmen, printed maintenance records, logbook of various installations, various registers, preventive maintenance schedules as per AAI format and as per the instructions of Engineer-in-charge will be provided within the 15 days of award of contract and maintained by the contractor at the site. Reserve Stock quantity to be decided by the EIC & nothing extra payment will be made in this regard and the agency has to keep minimum quantity of consumables for one month in stock depending on the actual requirement failing which the material will be arranged by the AAI and the expenditure will be recovered from the agency with 15% over head.

### 37. Tools And Tackles:

The contractor shall provide all the tools and tackles for the works including Measuring instruments and safety gadgets for attending breakdown of equipments. Cost of transportation of labour and material to Airport/office premises shall have to be borne by the contractor.

(i) Each Skilled manpower will be provided with the following minimum tools of reputed brand (Make: Taparia or equivalent) along with carrying bag for routine maintenance works: -

### 38. Guidance To Tenderer:

The contractor shall quote the tender based on the expenditure towards providing of manpower (based on minimum wages) Tool & Plants, Uniform to workers, Statutory items, PIC Charges Cost of consumables, Miscellaneous expenses, taxes & duties etc.

### 39. Penalty Clause:

No total Breakdown is acceptable. In case of total Breakdown due to negligence of the contractor or his workmen, suitable recovery proposed by Engineer-In-Charge will be final and binding on the contractor. Special care is required in attending the faults for the equipments where no standby is available.

Note: - In any case the total penalty at any point of time on account of any or all the categories put together shall not exceed 15% of the total contract value per month.

If any equipment damaged due to the negligence of the manpower, the agency shall repair the same and nothing extra shall be paid on this account by the AAI.

Once the total penalty reaches this limit, the contract shall be liable for review / rescind as per the provisions of the contract agreement and the decision of Engineer-in-Charge in this regard shall be final and binding on the contractor.
