The offer of the firms who fail to submit their offers in **Separate sealed envelopes** clearly specifying the **"Technical bid" and "Price Bid" will not be considered.**

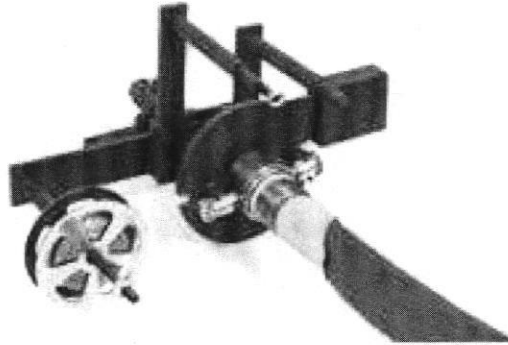
