

#### NOTICE INVITING QUOTATION

Renewal of General Conditions :-

- Item rate Sealed Quotation in the prescribed form is hereby invited on behalf of the Regional Executive Director, Airports Authority of India (AAI), Northern Region, New Delhi for Renewal of Insurance of AAI vehicles (Comprehensive Insurance) as per enclosed details (Annexure-A ) from Nationalized Insurance Companies or Private Insurance Companies having Valid License from IRDA.
- 2. The complete NIQ document including details of Vehicles (Annexure-A) and Format for Price / offer Bid (Annexure-B) can be obtained through E-Mail ; technr@aai.aero. The Quotation document can also be downloaded from the Website of Airports Authority of India www.aai.aero & www.airportsindia.org.in . The dully filled Quotation ( Price Bid / Offer in Prescribed format –Annexure-B) in a sealed envelope subscribing on the top " Quotation for Renewal of Insurance of 10 No ACFTs " shall be submitted upto1500 hrs.on 13.07.2022 and will be opened on the same day at 1530 hrs.
- The quotation for Insurance offer shall remain open for acceptance for a period of 90 (Ninety) Days from the date of opening of the quotation.
- 4. The item wise / vehicle wise Insurance premium should be quoted in prescribed format for Price-bid (Annexure-B). As on date, NO claim have been claimed in respect of polices detailed in Annexure-A. The scanned copies of all policies, if required can be requested through e-mail; <u>technr@aai.aero</u>.
- 5. The Regional Executive Director, Airports Authority of India, Northern Region, New Delhi does not bind himself to accept lowest or any quotation and reserves to himself the right of accepting the whole or any part of the quotation. The firm shall be bound to perform the same at the rate quoted.
- 6. Offers obtained on after prescribed time and date will not be considered.
- 7. AAI is not liable for any postal delay.
- 8. Offers of PSU insurance firm & Private Limited firms alone will be considered (Agent /

### Agency / Dealer offers will not be accepted).

Requirements :- Insurance firms other than PSU have to submit :-

i) Valid IRDA Registration copy.

- ii) Address Proof with Contract No.
- iii) GST Registration No. and its copy.

Non availability of valid document leads to rejection of offer.

9. The ACFTs are positioned at various Airports which is mentioned in colums 1 of Annexures.

#### **COVERAGE REQUIRED AND TERMS, CNDITIONS**

- 1. These ACFTs to be insured under comprehensive Insurance Policy [miscellaneous class] with coverage as mentioned below :
  - a) Overturning risk for vehicle under miscellaneous class D-IMT47.
  - b) PA cover to the insured or named passengers-IMT15.
  - c) PA cover for paid drivers, cleaners, conductors for all class of vehicle- IMT17
  - d) PA cover for unnamed passengers other than insured and the paid driver & cleaner IMT16.
  - e) Legal liability to paid driver and / or conductor and /or cleaner employed in connection with the operation of insured vehicle **IMT-28**.
  - f) The IDV includes the vehicle / equipment and all Non-electrical, Electrical and Electronic accessories fitted in the vehicle / equipment.
- Period of premium to be paid, calculated for specified period as mentioned in Annexure-B.
- 3. As the vehicles / equipment is driven / operated by departmental staff, the amount for PA cover for Owner Driver to be avoided unless it is mandatory.
- 4. No Voluntary deduction is applicable.
- 5. Special Discount under the corporate head may also be extended for renewal of policies.
- 6. **No insurance claims** have been lodged till date on the existing policies for vehicles & equipments.
- 7. No claim bonus (NCB) to be given as per applicability.
- 8. Copy of Current insurance policy will be made available through e-mail on request.
- 9. ACFTs are not registered and hance No RC is available. Insurance to be done under unregistred vehicle category with comprehensive coverage.
- 10. Firm has to mention the Basic Premium (OD + TP), GST amount and total premium to be paid in the given format only.

- 11. Conditional offer will not be accepted.
- 12. The successful Bidder will be decided by evaluation of lowest rate quoted for each vehicle / equipment.
