1. Item rate e-tenders are invited through the e-tendering CPP Portal by Asst. General Manager (Engg-Elect), Airports Authority of India, Hyderabad International Airport, Begumpet, Hyderabad-500 016 (Bid Manager) on behalf of Chairman, A.A.I. from the eligible contractors for the work of "Expansion of Turn pad and fillets for Link Taxi Track for Operation of B777-300ER type of Aircraft at Begumpet Airport, Hyderabad. Sub-Head: Electrical Works." at an estimated cost of Rs. 54,84,784/- (Excluding GST) with completion period of 04 (Four) Months.

The tendering process is online at CPP-portal URL address

https://etenders.gov.in/eprocure/app or www.aai.aero. Prospective Tenderers may download and go through the tender document.

Prospective Tenderers are advised to get themselves register at CPP- portal, obtain 'Login ID' and 'Password' and go through the instructions available in the Home Page after log in to the CPP-portal https://etenders.gov.in/eprocure/app orwww.aai.aero.Theys should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their application. - vii. PQ Performa (Checklist) duly filled (Annexure-A.)
- viii. Should have satisfactorily completed (# Phase/Part completion of the scope of work in a contract shall not be considered, however pre- determined phasing of the work will be accepted) three works, each of Rs.21,93,914/- or two works, each of Rs.27,42,392/- or one work of Rs.43,87,827/- in single contract of similar nature of i.e. "Supply and Installation of GLF System/Works" during last seven years ending on date of E-Bid Submission along with work order copy, bill of quantity.

"The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7.00% per annum, calculated from the date of completion to the last date of submission of bid".

The Experience certificate of works completed pre-GST era, the completion amount will be divided by 1.12 (to execute pre-GST tax or VAT 12%) to make it par with the experience certificate of post GST era but excluding GST.

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Experience certificate should contain work order copy, bill of quantities & completion certificate. Firms showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work. (In case TDS is not available for supply portion, tax invoice along with client receipt / certificate is to be submitted).



- ix. Should have annualized average financial turnover of Rs.16,45,435/- against works executed during last three years ending 31st March of the previous financial year. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement with UDIN (Unique document Identification Number) of the tenderer should be submitted along with the application. Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- x. The tenderer should have a minimum net worth of Rs. 8,22,718/- per annum issued by certified Chartered Accountants with UDIN (Unique Document Identification Number of the Instituted of Charted Accountant of India) (Proforma-4).
- xi. GST registration or undertaking.
- xii. Scanned copy of [in PDF Format] ESI & EPF Registration documents.
- xiii. Digitally Signed Tender Documents.
- xiv. Scanned copy of Valid Electrical License issued by Govt.

The tenderer shall upload the digitally signed file of scanned documents and all other documents in support of their meeting each criterion mentioned above in the CPP Portal.

EMD of value of Rs. 1,09,696.00 shall be accepted online only in CPP portal.

Refund of EMD

The refund of EMD to tenderers who fail to qualify in the eligibility/technical criteria, shall be initiated within 7 days of their rejection. For all tenderers who qualify after their financial bids are opened, the refund of EMD all such tenderers except L-1 shall be processed within 7 days of opening of the financial bid.

Envelope-II: - The Financial e-Bid through CPP portal.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected.

3. Bid Submission: -

The tenderer shall submit their application only at CPP Portal: https://etenders.gov.in/eprocure/app. Tenderer/contractor are advised to follow the instruction provided in the tenderer document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and while option which helps in reducing size of the scanned document.



Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- 4. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstances will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partners(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 5. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPP)website http;//etenders.gov.in/e procure/app shall not tamper /modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered /modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AAI.

6. Bids Opening Process is as below: -

Envelope- I: (Tender Processing Fee, EMD, Technical bid and pre- qualification):

Envelope I containing document as per Para2 (A), (B) and (C) (uploaded by the tenders) shall be opened on date &time mentioned in **CRTICAL DATASHEET**.

Payment confirmation will be checked at the time of tender opening. Payment status will be checked for each individual bidder. Paid information link will be viewed and bidder details along with payment details will be checked. The payment status should show success against each bidder. If the status (tender fee) is not displaying success the tender will be rejected.

If the bidder has any query related to the Bid document of the work, they should use "Seek clarifications' on CPP portal to seek clarifications. No other means of communication in this regard shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope I he will be asked to provide it through CPP Portal. The tenderer shall upload the requisite clarification/documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/rejection of their bids will be intimated to the tenderers through CPP Portal.

Envelope-II: (Financial Bid):

Envelope — II containing financial bid of the tenders found to be meeting the technical criteria and qualifying requirements shall be opened on date &time mentioned in CRITICAL DATA SHEET. (In case the date and time for opening of Envelope II (Financial Bid) is required to be changed, the same shall be intimated through CPP portal).



- 7. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
- 8. AAI reserve the right to disallow issue of tender document to working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/Temporary/Permanent debarment/blacklisting by any department of AAI or Central/State Govt. Dept./PSUs/World Bank/ADB etc. AAI reserve the right to verify the credential submitted by the agency at any stage (before or after the award the work). If at any stage, any information/documents submitted by the applicant is found to be incorrect/false or have some discrepancy which disqualifies the tenderer then AAI shall take the following action:
 - a. Forfeit the entire amount of EMD submitted by the firm.
 - b. The tenderer shall be liable for debarment from tendering in AAI, including termination of the contract apart from any other appropriate contractual/legal action.
- 9. Consortium /JV companies shall not be permitted.
- 10. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.
