**NOTICE INVITING e-TENDER (2 BOT -2 Envelope Open Tender)**

1. Item rate e- Tenders are invited through the CPP e-tendering portal by Asst. General Manager Engg (Civil), AAI, SR, Operational office, Chennai Airport, Chennai-600027 PH.04422567567 on behalf of Chairman, AAI from the eligible contractors for the work of “**Extension of Apron at Salem Airport. SH: Provision of Technical Assistant Services to Engineering office (Civil) at AAI/RHQ-SR & Salem Airport, for the year 2022-23**”. At an estimated cost of **Rs. 7,61,743/- (Excluding GST)** with period of Completion **11 Months**. The scope of work includes Provision of Technical Assistant Services.

The tendering process is online at CPP-portal URL address <http://etenders.gov.in/eprocure/app> or [www.aai.aero](http://www.aai.aero) Prospective tenderers may download and go through the tender document.

Prospective Tenderers are advised to get themselves register at CPP-portal, obtain ‘Login ID’ & ‘Password’ and go through the instructions available in the Home Page after log in to the CPP-portal <https://etenders.gov.in/eprocure/app> or [www.aai.aero](http://www.aai.aero). They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their application.

- viii) Proprietor firm shall submit scanned copy of authorization letter/power of attorney only if the tender is processed by a person other than proprietor.
- ix) Scanned copy of valid EPF & ESI registration.
- x) Scanned Copy of certificate of Net worth from Chartered Accountant with UDIN (**As per Annexure – E) - Page no. 32**)
- xi) Scanned copy of duly signed Contract of Engagement for Job Contract (**As per Annexure – F) - Page no. 33**)
- xii) PQ proforma dully filled.

**C. Qualifying requirements of contractors / tenderers containing the following:**

- i. Should have satisfactorily completed (# Phase/Part completion of the scope of work in a contract shall not be considered, **however pre-determined phasing of the work will be accepted**) three works, each of **Rs. 3,04,700.00** or two works, each of **Rs. 3,80,900.00** or one work of **Rs. 6,09,400.00** in single contract of similar nature of work (**similar nature of works like Providing Technical assistants/ministerial services / Annual Maintenance type of works**)” during last seven years ending on date of E-bid submission/ Extended date of submission in India.

**"The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid” as mentioned in the CRITICAL DATA SHEET”.**

**“The experience certificates of works completed pre GST era, completion amount will be divided by 1.12(to exclude pre GST tax of VAT 12%) to make it at par with experience certificate of post GST era but excluding GST”.**

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work.

**Tenderers showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.**

- ii) Should have annualized average financial turnover of **Rs.2,69,700.00** against works executed during last three years ending on 31.03.2021. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement with UDIN of the tenderer should be submitted along with the application. Tenderers showing continuous losses during the last three years in the balance sheet

shall be summarily rejected.

- iii) The tenderer should have a minimum net worth of **Rs.1,34,850.00** issued by the certified Chartered Accountants with UDIN. **(As per Annexure-E) - Page no. 32**
- iv) **Both the Certificates Issued / undertaken/ signed by Chartered Accountant as per (C) ii & (C) iii of above, should have / consist Unique Document Identification Number (UDIN) of the Institute of Chartered Accountant of India.**
- (v) **Tenderers have to submit UDIN generated documents like Balance Sheet / Turnover Certificate, Net worth Certificate, Tax Deduction at Source (TDS) Certificate for Non-Govt. works etc. as per NIT conditions duly certified by CA and having UDIN. The documents submitted by bidders without UDIN shall not be entertained.**

**Envelope-II: - The Financial e-Bid through CPP portal.**

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue colored (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected.

**3. Bid Submission :-**

The tenderer shall submit their application only at CPP Portal: <https://etenders.gov.in/eprocure/app>. Tenderer/contractor are advised to follow the instruction provided in the tenderer document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- 4. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstances will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partners(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 5. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPP) website <https://etenders.gov.in/eprocure/app> shall not tamper /modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered /modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AAI.

**6. Bids Opening Process is as below: -**

**Envelope-I: (Tender Processing Fee, EMD, Technical bid and pre-qualification):**

Envelope I containing document as per Para 2 (A), (B) and (C) (uploaded by the tenders) shall be opened on date & time mentioned in CRITICAL DATA SHEET.

If the bidder has any query related to the Bid document of the work, they should use 'Seek clarifications' on CPP portal to seek clarifications. No other means of communication in this regards shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope-I he will be asked to provide it through CPP portal or email if required.

The tenderer shall upload the requisite clarification/documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly. The intimation regarding acceptance/rejection of their bids will be intimated to the tenderers through CPP Portal.

**Envelope-II: (Financial Bid)**

Envelope – II containing financial bid of the tenders found to be meeting the technical criteria and qualifying requirements shall be opened on date & time mentioned in CRITICAL DATA SHEET.

**(In case the date and time for opening of Envelope II (Financial Bid) is required to be changed, the same shall be intimated through CPP portal)**

7. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
8. AAI reserve the right to disallow issue of tender document to working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/Temporary/Permanent debarment/blacklisting by any department of AAI or Central/State Govt. Dept./PSUs/World Bank/ADB etc.

**AAI reserve the right to verify the credential submitted by the agency at any stage (before or after the award the work). If at any stage, any information /documents submitted by the applicant is found to be incorrect/false or have some discrepancy which disqualifies the tenderer then AAI shall take the following action:**

- a) **The tenderer shall be liable for debarment from tendering in AAI, including termination of their contract apart from any other appropriate contractual/legal action.**
9. Consortium /Joint Ventures companies shall not be permitted.
10. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.

11. Concession to India Micro & Small Enterprises (MSEs) units registered with DIC/NSIC/KVIC/Directorate of Handcraft etc., to be given as per the provisions of Public Procurement policy for MSEs order 2012 with up to date amendments, shall be applicable for tenders of supply/services and shall not be extended to construction work. Concession to MSME is not applicable in this work.
