Transport for NSW (TfNSW) seeks a suitably qualified and experienced Utility Project Manager for the Stimulus Pinch Points Program (Project).

The Easing Sydney Congestion (ESC) program to be delivered by TfNSW includes the Macquarie Park 1A project. This project is providing intersection upgrade to accommodate improved bus movements within Macquarie Park.

The key roles and responsibilities of the Utility Project Manager include but are not limited to:

- Lead and manage delivery phase of utility works on the project.
- Liaise with and pro-actively manage the construction contractor(s) to deliver project safely, within cost, time and quality requirements.
- Carry out Safety, Environment, Quality and community liaison audits to verify conformance to statutory and defined project requirements. Liaise with environmental, quality and community liaison representatives.
- Liaise and coordinate with stakeholders, such as TfNSW, Utility Providers, TMC, Local Councils.
- Prepare and manage utility project estimates and cash flow forecast to feed into the master project.
- Prepare and manage utility program to contribute to the project master program and sub-programs.

- Prepare and manage implementation of utility Risk Register, Risk Management Plan/Strategy; assist with identification of cost and time impact and its management.
- Prepare and implement utility project management plans, aligned with PMBOC principles.
- Identify applicable standards, acceptance criteria and testing standards.
- Drive utility works to program, proactively monitoring Project/Contracts progress, collect and analyse costs, report progress and forecast cost at completion and completion time.
- Assist with preparation of Project Status Reports with regards to utilities. Update project information such as cost reconciliation, accruals, commitments, forecasts, cashflow and contingency allocations.
- Establish and chair various technical utility meetings and workshops to expedite the delivery of works.
- Manage commissioning and handover process of utilities.
