Overview

The National Property Office (NPO) within NZ Police has established a Custody Infrastructure Programme of works to address Health and Safety remediation works required across its national portfolio of custodial facilities. NZ Police is seeking a main contractor to help deliver this programme. This will be a multi-year programme.

The initial contract term will be for 2 years with two rights of renewal (2+2+1).

- h) Respondent has completed H&S information / provided a copy of their H&S policy

NZ Police intends to select between 3-5 suppliers for the RFT stage. However, this may be amended, depending upon the number and quality of the responses received.

- 2) Capacity of the organisation 15%
- 3) Previous experience 20%
- 4) Approach to project methodology 15%
- 5) Broader Outcomes 15%
- 6) Health and Safety and Quality Assurance 15%
