

## **Expressions of Interest**

## Manx Re-Skill Scheme Co-ordinator

The Isle of Man Government invites expressions of interest from an experienced recruitment agency or supplier to act as a Manx Re-Skill Scheme Co-ordinator for the Treasury.

The Manx Re-skill Scheme has been developed and is funded by the Economic Recovery Group. It is focused on those individuals who would like to return to work with appropriate support where necessary.

This pilot scheme will fund and support up to 50 employment relationships for up to 12 months.

The shared and supported approach between the public and private sector will provide:-

- a) the individual with a 12-month employment opportunity providing valuable training, support, skills development and experience with the objective of leading to sustained employment with the employer, or an alternative employer at the end of the supported period.
- b) financial support and optional access to a 2 day training course will be available to employers who are willing to employ from within this cohort. The employer would directly employ the individual thereby establishing a real and meaningful employment relationship. The employer could then claim back a percentage of salary (capped at the hourly living wage of £10.87 per hour) for up to 35 hours per week. For the first 6 months this will be 100%, then 75% for months 6 to 9 and then 50% for months 9 to 12.

The experienced recruitment agency/supplier will:

- match candidates with employers;
- support the recruitment and on boarding process by helping prepare candidates for interview and job start;
- provide and co-ordinate ongoing support and mentoring to the employees throughout, with the aim of supporting candidates to sustain employment at the end of the financially supported period.

In order to participate in this competitive exercise, your organisation must be registered on the Isle of Man Government's Procurement Portal.
