



Expressions of Interest

Quick Quote - Proposed Replacement Aluminium Windows/External Double Doors to Cronk y Berry Primary School, Hailwood Avenue, Douglas IM2 7PA – Phase 2.

The Isle of Man Government invites expressions of interest from Contractors to provide construction services to the Department of Infrastructure.

The project briefly comprises the replacement of 11no. external double doors, 32no. double glazed windows with cills, & all to have top hung casement sashes as existing. The new glazing system is to match the existing design as near as possible as this is based on the original window design, colour and glazing i.e. Clear/Obscure glass.

All new door sets and windows to be aluminium with polyester power coating to BS6496 suitable for a marine environment – 60 microns in RAL 9010 White. Each window or section will also include one top hung opening casements as existing.

It is envisaged that the works will be undertaken during mid to late October 2021 and to make use of the October half term period – schools close Friday 22nd October and re-open Monday 1st November 2021. A phasing program will need to be submitted & work on with the school, to enable a classroom(s) to be made available to progress the installation during term time.

The Glazing System should include a minimum 10 year Product Warranty, or better.

The Glazing System should be manufactured/fabricated to CWCT Certification to BS 13830

Impact Resistance to either IPAS 24 ISO 9001 or Secured by Design ISO 14007

Thermal Breaks extruded to BS 7619 or better.

All works detailed on Drawing SKM_c308_7122042809450.pdf, together with Door and Windows Specification Sheets.

All Tenders are to include all Materials, Labour, Tools & Equipment including any low level access that may be required to complete the works safely &, to clear up all mess upon completion to leave the area clean and tidy.
