The Department of Veterans Affairs, Office of Construction & Facilities Management, anticipates awarding a Firm Fixed Priced contract in support of the Ft. Logan National Cemetery Phase 1 Expansion (Construction), Project No. 888-043, located at 4400 W. Kenyon Ave, Denver, CO 80236, as described herein.

This project will develop approximately 20 acres of land for the Phase 1 gravesite expansion at Ft. Logan National Cemetery, providing approximately 38,546 gravesites, including both casketed and cremation sites. The project will include constructing burial sections, access roads and other paving, grading, landscaping, construction of buildings and other improvements to the cemetery.

This procurement is 100% set-aside for Service-Disabled Veteran-Owned Small Business (SDVOSB) concerns. The applicable North American Industry Classification System NAICS CODE: 237990 (size standard \$39.5M).

The magnitude of construction cost for this project is between \$20,000,000 and \$50,000,000.
